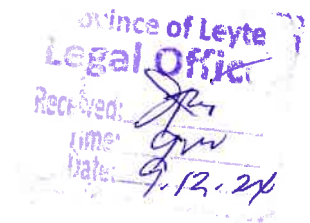

<sup>2</sup> Section 325(d) In cases of abolitions of positions and the creation of new ones resulting from the abolition of existing positions in the career service, such abolition or creation shall be made in accordance with pertinent provisions of the Code and the civil service law, rules and regulations;


