MUNICIPAL ORDINANCE NO. 24-005

AN ORDINANCE CORRECTING THE SALARY GRADE OF THE POSITION OF DENTIST II FROM SALARY GRADE 16 TO SALARY GRADE 17 AND ALSO THE SALARY GRADE OF THE POSITION OF PHARMACIST II FROM SALARY GRADE 12 TO SALARY GRADE 15 IN COMPLIANCE TO CIVIL SERVICE COMMISSION (CSC) RULES AND REGULATIONS.

BE IT ENACTED, as it is hereby enacted, by the Sangguniang Bayan of Mahaplag, Leyte, in a session duly assembled that:

Section 1.

The Salary Grade of the position of Dentist II is hereby corrected from Salary Grade 16 to Salary Grade 17 in compliance to Civil Service Commission (CSC) rules and regulations, and shall be entitled to a Monthly Salary of Forty-Three Thousand Thirty Pesos (₱43,030.00) and with a Gross Annual Compensation (including all benefits) amounting to Eight Hundred Sixty-Four Thousand One Hundred Eighty-Two Pesos (₱864,182.00).

Section 2.

The Salary Grade of the position of Pharmacist II is hereby corrected from Salary Grade 12 to Salary Grade 15 in compliance to Civil Service Commission (CSC) rules and regulations, and shall be entitled to a Monthly Salary of Thirty-Six Thousand Six Hundred Nineteen Pesos (\$\mathbb{P}36,619.00) and with a Gross Annual Compensation (including all benefits) amounting to Seven Hundred Forty-Four Thousand Forty Pesos (₱744,040.00).

Section 3.

SEPARABILITY CLAUSE. If, for any reason, any item, section or provision of this Ordinance is dealared invalid or unconstitutional, the other items, sections or



provisions thereof which are no affected thereby shall continue to be in full force and effect.

- Section 4. REPEALING CLAUSE. All ordinances, resolutions or parts thereof, whose provisions are in conflict with or contrary to the provisions of this ordinance are hereby repealed, amended or modified accordingly.
- EFFECTIVITY CLAUSE. This Ordinance shall be effective immediately upon Section 5. approval by the Local Chief Executive.
