

AFFIDAVIT

I, BRAIANCE S. TORREÑA, of legal age, married, and a resident of Tacloban City, after having been duly sworn in accordance with law, do hereby depose and state that:

1. I would like to bring to your attention the acts of Municipal Councilor **DENNIS BALDERIAN** (MR. BALDERIAN) of the Municipality of Tabontabon, Leyte, which constitute **Unjust Vexation, Oral Defamation, and Grave Threats**;
2. On or about August 18, 2024 at or about 9:30-10:00 o'clock in the evening, MR. BALDERIAN arrived and joined the drinking session of Jeff Niñada (Jeff), Lodegario Poserio, Ronil Pacala and Isidro Florencio in front of the sari-sari store owned by Rodel Pacala. He angrily uttered that Jeff committed a wrongdoing against him because Jeff is living with me and my family in Tacloban City. For context, Jeff is from Tabontabon, Leyte, awaiting the confirmation of his enrolment in TESDA and Asian Development College Foundation, so he lives with my family in Tacloban City.
3. MR. BALDERIAN hurled curse words at Jeff, an impressionable 19-year-old, forcing him to divulge everything that he knows about me and my family. Of course, Jeff did not tell him anything but what MR. BALDERIAN was insinuating is nothing short of an invasion of my privacy and utter neglect and disrespect for Jeff's rights;
4. MR. BALDERIAN continued to make threats against me just because I am unable to speak Waray-waray. This was witnessed by Lodegario Poserio whom MR. BALDERIAN also threatened because he speaks Tagalog when talking to me. Attached hereto as "Annex A" is the Affidavit of Lodegario Poserio supporting these statements;
5. At or about 11:30 in the evening of August 18, 2024 to 12 o'clock midnight of August 19, 2024, MR. BALDERIAN proceeded to the house of Jeff's parents and stated that he will involve Jeff in his grave threats against me and my wife. Attached as "Annex B" is the Affidavit of Jeff Niñada, attesting to the abovementioned facts.

6. In my mind, there is nothing wrong with our living arrangements with Jeff. But if his actions towards Jeff has something to do with the incident wherein I sustained serious physical injuries (fractures) in the head caused by my brother-in-law, JULIUS, who is a police officer and whose wife is the sister of MR. BALDERIAN, then I firmly believe that his unjust actions are misplaced. The filing of the appropriate legal action against JULIUS with the Philippine National Police was well within my rights, but for the sake of family harmony, I did not proceed to do so.
7. Nevertheless, MR. BALDERIAN's threats and intimidation towards the people I care for is quite alarming. This has caused annoyance which I can no longer tolerate. I am worried for the safety of my family and that of Jeff and his family. MR. BALDERIAN has went to Jeff's house several times already and again made threats if Jeff does not speak to him.
8. The Public office is a public trust. Public officers and employees must at all times be accountable to the people, serve them with utmost responsibility, integrity, loyalty, and efficiency, act with patriotism and justice, and lead modest lives.

MR. BALDERIAN, as a public officer, is expected to demonstrate courtesy and civility in all his actuations and dealings with the public, but alas, he has failed to do the same;






