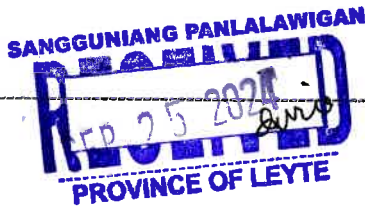

REVIEW/RECOMMENDATION/LEGAL OPINION:

This office is of the opinion that the Subject Ordinance is in accordance to its power under Section 447(3)(vi)¹ of the Local Government Code of 1991(R.A 7160).

Said ordinance is consistent with the authority devolved by Land Transportation Franchising and Regulatory Board (LTFRB) to the Local Government to determine, fix, prescribe or periodically adjust fares or rates for the service provided in a zone after public hearing (G.R No. 131512, Jan 20, 2000). Hence, recommending for the declaration of its validity.

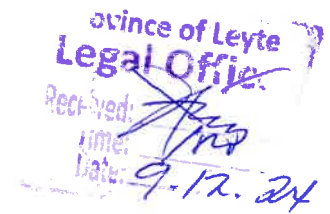

AN ORDINANCE REGULATING THE NEW FARE MATRIX OF MOTORIZED
TRICYCLE-FOR- HIRE WITHIN THE MUNICIPALITY OF HINDANG, PROVINCE
OF LEYTE

EXPLANATORY NOTE

The regulation of tricycles for hire has undergone a significant shift, devolving from the Land Transportation Franchising and Regulatory Board (LTFRB) to the Local Government Units (LGUs) Republic Act 7160, also known as the Local Government Code of 1991. This decentralization aims to empower LGUs in effectively managing transportation services within their jurisdictions.

In line with this decentralization and in response to the challenges posed by rising fuel prices and the increasing cost of living, the Sangguniang Bayan of Hindang, Leyte, is taking proactive measures to ensure the orderly and efficient provision of tricycle services to the community. With the goal of enhancing service quality and addressing economic concerns, the Sangguniang Bayan has enacted a new fare matrix for motorized tricycles for hire in the municipality. This updated fare structure seeks to strike a balance between the needs of both tricycle operators and commuters, thereby promoting fairness and sustainability in the local transport sector.

BE IT ENACTED by the Sangguniang Bayan in its regular session assembled this date, that:

SECTION 1. TITLE. This Ordinance shall be known as "THE NEW FARE MATRIX OF MOTORIZED TRICYCLE-FOR- HIRE IN THE MUNICIPALITY OF HINDANG, LEYTE".

SECTION 2. NEW FARE MATRIX

- a. The new minimum fare is **Fifteen Pesos (Php15.00)** and shall be applied for the first Three (3) kilometers from point of origin.
- b. Students, elderly passengers or senior citizens and persons with disabilities (PWDs) are also entitled to a fare discount of 20% as mandated by law.

SECTION 3. SEPARABILITY CLAUSE. Should any provision, section or part of this ordinance declared as invalid by any court of competent jurisdiction, such judgment shall not affect or impair the remaining provisions, sections or parts hereof which shall continue to be in full force and effect.

SECTION 4. REPEALING CLAUSE. All ordinances, resolutions, rules and regulations or parts thereof in conflict with this ordinance are hereby repealed, provided that the rights are vested upon the effectivity of this Ordinance shall not be impaired.

SECTION 5. EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately upon its approval.
