## 2<sup>nd</sup> INDORSEMENT September 2, 2024

Respectfully returned to the Sangguniang Panlalawigan of Leyte, through SP Secretary, the attached Ordinance No.474 of the Sangguniang Bayan of Babatngon, Leyte.

## Issues/concerns for review/recommendation/legal opinion is/are as follows:

• Ordinance No. 444 entitled: "An Ordinance Reclassifying Cadastral Lot No. 1208 measuring 1,091 hectares covered by Certificate of Title No. 115-2019003430 and Tax Declaration No. 2008-04001-00689 located at Brgy. District 1, Babatngon, Leyte from Agricultural Land to Commercial Land in classification.

#### REVIEW/RECOMMENDATION/LEGAL OPINION:

This office is of the opinion that the subject Ordinance is within the corporate powers of the local government unit particularly covered under Section 447 of the Local Government Code.

Moreover, Section 20.1 Chapter 1 of the Local Government Code, empowered the city or municipality through an ordinance, to reclassify agricultural land when the land ceases to be economically feasible and sound for agricultural purposes as determined by the Department of Agriculture or where the land shall have substantially greater economic value for residential, commercial, or industrial purposes, as determined by the sanggunian concerned. Reclassification likewise finds support under Section 3, Article XII of the 1987 Constitution<sup>2</sup>.

It must be noted however, that the power of the LGUs to reclassify agricultural lands is not absolute. The authority of the DAR to approve conversion of agricultural lands covered by Republic Act No. 6657 to non-agricultural uses has been validly recognized by said Section 20 of Republic Act No. 7160 by explicitly providing therein that, "nothing in this section shall be construed as repealing or modifying in any manner the provisions of Republic Act No. 6657."

<sup>&</sup>lt;sup>1</sup> Section 20. Reclassification of Lands. - xxx (a) A city or municipality may, through an ordinance passed by the sanggunian after conducting public hearings for the purpose, authorize the reclassification of agricultural lands and provide for the manner of their utilization or disposition in the following cases: (1) when the land ceases to be economically feasible and sound for agricultural purposes as determined by the Department of Agriculture or (2) where the land shall have substantially greater economic value for residential, commercial, or industrial purposes, as determined by the sanggunian concerned: Provided, That such reclassification shall be limited to the following percentage of the total agricultural land area at the time of the passage of the ordinance.

<sup>&</sup>lt;sup>2</sup> Section 3. Lands of the public domain are classified into agricultural, forest or timber, mineral lands and national parks. Agricultural lands of the public domain may be further classified by law according to the uses to which they may be devoted. Alienable lands of the public domain shall be limited to agricultural lands. xxx

A perusal of the provisions of law cited above and of the copy of the ordinance submitted for review, this office is of the opinion that the LGU shall cite the reason for reclassification of the involved lots with compliance to the requirements specified under Section 20(a) of the Local Government Code.

Finally, this office recommends that the title of the Ordinance be revised to "Barangay Bacong Reclassification of Land Ordinance".

Hence, returned to Sangguniang Panlalawigan for further review.

Section 1. – Short Title – This ordinance shall be known as the "Barangay District 1 Reclassified Ordinance" in the Municipality of Babatngon, Leyte.

Section 2. – Reclassification of Lot – By virtue of this ordinance, CAD LOT NO. 1208 MEASURING 1.0916
HECTARES COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 115-2019003430 AND TAX DECLARATION NO. 2008-04001-00689
LOCATED AT BRGY. DISTRICT 1, BABATNGON, LEYTE, IS HEREBY RECLASSIFIED FROM AGRICULTURAL LAND TO COMMERCIAL

<u>Section 3.</u> – <u>Repealing Clause</u> – All laws, rules and regulations inconsistent herewith are hereby likewise repealed or modified accordingly.

<u>Section 4.</u> – Effectivity Clause – This ordinance shall take effect after ten (10) days from the date of its approval and posting in three (3) conspicuous places in the local government unit.
