This office is of the opinion that the Subject Ordinance is in accordance to its power under Section 161 - the General Welfare Clause of the Local Government Code of 1991 (R.A 7160) and Article XIV Section 19 of the 1987 constitution which provides that "the state shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry xxxx". Hence, recommending for the declaration of its validity.



AN ORDINANCE ESTABLISHING THE BURAUEN VOLCANOES BASKETBALL TEAM AS THE OFFICIAL BASKETBALL TEAM OF THE MUNICIPALITY OF BURAUEN, AND PROVIDING FUNDS THEREFOR

WHEREAS, the Municipality of Burauen recognizes the importance of promoting sports and recreational activities among its constituents for the enhancement of physical fitness, camaraderie, and community spirit;

WHEREAS, the formation of a municipal basketball team will provide an avenue for the development of local basketball talents and contribute to the overall well-being and pride of the municipality;

NOW, THEREFORE, be it ordained by the Sangguniang Bayan of the Municipality of Burauen in regular session assembled THAT:

Section 1. ESTABLISHMENT OF THE BURAUEN VOLCANOES BASKETBALL TEAM. The "Burauen Volcanoes Basketball Team" is hereby established as the official basketball team of the Municipality of Burauen, Leyte.

Section 2. PURPOSE. The primary purpose of the Burauen Volcanoes Basketball Team is to represent the Municipality of Burauen in local, regional, and national basketball competitions, fostering sportsmanship, teamwork, and community pride.

Section 3. SUPPORT AND FUNDING. The Municipal Government of Burauen shall support the Burauen Volcanoes Basketball Team in its establishment, operations, and activities, including but not limited to, team formation, training programs, purchase of uniforms for the athletes and coaches, compensation of coaches and trainers, equipment acquisition, participation fees for competitions, and other necessary expenditures related to the development and promotion of the team.

All the necessary expenses shall be charged to the Socio-cultural Fund under the Mayor's Office upon the approval of this ordinance and the rest of the calendar year 2024. The Municipal Government of Burauen shall allocate funds to the Local Youth Development Office for the next and succeeding years for utilization of Burauen Volcanoes Basketball Team engagements.

The allocated funds shall be disbursed and managed by the Local Youth Development Officer in coordination with the Management Team to ensure transparency, efficiency, and accountability in the utilization of funds.

Section 4. MANAGEMENT TEAM. The management team of the Burauen Volcanoes Basketball Team shall be appointed by the Local Chief Executive. The management team shall oversee the day-to-day operations, strategic planning, and development initiatives of the team.

Section 5. IMPLEMENTATION. This ordinance shall take effect immediately upon its approval and publication in accordance with existing municipal laws and regulations.

Section 6. REPEALING CLAUSE. All ordinances, rules, regulations, or parts thereof which are inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

Section 7. EFFECTIVITY. This ordinance shall take effect immediately upon its approval by the Sangguniang Bayan of Burauen, Leyte.
