have nothing to do with it then they got the permit from the province so that is what I wanted to be cleared with on who and which office should we ask.

HON. LEONARDO M. JAVIER, JR.: PRESIDING OFFICER/VICE-GOVERNOR

The answer is already there, Honorable Rama. Atty. Acol has the control of the permission and extraction of Gravel and Sand. The procedure is you get a permit from the barangay and also the concurrence of the LGU before Atty Acol gives the permit. So that is the procedure so if there are no documents that are there like the barangay didn't give the clearance then necessarily the province will not issue an extraction permit.

HON. CARLO P. LORETO: FLOOR LEADER/5TH DISTRICT BOARD MEMBER

Mr. Chair, will you please recognize the Honorable Reposar?

HON. RONNAN CHRISTIAN M. REPOSAR: 1ST DISTRICT BOARD MEMBER

Thank you, Mr. Chair. Thank you, Mr. Floor Leader.

This is just actually a clarification for the Honorable Rama whether they have determined what kind of Sand and Gravel Operations. Whether it's an Industrial Sand and Gravel or Commercial Sand and Gravel because if its industrial, the MGB is already involved but if it's commercial it just the provincial government that issues a permit. If its more than 5 hectares, it is usually an Industrial Sand and Gravel. If it's less than 5 hectares, it is Commercial Sand and Gravel. So, I think, under the provision of the Environmental Code of the Provincial Government of Leyte authored by the Distingueshed Lawyer from Baybay and Palo, there is actually a provision there requiring that concessionaires should obtain "Interposing no objections" from the Baranggay, Municipality and Province. I think one of the things that you can do is you can check the documentations relative to the permits. You could also check because it would also be required an Environmental Certificate coming from the EMB. So if there are already a lot of complaints, check those documents because, probably, those can be basis or references later on for possible legal actions against the concessionaire.

HON. VINCENT L. RAMA: 4TH DISTRICT BOARD MEMBER

Okay. Thank you. Thank you Vice-Gov. I'll look into it Vice.
