115 HON. CARLO P. LORETO: FLOOR LEADER/5<sup>TH</sup> DISTRICT BOARD MEMBER

116 Mr. Chair, item number 25 and 26 in our Agenda is the appointment of Dr. Ronald E.  
117 Flores as Provincial Government Department Head, Provincial Health Officer II with Salary  
118 Grade 26 and the Appointment of Dr. Lea P. Ramos as Provincial Government Department  
119 Head, Provincial Veterinarian with Salary Grade 26. They're here, Mr. Chair. As agreed, so

120 they will not be out of there office for so long, perhaps, we could take up their items first. I  
121 move that we suspend the rules.

122 HON. LEONARDO M. JAVIER, JR.: PRESIDING OFFICER/VICE-GOVERNOR

123 Okay. The rules are now suspended.

124 HON. CARLO P. LORETO: FLOOR LEADER/5<sup>TH</sup> DISTRICT BOARD MEMBER

125 Thank you, Mr. Chair. Mr. Chair, may we hear a few words from Dr. Flores. I've known  
126 him as former vice-mayor of Tanauan and he is a very diligent doctor, Mr. Chair.

127 May we hear from Dr. Flores?

128 HON. LEONARDO M. JAVIER, JR.: PRESIDING OFFICER/VICE-GOVERNOR

129 Dr. Flores, please. Welcome to the Sangguniang Panlalawigan. Good Afternoon.

130 DR. RONALD E. FLORES: PROVINCIAL HEALTH OFFICER I

131 Thank you very much for the invitation. I'm very thankful to the good Governor and of  
132 course to the August Body for this privilege given to me to work with the Province of Leyte  
133 particularly at the Provincial Health Office. Rest assured that under my administration, the  
134 health of our fellow Leyteños will be our utmost concern. That's all, thank you.

135 HON. LEONARDO M. JAVIER, JR.: PRESIDING OFFICER/VICE-GOVERNOR

136 Is there any question from the Board?

137 HON. WILSON S. UY: 1<sup>ST</sup> DISTRICT BOARD MEMBER

138 Mr. Chair, I have a question for Dr. Flores.

139 HON. LEONARDO M. JAVIER, JR.: PRESIDING OFFICER/VICE-GOVERNOR

140 Yes, go ahead.

141 HON. WILSON S. UY: 1<sup>ST</sup> DISTRICT BOARD MEMBER

142 Good Afternoon, Dr. Flores. My question is, do you have any intentions to run for an  
143 elective position this October because I've been hearing your name that you will be going  
144 back to Tanauan. That's all, thank you.

145 DR. RONALD E. FLORES: PROVINCIAL HEALTH OFFICER I

146 Thank you very much for that very wonderful question.

147 I've been enjoying the perks of fewer headaches in the Province of Leyte. I think that  
148 would be stupid for me or rather idiotic for me to go back again. Well, it doesn't mean that I

149 don't like my constituents. I love them so much but I have a bigger cause and that is really to  
150 help our health care service to be better in the Province of Leyte. I believe they can still wait  
151 for me in the proper time. To answer your question, Honorable Uy, I have no intentions to run  
152 for an election position this October.

153 HON. TRINIDAD G. APOSTOL: 2<sup>ND</sup> DISTRICT BOARD MEMBER

154 Mr. Chairman, if I may, I have a question.

155 HON. CARLO P. LORETO: FLOOR LEADER/5<sup>TH</sup> DISTRICT BOARD MEMBER

156 Mr. Chair, will you please recognize the Honorable Apostol, please.

157 HON. LEONARDO M. JAVIER, JR.: PRESIDING OFFICER/VICE-GOVERNOR

158 Yes, go ahead.

159 HON. TRINIDAD G. APOSTOL: 2<sup>ND</sup> DISTRICT BOARD MEMBER

160 Thank you, Mr. Chairman. Thank you, Mr. Floor Leader.

161 Now I just want to ask something to the incoming Head of Provincial Health Office. I  
162 have heard a lot of complaints that all patients going at our Provincial Hospitals are not  
163 attended well. May I know and I'm hoping that with the leadership of Dr. Flores, all the  
164 indigent patients will be attended well. That is just a reminder. Thank you so much.

165 DR. RONALD E. FLORES: PROVINCIAL HEALTH OFFICER I

166 Thank you so much, Honorable Apostol.

167 To answer that question, we have already made the necessary innovation to address  
168 the needs of our indigent patients. Actually yes, we admit that there are some glitches at this  
169 point in time but what is important is that the Provincial Health Office together with the  
170 Hospital Committee are working very hard to be responsive to the needs of our indigent  
171 patients. And with the leadership of Governor Carlos Jericho "Icot" Petilla, and with the  
172 support that he is providing us and also with this August Body giving us enough funds to  
173 purchase for the medicine and re agents for the laboratory, we are really confident that we  
174 will be able to deliver the services that our fellow Leyteños deserve. Thank you very much.

175 HON. TRINIDAD G. APOSTOL: 2<sup>ND</sup> DISTRICT BOARD MEMBER

176 Dr. Flores, if that is the case, I am so happy. I hope it will change this time under your  
177 leadership because I've been hearing a lot of complaints against the Provincial Health Office

178 that they are not well attended there. If this will be realized, I will be so happy. Thank you so  
179 much.

180 HON. CARLO P. LORETO: FLOOR LEADER/5<sup>TH</sup> DISTRICT BOARD MEMBER

181 Mr. Chair, if I may?

182 HON. LEONARDO M. JAVIER, JR.: PRESIDING OFFICER/VICE-GOVERNOR

183 Yes, Honorable Floor Leader, go ahead.

184 HON. CARLO P. LORETO: FLOOR LEADER/5<sup>TH</sup> DISTRICT BOARD MEMBER

185 Thank you, Mr. Chair. If the incoming Provincial Health Officer would be amenable, I  
186 just have a query. A few days ago, personnel from PHO made a presentation about the  
187 status of Dengue in the Province of Leyte. Several towns were in red, some were pink. May  
188 we know, question number 1, is there an outbreak already or are we near the outbreak level?  
189 Number 2, what are the plans of the PHO about dengue?

190 DR. RONALD E. FLORES: PROVINCIAL HEALTH OFFICER I

191 First of all, I would like to apologize for not being able to be with my team when they  
192 came here to present the current status of Dengue because that time, I was called for a  
193 meeting at the PHILHEALTH Central Office. At any rate, the current dengue situation that we  
194 have, if we will compare it historically, what I understand is at 2019 Leyte was able to declare  
195 State of Calamity due to the rise of Dengue cases but at that time, the number of cases of  
196 Dengue as compared to the present was at around Five Thousand plus. Now our cases are  
197 only Three Thousand and the mortality that time reached 21 with 0.028% case fatality rate  
198 but at this point in time our total number of rate is 3,400 plus with Hilongos leading followed  
199 by Baybay and then the case fatality rate for this year is less than 0%. So to answer the  
200 question whether we need to declare a State of Calamity, I think we can only do that through  
201 granular but there are some Municipalities who actually already declared State of Calamity,  
202 for example is Isabel. For Hilongos, though they have already exceeded the Epidemic  
203 Threshold, the Mayor is still hesitant to declare. So what are we doing right now is, as usual,  
204 the way to prevent dengue are the preventive measures and one of which is the Search and  
205 Destroy and the Fogging. Right now, the team is in Hilongos and they have already  
206 conducted a series of meetings with the ABCs because this is really to capacitate our

207 Barangay Officials kasi nandun talaga sa kanila ang basic response to halt the increasing  
208 number of Dengue cases and that is really by clean up drive, search and destroy and  
209 fogging.

210 HON. CARLO P. LORETO: FLOOR LEADER/5<sup>TH</sup> DISTRICT BOARD MEMBER

211 Mr. Chair, considering that the appointee satisfactorily answered our query, I move  
212 that we confirm his appointment.

213 HON. VINCENT L. RAMA: 4<sup>TH</sup> DISTRICT BOARD MEMBER

214 Mr. Presiding Officer, if I may?

215 HON. CARLO P. LORETO: FLOOR LEADER/5<sup>TH</sup> DISTRICT BOARD MEMBER

216 Mr. Chair, will you please recognize the Honorable Rama?

217 HON. LEONARDO M. JAVIER, JR.: PRESIDING OFFICER/VICE-GOVERNOR

218 Honorable Rama, you are recognized.

219 HON. VINCENT L. RAMA: 4<sup>TH</sup> DISTRICT BOARD MEMBER

220 Before we approve it, may we ask the good Dr. Flores what is exactly his role sa entire  
221 Province because for Board Member Centino and I, we have the ODH. My question is, are  
222 you also in charge of the people running that hospital? And may we have an update on that  
223 Palompon Hospital where I think you and I, the Governor and I think Board Member Raissa  
224 were there. Just an update because I remember the Chief of Hospital was pulled out. Can we  
225 have an update?

226 DR. RONALD E. FLORES: PROVINCIAL HEALTH OFFICER I

227 Thank you very much. Actually, I just came from Palompon Hospital because I did  
228 their MANCOM because at this point in time I am also their Hospital-in-charge. Nobody from  
229 the pool of Doctors we have in Leyte wants to become the Chief in Palompon Hospital.

230 HON. VINCENT L. RAMA: 4<sup>TH</sup> DISTRICT BOARD MEMBER

231 Before that, Dr. Flores, can you give the rest of the Body the situation there so the  
232 Vice Governor will understand the situation of Palompon, before and after?

233 DR. RONALD E. FLORES: PROVINCIAL HEALTH OFFICER I

234 The problem in Palompon is they have an issue with their Chief of Hospital because of  
235 some petty issues that just boils down to one thing, the very strong politics in there that

236 divides the employees. There is a TEAM O and there is TEAM A and then affected ang  
237 kanilang services so what we did is we did not deal so much the issue in politics but we go  
238 back to their status. So our style then was to inform then that Palompon will close if they will  
239 not behave because their income is very low. In fact, in 2022-2023, the government was  
240 spending P 14,000.00 per patient as subsidy compared to the Leyte Provincial Hospital  
241 wherein the subsidy is only at P160.00. So we are spending so much for them. We were  
242 looking for a Chief of Hospital that will replace the present but nobody wants so I have to  
243 volunteer because I told them that we still need to give chance to Palompon Hospital for it to  
244 survive and for it to be useful for the community. If we really close Palompon Hospital, then  
245 there would be some political ramification so I volunteered and then we transferred the  
246 excess workers there to the nearby hospital which is Villaba in order to provide additional  
247 manpower support. So to cut the story short, this morning I had their MANCOM and I was  
248 able to present to them their current financial status, that for the 2<sup>nd</sup> quarter, the time when  
249 we introduced changes for Palompon Hospital, the income of Palompon Hospital is negative  
250 but now on the 2<sup>nd</sup> Quarter it is now positive. We are not anymore providing them so many  
251 subsidies because in the last computation that we have for the 2<sup>nd</sup> Quarter, they already  
252 posted an income of about P150,000.00 which is very good compared to the previous that  
253 there income was always negative.

254 HON. CARLO P. LORETO: FLOOR LEADER/5<sup>TH</sup> DISTRICT BOARD MEMBER

255 Mr. Chair?

256 HON. LEONARDO M. JAVIER, JR.: PRESIDING OFFICER/VICE-GOVERNOR

257 Go ahead, Floor Leader.

258 HON. CARLO P. LORETO: FLOOR LEADER/5<sup>TH</sup> DISTRICT BOARD MEMBER

259 I'm sorry to cut off Dr. Flores. Clearly, he is very competent so I would like to re iterate  
260 my motion to confirm his appointment as the Provincial Health Officer II. I so move.

261 HON. RAISSA J. VILLASIN: 2<sup>ND</sup> DISTRICT BOARD MEMBER

262 Second.

263 HON. LEONARDO M. JAVIER, JR.: PRESIDING OFFICER/VICE-GOVERNOR

264 It's been seconded.

276 I just have some words for you, Dr. Flores. Please don't give our good governor a  
277 headache as far as health is concerned.

278 DR. RONALD E. FLORES: PROVINCIAL HEALTH OFFICER I

279 Definitely, Vice-Gov.

280 HON. CARLO P. LORETO: FLOOR LEADER/5<sup>TH</sup> DISTRICT BOARD MEMBER

281 Thank you, Mr. Chair.

282 Mr. Chair before us today also is Dr. Lea Ramos, appointed by the Provincial  
283 Governor as the Provincial Veterinarian. May we hear a few words from her as well, Mr.  
284 Chair?

285 HON. LEONARDO M. JAVIER, JR.: PRESIDING OFFICER/VICE-GOVERNOR

286 Dr. Ramos, you are recognized. Welcome to Sangguniang Panlalawigan.

287 DR. LEA P. RAMOS: OIC-PROVINCIAL VETERINARY OFFICE

288 Good afternoon, Vice Governor and to our Provincial Board Members. I am Dr. Lea P.  
289 Ramos, a native of Palo, Leyte and I have served the Provincial Veterinary office for more  
290 than 28 years. I've been a staff of the former Provincial Vet. I am very much thankful to our  
291 dear Governor that I have been selected to be the Provincial Head for the Veterinary Office.  
292 Thank you so much.
