A RESOLUTION APPROVING ON THIRD AND FINAL READING, PROVINCIAL ORDINANCE NO. 2021-02, ENTITLED: "AN ORDINANCE AMENDING, MODIFYING, AND REPEALING CERTAIN PROVISIONS OF ORDINANCE NO. 2020-15 OTHERWISE KNOWN AS THE UNIFORM COVID-19 INTEGRATED LEYTE PROTECTION HEALTH PROTOCOLS OR ILP HEALTH PROTOCOLS ORDINANCE, TO HARMONIZE SAID ORDINANCE WITH THE NATIONAL IATE RESOLUTION NO.101 SERIES OF 2021 ON TRAVEL PROTOCOLS FOR LAND, AIR AND SEA, AND FOR OTHER PURPOSES".

WHEREAS, on 26 February 2021, the National Inter-agency Task Force ("National IATF") for the Management of Emerging Infectious Diseases passed Resolution No. 101, Series of 2021, approving the uniform travel protocols for land, air, and sea of the Department of the Interior and Local Government, crafted in close coordination with the Union of Local Authorities of the Philippines, League of Provinces of the Philippines, League of Municipalities of the Philippines, and the League of Cities of the Philippines;

WHEREAS, on 4 March 2021, the League of the Municipalities of the Philippines – Leyte Chapter ("LMP – Leyte") adopted Resolution No. 1, Series of 2021, harmonizing the LMP Leyte integrated Protocals with National IATE Resolution No. 191 Series of 2021 on Travel Protocols for Land, Air and Sea;

AN ORDINANCE AMENDING, MODIFYING, AND REPEALING CERTAIN PROVISIONS OF ORDINANCE NO. 2020-15 OTHERWISE KNOWN AS THE UNIFORM COVID-19 INTEGRATED LEYTE PROTECTION HEALTH PROTOCOLS OR ILP HEALTH PROTOCOLS ORDINANCE, TO HARMONIZE SAID ORDINANCE WITH THE NATIONAL IATE RESOLUTION NO.101 SERIES OF 2021 ON TRAVEL PROTOCOLS FOR LAND, AIR AND

Be it ordained by the Sangguniang Panlalawigan of Leyte, that:

ARTICLE

TITLE, POLICY AND PRINCIPLES AND DEFINITION OF TERMS

Section 1. Title. This ordinance shall be known as the "Amended Uniform COVID-19 Integrated Leyte Protection Health Protocols or ILP Health Protocols Ordinance".

Section 2. Amendments to Quarantine and Testing Protocols in Sections 3, 5 and 8 of the ILP Health Protocols Ordinance. Without prejudice to observance of entry protocols mandated by the National IATF pursuant to additional measures to be observed to protect the population from new COVID – 19 variants as set forth in the Memoranda of the Executive Secretary, Sections 3, 5, and 8 of the ILP Health Protocols Ordinance are hereby amended to conform with the uniform travel protocol that no traveler shall be required to undergo quarantine unless said traveler exhibits symptoms upon arrival at the local government unit (LGU) of destination, Sections 5 and 8 of the ILP Health Protocols Ordinance are likewise amended to empower the local chief executive and the Sangguniang

Bayan/Panlungsod of a component municipality or city of the Province of Leyte, to declare that prior RT-PCR testing at the city or municipality of origin yielding a negative result shall be a mandatory requirement for travel of individuals destined for said local government unit (LGU), provided that said LGU's Inter-Agency Task Force ("IATF") obtains prior approval from the Provincial IATF through the Governor of the Province of Leyte, in accordance with the uniform travel protocol set forth under Section (B) (1) of National IATF Resolution No. 101, Series of 2021; Provided, further, that peculiar circumstances that warrant the implementation of stricter travel protocols will be considered pursuant to an Exigent Circumstances Request lodged by the IATF of a component Municipality/City of the Province of Leyte in the form of an IATF resolution lodged with the Provincial IATF through the Governor, and premised on the need for a deviation of the Province of Leyte's travel protocols in order to curtain a possible outbreak; Provided, finally, that the aforesaid modifications or amendments shall not, in any way, affect the destination LGU's power and discretion to require RT-PCR testing, not as a prior requirement for travel, but as a requirement for entry at the LGU of final destination.

2.1. Section 3.c. is hereby amended to read as follows;

"3.c. Quarantine, for purposes of this Ordinance, refers to the physical separation and restriction of movement of persons who were exposed to COVID-19, to see if they become sick with COVID-19 and may therefore become infectious. Quarantine of exposed persons is a public health strategy medically proven to be very effective in protecting the public from disease. Quarantine, as a public health strategy to contain the spread of COVID-19, may be mandatory or observed voluntarily as a precautionary measure, and shall apply (1) in accordance with law, morals, good customs, public order, or public policy, (2) upon arrival in the territorial jurisdiction of the Province of Leyte, and (3) as a safeguard to prevent the spread of COVID-19, in accordance with the provisions of this Ordinance. The rules governing Quarantine as set forth in this Ordinance shall be without prejudice to the application of existing rules and issuances by the National IATF on the Quarantine of individuals/arriving passengers and Authorized Persons Outside Residence (APOR), existing prohibitions and procedures on entry pursuant to rules and protocols generally applicable to arriving individuals and/or APOR, and mandatory criteria for releasing individuals who may be afflicted with COVID-19.

2.2. Section 5 is hereby amended to read as follows:

"5. RT – PCR Testing Protocol. The following RT-PCR Testing protocol shall apply without prejudice to observance of travel protocols mandated by the National IATF on the testing and Quarantine of individuals/arriving passengers and Authorized Persons Outside Residence (APOR), existing rules and protocols generally applicable to arriving individuals and/or APOR, and mandatory criteria for releasing Quarantined individuals showing symptoms of COVID-19:

> 5.n. If a person tests negative under the RT-PCR test and the person exhibits no symptoms of COVID-19, the person will be discharged unless existing Quarantine protocols provide otherwise. If the person tests negative under the RT-PCR test but exhibits COVID-19 symptoms, the person shall comply with existing Quarantine and/or

- 2.3. Section 8 is hereby amended to read as follows:
 - "8. Testing Protocol Using Rapid Test Kits. Without prejudice to generally applicable and existing prohibitions, procedures and protocols, the following Testing protocol using Rapid Test Kits shall be employed for contact tracing and baseline monitoring purposes, and not as a prior requirement for travel to the destination LGU.

8.f. If a person tests negative under the RT-PCR test but positive in the rapid test, the person may be discharged unless the person exhibits COVID-19 symptoms, in which case the person will undergo Quarantine until his/her symptoms have disappeared and he/she is given clearance by the City or Municipal Health Officer (C/MHO)."

Section 3. Amendments to Protocols for Individuals Arriving in the Province of Leyte in Sections 10 and 11 of the ILP Health Protocols Ordinance. prejudice to observance of entry protocols mandated by the National IATE pursuant to additional measures to be observed to protect the population from new COVID – 19 variants as set forth in the Memoranda of the Executive Secretary, and legally permissible exemptions warranted by circumstances to curtail a possible Covid-19 outbreak, Sections 10 and 11 of the ILP Health Protocols Ordinance are hereby amended to conform with the uniform travel protocol that no traveler shall be required to undergo Quarantine unless said traveler exhibits symptoms upon arrival at the local government unit (LGU) of destination, or tests positive for COVID-19 using RT-PCR at the LGU of destination, as the case may be, and even upon arrival without symptoms at the LGU of destination, that said individual nonetheless agrees to strict compliance with minimum public health standards and local health protocols, immediate and expedient disclosure and reporting of COVID-19 symptoms, and prompt payment of fines and penalties as a result of non-compliance and or belated disclosure and reporting of COVID-19 symptoms.

3.1. Section 10 is hereby amended to read as follows;

"10. Protocol for All Persons Arriving in the Province of Leyte. The following protocol shall apply without prejudice to (1) the observance of entry procedures, rules, and protocols mandated by the National IATF pursuant to additional measures to be observed to protect the population from new COVID – 19 variants as set forth in the Memoranda of the Executive Secretary, and (2) legally permissible exemptions warranted by exigent circumstances to curtail a possiple Covid-19 outbreak, in conformity with the uniform

travel protocol that no traveler shall be required to undergo quarantine unless said traveler exhibits symptoms upon arrival at the local government unit (LGU) of destination, and even upon arrival without symptoms at the LGU of destination, that said individual nonetheless agrees to strict compliance with minimum public health standards and local health protocols, immediate and expedient disclosure and reporting of COVID-19 symptoms, and prompt payment of fines and penalties as a result of noncompliance and or belated disclosure and reporting of COVID-19

10.a. The component city or municipal government of the destination LGU is hereby empowered to craft its protocols requiring prior notification and coordination by all persons destined for said LGU with the Municipal/City Health Officer of the component LGU or his/her duly designated representative, or the component LGU's Focal Person, as the case may be, prior to said person's arrival in the destination LGU, through any mode of official communication that is duly recognized by the component destination LGU.

10.b. Unless otherwise mandated by the National and Provincial IATF, the documentary requirements of Travel Authority issued by Joint Task Force COVID Shield and health certificates shall no longer be required in compliance with National IATF Resolution No. 101, Series of 2021. Nevertheless, all individuals arriving in the Province of Leyte shall be required to register and/or notify the Provincial IATE through its focal person, of their details of arrival, through any mode of official communication, and through the Safe, Swift, and Smart Passage (S-PaSS) Travel Management System of the DOST in accordance with Section 12 of this Ordinance.

10.c. All individuals arriving at the destination LGU must report to their City/Municipal Health Office, BHERT, City/Municipal Focal Person, or any authorized person designated by the component destination LGU at reasonable office hours not later than 24 hours

10.d. The C/MHO, RHU, BHERT, LGU Focal Person or Designated Personnel shall comply with health assessment protocol and determine if the arriving individuals manifest Covid-19 symptoms that warrant Quarantine and RT-PCR-testing.

10.d.1. If the arriving individuals manifest Covid-19 symptoms, they will be subject to Quarantine and scheduled for RT-PCR testing.

10.d.2. If the arriving individuals do not manifest Covid-19 symptoms, they will be required to sign an Oath of Undertaking, and reminded that they may opt to voluntarily Quarantine themselves as a precautionary measure.

10.d.3. All arriving individuals who do not manifest Covid-19 symptoms upon their arrival at their destination LGU as confirmed by health assessment protocol, shall execute an Oath of Undertaking binding each of them to the following obligations, non-compliance of which, shall be punishable under this Ordinance and applicable law:

- (i) That said individual shall faithfully abide by and strictly comply with the minimum public health standards which include physical distancing, hand hygiene, cough etiquette, and wearing of face masks and face shields among others, in all settings;
- (ii) That said individual undertakes to immediately disclose and report to the C/MHO, RHU, BHERTs, LGU Focal Person or Designated Personnel any Covid-19 symptoms they experience for the entire duration of the Covid-19 pandemic;
- (iii) That said individual undertakes to be held liable for non-disclosure and/or belated reporting of Covid-19 symptoms experienced during their stay at the destination LGU for the entire duration of the Covid-19 pandemic, and to promptly and willingly pay the fines and/or penalties as a consequence of their belated reporting or non-disclosure of their Covid-19 symptoms that arose or became manifest during their stay at the destination LGU.

10.e. The C/MHO, RHU, BHERT, LGU Focal Person, or Designated Personnel shall visit the arriving individuals at least once between the 5^{th} - 10^{th} day from arrival in the destination LGU, in order to monitor their health condition.

10.f. As warranted by circumstances, the C/MHO, RHU, BHERTs, LGU Focal Person, or Designated Personnel may require arriving individuals or their close contacts to undergo Quarantine and Covid-19 testing in order to curtail any possible Covid-19 transmission.

10.g. Any individual displaying Covid-19 symptoms must undergo Quarantine and shall be subjected to RT-PCR testing. In the event that the RT-PCR test of said individual yields a Covid-19 positive result, said individual shall be brought to the Municipal Isolation Center or Isolation Facility, as the case may be, for proper care and management. Should the RT-PCR test of said individual yield a negative RI-PCR result, said individual shall nonetheless remain in Quarantine until his/her symptoms have disappeared and he/she is

10.h. In case of peculiar circumstances that warrant the implementation of stricter travel protocols, the requesting component LGU shall, through its C/MIATF, issue a Resolution requesting the Provincial IATF through the Governor, for an Exigent Circumstances deviation of these Travel Protocols in order to curtail a possible Covid-19 outbreak. The IATF-sanctioned exemption to the application of the Travel Protocols set forth in this Ordinance shall be incorporated by the requesting LGU in their MIATF Resolution approving stricter travel protocols warranted by exigent Circumstances justifying the requested departure from established Travel Protocols.

- 10.i. All other contrary provisions of Section 10 from the prior ILP Health Protocols Ordinance are hereby repealed.
- 3.2. Section 11 is hereby amended to read as follows:

Section 11. Protocol For Overseas Filipino Workers (OFWs), Returning Local Residents and Balik Probinsya Beneficiaries.

11a. Returning Local Residents refer to people who are currently located in provinces in the Philippines other than their home province, and who intend to go back to their home towns right after the quarantine in the origin province, city, or municipality is lifted.

11.b. Balik-Probinsya program is a National Government program open to Returning Local Residents and individuals who have signified their intention to relocate to their home province ("BP2 beneficiaries"), enabling them to avail of logistical assistance provided by the National Government to facilitate their migration or travel back to their respective hometowns. In this case, the National Government shall coordinate with the Receiving LGU for the purpose of sending individuals back to their respective hometowns. Efficient and expedient coordination between the National government and the Receiving LGU shall necessitate the prompti exchange of pertinent information, which shall include communicating and acknowledging receipt of the following information at the soonest home towns, (2) destination address, (3) mode of transportation, and (4) port.of arrival.

11.c. All arriving individuals shall comply with the prior notification and coordination requirements referred to in Section 10 of this Ordinance.

11.d. All arriving individuals shall undergo mandatory health assessment and symptom screening in accordance with mandatory travel protocol.

11.e. All arriving individuals exhibiting Covid-19 symptoms at the destination LGU shall undergo Quarantine in accordance with mandatory travel protocol.

11.f. The RT- PCR test shall be conducted on the arriving individual if said individual exhibits any of the Covid-19 symptoms referred to in Section 5.a upon arrival at the destination LGU. If said individual tests negative for COVID-19, he or she shall remain in Quarantine until his/her symptoms disappear and he/she is given clearance by the C/MHO, If the patient tests positive, he/she shall be brought to the Isolation Facility for proper care and management.

11.g. If the C/MHO suspects that the person has a high probability of being infected during the domestic travel (land, sea and air) and if the person, having exhibited Covid-19 symptoms, is a candidate for RT - PCR test, then the RT - PCR test shall be conducted on said person in accordance with RT-PCR testing protocol, in order for the Receiving LGU/municipality to ensure detectible viral load and to avoid false negative results in RT - PCR.

11.h. The following rules shall govern in cases of mandatory Quarantine at home or in an accredited private facility:

11.h.1. Mandatory home Quarantine upon on Day 1 of arrival shall be recognized on the condition that the arriving person/persons will stay in an exclusive house with no other existing residents for the duration of Quarantine. The house shall be inspected by designated people from the Mayor's office, and shall be accredited as a home Quarantine facility with the approval and concurrence from the Barangay Chairman shall ensure that applicable Quarantine protocols are adhered to.

11.h.2. Completion of the mandatory Quarantine by moving the person from the municipal/barangay quarantine to home quarantine shall be considered permissible under the following conditions: 1) the person exhibiting Covid-19 symptoms has undergone RT - PCR testing and the result is negative; 2) the house to which the person will be moving to has a dedicated room separate from the rest of the existing residents of the house; 3) Quarantine is made practicable on account of the room having dedicated toilet and bath facilities.

11.h.3. The Barangay Chairman shall see to it that the person in mandatory Quarantine shall be monitored by posting the barangay tanod near the house of the person in quarantine. The BHERT shall also monitor the health condition of the person in quarantine and shall report information to the MHO on a regular basis.

11.1. The component City/Municipalities in the Province of Leyte are encouraged to pass an ordinance or resolution making it mandatory for arriving person to report to the Office of the Mayor or the C/MHO to supplement the Mandatory Registration, Disclosure and Reporting for COVID-19 Contact Tracing, Surveillance, and Response Provincial Ordinance No. 2020-12.

11.j. The City/Municipalities in the Province of Leyte are also encouraged to formulate a reward system for those people who report arrivals of person who did not coordinate with the Office of the Mayor or the C/MHO, to supplement the Mandatory Registration, Disclosure and Reporting for COVID-19 Contact Tracing, Surveillance, and Response Provincial Ordinance No. 2020-12.

11.k. The graphical flowchart reference "G&J. OFW & RLR" of the LEYTE-FLOWCHART attached as Annex G of this Ordinance is hereby modified. All other contrary provisions of Section 11 from the prior ILP Health Protocols Ordinance are hereby repealed.

Section 4. Information and Communication Technology Solutions, and Amendments to Protocols on Information Sharing and Contact Tracing in Section 12 of the ILP Health Protocols Ordinance. To ensure centralized registration and contact tracing, compliance with the IATF requirement to report those who have availed of Covid-19 vaccination, and to institutionalize the sharing of required information by the Province of Leyte with the focal persons it must coordinate with, Section 12 is hereby amended to read as follows:

"Section 12. Information and Communication Technology Solutions, Information Sharing And Contact Tracing. The Province of Leyte shall adopt and institutionalize a centralized registration system to track all arriving individuals for contact tracing purposes, assign a focal person, and identify and report all who have availed of Covid-19 vaccination, in conformity with the institutionalized Department of Science and Technology's Safe, Swift, and Smart Passage (S-PaSS) Travel Management System for travelers, and integrated with the StaySafe.ph System's primary contact tracing system pursuant to National IATE Resolution No. 85 series of 2020."

12.a. Once a person tests positive for Covid-19, it is imperative that Information should be shared with city/municipalities in accordance with established Covid-19 surveillance protocols to contain the spread of Covid-19.

12.b. During the contact tracing, the Mayor should order a thorough interview with the patient who tested positive, complete with timeline and detailed narrative. The interview should be documented in writing, and if possible, with video or audio recording.

12.c. The information should be shared with the LGU and National Government Agencies (NGAs), particularly where these NGAs may be affected by the contact tracing underway due to exposure or possible contamination as a result of direct contact with a confirmed COVID-19 positive patient. The information sharing is intended to address the spread of COVID-19 envisioned by scenarios similar to the following example where Municipal A has a Confirmed COVID-19 positive patient who had contact with people in Municipal B, thus necessitating the sharing by Can take proper action including triggering contact tracing in Municipal B.

> 12.d. Data privacy shall be observed in the handling of protected information regarding a confirmed COVID -19 patient, in consonance with the DOH guarantee protecting the data privacy rights of patients from unbridled disclosure to the public that has been proven to cause a real risk of severe harm to patients. As such, all personally-identifiable information gathered shall be treated with utmost confidentiality and should only be shared with pertinent authorities with the aim of ensuring of public safety as the primary purpose.

The Mayor shall form a contact tracing team with suggested 12.e. minimum members as follows: 1) PNP personnel with background in Cognitive Interview; 2) City or Municipal Health Officer.

12.f. Contact tracing is a crucial tool to contain the spread of COVID - 19. Hence, during the conduct of contact tracing in a city/municipality where COVID -19 infection has been recently discovered, the Governor and/or the LMP, thru its chapter President, may send an augmentation tracing team to assist the affected component city or municipality.

The Mayor and/or the C/MHO shall report all findings to the PHO 12.g. and DOH."

Section 5. Separability Clause. If, for any reason, any part or provision of this Ordinance shall be held unconstitutional or invalid, other parts or provisions hereof, which are not affected thereby, shall continue to be in full force and

Section 6. Repealing Clause. All ordinances, orders, resolutions, instructions, rules and regulations, or parts thereof, which are previously issued and inconsistent with any provision of this Ordinance, are hereby repealed or modified

Section 7. Effectivity. This Ordinance shall take effect immediately upon approval due to the urgency of the concern caused by the COVID-19 pandemic. Should the declared state of national emergency be lifted, the regulations imposed in this Ordinance shall accordingly be suspended until a subsequent Declaration of State of Calamity is made in accordance with Section 16 of Republic Act No. 10121, or a subsequent Declaration of Epidemic or Public Health Emergency is made in accordance with Section 7 of Republic
