

WHEREAS, Section 16 of the local Government Code of 1991 provides that every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balance ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, Section 4 of house bill No 8149 institutionalizing a New Filipino Gesture of Respects, Goodwill and Praise states that a new and safe gesture of respects, goodwill, and praise shall be observe and performed through the simple act of gracefully laying the palm of the right hand over the center of one's chest while simultaneously lowering the head, with eyes either closed or cast down;

WHEREAS, Section 1 of the Republic Act 9593 declares tourism as an indispensable element of the national economy and an industry of national interest and importance, which must be harnessed as an engine of socio-economic growth and

cultural affirmation to generate investment, foreign exchange, and employment, and to continue to mold an enhanced sense of national pride for all Filipinos;

WHEREAS, under the completed National Tourism Development Plan (NTDP) 2023 to 2028, the DOT shall "establish a Philippine tourism industry anchored on Filipino culture, heritage, and identity, which aims to sustainable, resilient, competitive in order to transform the Philippines into a tourism powerhouse in Asia",

WHEREAS, the Department of Tourism (DOT) seeks the support of Municipality of Matag-ob to cascade the Filipino Brand of Service Excellence Program through the institutionalizing of "Mabuhay and Salamat" gesture as a form of greetings in government offices, local government units, academic institutions, tourism enterprises and establishments, during government program gatherings, in answering phone calls, and public speeches;

WHEREAS, the Mabuhay and Salamat gesture under the Filipino Brand of Service Excellence Program is the department's thrust to promote the best qualities and positive values of Filipino hospitality and envision to enhance and uplift the quality of tourism services in the country by fostering excellent service to tourists as part of distinct Filipino brand, thereby making the excellence in service as the regional brand and a holistic national identity;

WHEREAS, the Municipality of Matag-ob recognizes the importance of providing quality and excellence service to its constituents and in instilling the culture of service excellence among tourism stakeholders to raise the quality of standards among the workforce in tourism industry and service sectors;

WHEREAS, in support to the national thrust of Philippine Tourism Industry, it is deemed necessary to institutionalize the Mabuhay and Salamat gesture in the Municipality of Matag-ob which shall give substantial benefits in terms of tourism promotion, guest/client satisfaction, human resource development, ang quality customer service, without entailing the amount of investment of fund allotment on the part of the province.

BE IT ORDAINED, by the Honorable Sangguniang Bayan of Matag-ob in SESSION ASSEMBLE **THAT**:

Section 1. TITLE. This Ordinance shall be known as the "MABUHAY AND SALAMAT GESTURE ORDINANCE",


Section 2. SCOPE AND COVERAGE. This Ordinance shall cover all government offices and facilities, academic institutions, business entities, tourism establishments, and tourism frontliners in the Municipality of Matag-ob, Leyte.

Section 3. DEFINITION OF TERMS.

- 3.1 Filipino Brand of Service Excellence- is a Department of Tourism (DOT)initiated program designed to promote excellence in delivering customer service, interacting with customers, optimizing sales, and handling customer concerns founded on Filipino Values.
- 3.2 Mabuhay-is a Filipino greeting, usually expressed as Mabuhay! The phrase carries various meanings including "long live", "may you live", "cheers", "welcome", and "hurrah". The expression is mostly used for toast during gathering and parties, and is used as a cry of adulation towards individuals or concepts at rallies and political conference. For the purpose of this ordinance, the word Mabuhay means the modern appropriation of the greetings in the local hospitality industry to welcome guests.
- 3.3 PRIMARY TOURISM ENTERPRISES facilities and services that are directly related to tourism such as, but not limited to, travel and tour services: inbound travel agencies and tour operators, local tour operators, and tour guides; tourist transport services whether for land, sea and air transport exclusively or majority of its seats are for tourist use, including airport taxis and tourist driver; accommodation establishments such as, but not limited to, hotel, resorts, apartment hotels, tourism inns, motels, pension houses, private homes use for home stay, ecolodge, condotels serviced apartment, and bed and breakfast facilities; hotel tourism estate management services; meetings, incentives, conventions, and exhibition organizers and facilities; sports and recreational facilities such as, but not limited to, dive shops, amusement parks, adventure and ecotourism facilities; foreign exchange dealers and such enterprises as maybe identified by the secretary, after due consultation with concerned sectors.
 - 3.4 SALAMAT the act of thanking or an expression of gratitude.
- 3.5 SECONDARY TOURISM ENTERPRISES facilities and services that may be related to tourism such as, but not limited to, restaurants; specialty shops and department stores; sports facilities and recreational centers such as, museums and galleries, theme parks, zoos; health and wellness facilities such as, but not limited to, spas, tertiary hospitals, ambulatory clinics and medical concierge; rest areas in gas stations; Agri-tourism farm and facilities; tourism training centers or Institute, including tourism trainers; outbound travel agencies; and such other enterprises as may be identified by the Secretary, after due consultation with concerned Sectors.

3.6 TOURISM ENTERPRISES - facilities, services and attractions primarily engaged in whole or in part in tourism and for the purpose of attracting visitors to and within the Philippines, such as, but not limited to enterprises provided for under the Primary and Secondary Tourism Enterprises.

Section 4. USE OF MABUHAY AND SALAMAT - shall be used as official greetings in government offices, tourism-related establishments (Primary and Secondary Tourism Establishments), institutions and service providers, schools/colleges/universities and business entities in:

- i. Receiving, welcoming and thanking guests;
- ii. Answering phone calls;
- iii. Interacting with clients/costumers.

4.1. PROPER EXECUTION OF THE MABUHAY AND SALAMAT GESTURE.

The proper execution of the Mabuhay and Salamat gesture shall be observed:

- i. To utter the "Mabuhay" with the right hand in open palm (close knitted) placed on the left Side of the chest, sporting a smile and eye contact with the person to be greeted, then simultaneously bow the head then say the phrases "good morning" "good afternoon" as the case may be;
- ii. For welcoming the visitors and guest in tourism establishments to say the word "Mabuhay!" with the right hand in open palm (closed knitted) placed on the left side of the chest, sporting a smile and eye contact with the person to be greeted, then simultaneously bow the head then say the phrases "good morning" or "good afternoon" or "good evening" as the case may be, followed by saying "I'm [your name] "Welcome to [name of the office/establishment] whichever is applicable:
- iii. For offering a toast: say the word "Mabuhay" simultaneously raising the glass;
- iv. During speeches: as part of salutation, after acknowledging the guest or visitors, say the word "Mabuhay" with the right hand in open palm ("close knitted") placed on the left side of the Chest, then simultaneously bow the head, then utter the phrases "good morning" or "good Evening" as the case may be. At the end of speech, say the words: "Thank you and Mabuhay!" or "Salamat and Mabuhay!" or "Mabuhay tayong lahat!"

- v. In answering phone calls: upon answering first say the word "Mabuhay!" followed by saying "This is <u>[your name]</u> or <u>[name of office/establishments]</u> followed by the phrase: "What can I do For you?" or "How may I help you?"
- vi. For Government Offices interacting with clients: first say the word "Mabuhay!" with the right hand in an open palm (close knitted) placed on the left side of the chest, sporting a smile and eye contact of the person to be greeted, then simultaneously bow the head then proceed to introduction your name as the name of respective office, followed by the phrase: "what can I do for you?" or "how may I help you?" or its equivalent in local dialect.
- vii. For Malls, Convenient Stores, and other business establishments: first say the word "Mabuhay!" with the right hand in open palm (close knitted) place on the left side of the chest, sporting a smile and eye contact of the person to be greeted, then simultaneously bow the head then say the phrases "good morning" or "good afternoon" or "good evening" as the case may be and proceed business transaction. Thank the costumer by saying "Salamat Maam or Sir" whichever is applicable, with the right hand in open palm (close knitted) placed on the left side of the chest, sporting a smile and eye contact with the person thanking with.
- viii. For Schools, Colleges and Universities: integration Mabuhay and Salamat in academic activities and learning instructions.
- **Section 5. OFFICE OF THE MUNICIPAL TOURISM (OMT).** Shall ensure implementation of this Ordinance and shall reflect in its annual regular program in coordination with the department of tourism.
- Section 6. CONDUCT OF FILIPINO BRAND OF SERVICE EXCELLENCE (FBSE) TRAINING. The Filipino Brand of Service Excellence Training Shall be held regularly in all tourism-related establishments, government offices, academic institutions and other agencies, offices, organizations, and institutions as may deemed necessary by the OFFICE OF THE MUNICIPAL TOURISM (OMT). and its lined government agency.
- Section 7. INFORMATION AND EDUCATION AND COMMUNICATION (IEC) CAMPAIGN. The OMT shall spearhead the information dissemination for the implementation of this Ordinance.
- **Section 8. AMENDMENT CLAUSE.** This ordinance may be amended or modified as necessary through the appropriate legislative process.

Section 9.FINAL PROVISION. In the event that any provision of this ordinance, or application of such provision to any circumstance, is held invalid by competent court or agency, the remaining or other provisions shall not be affected thereby.
