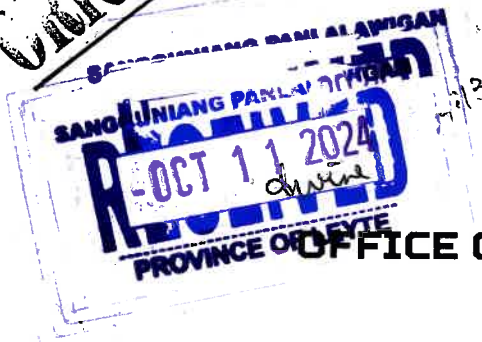

VERIFIED ANSWER

I, **ANGEL ARAS SIA JR.**, Filipino, of legal age, married, a resident of Poblacion District IV, La Paz, Leyte, incumbent Municipal Mayor of LGU-La Paz, Leyte with Salary Grade 27, in compliance with Resolution No. 2024-359 of the Office of the Sangguniang Panlalawigan of Leyte received on 28 September 2024, seasonably files this **VERIFIED ANSWER**, and under oath hereby depose and state: **THAT---**

THE DEFECTIVE ADMINISTRATIVE COMPLAINT

1. This complaint is supposedly grounded on the Legal Administrative Charges provided under Section 60 of Rep. Act no. 7160 in relation to Section 5(a) of Rep. Act no. 6713, to wit:

Section 60. Grounds for Disciplinary Actions. – An elective local official may be disciplined, suspended, or removed from office on any of the following grounds:

c. xxx Misconduct in Office xxx dereliction of duty

X.X.X

Section 5. Duties of Public Officials and Employees. — In the performance of their duties, all public officials and employees are under obligation to:

(a) Act promptly on letters and requests. — All public officials and employees shall, within fifteen (15) working days from receipt thereof, respond to letters, telegrams or other means of communications sent by the public. The reply must contain the action taken on the request. (Underlining & Emphasis Ours)

2. These administrative charges were defectively applied in the complaint-affidavit with certificate of non-forum shopping of Marvin

T. Marticio dated 19 August 2024¹ before this SP-Leyte and another complaint-affidavit with certificate of non-forum shopping of Marvin T. Marticio dated 7 February 2024² before the Ombudsman (Visayas), viz:

- (a) He and his sons Raymart P. Marticio and Raffy P. Marticio went to a residential lot designated as Lot no. 3046 situated at Brgy. Pansud, La Paz, Leyte purchased by Emy De Paz Marticio from the heirs of Maximo Magayones and Aquilina Gara per Extrajudicial Settlement of Estate with Sale dated 30 December 2023 (*blurred photocopy*);
- (b) He was surprised to see that the house in Brgy. Pansud, La Paz, Leyte was being fenced by several individuals he identified as Punong Barangay Eleuterio L. Magayones, Brgy. Kagawad Arsenio S. Alcuetas, Jr. Brgy. Kagawad Emelinda S. Versoza, Brgy. Kagawad Jesus M. Solibar, Brgy. Kagawad Melmer A. Quillotes, Brgy. Kagawad Charlito A. Badion, Brgy. Secretary Gina A. Cayobit, Brgy. Treasurer Myra P. Alvero and SK Chairman Dexter A. Quillotes – who are not respondents in this instant case;
- (c) These barangay officials claim ownership of this property after being asked the reason for fencing the premises; the confrontation turned ugly and violent after verbal altercation between the parties;
- (d) On 8 January 2023, he instructed Emy P. Marticio to secure the services of Atty. Tenebro to write a formal letter to Hon. Angel Aras Sia Jr. in order to call out the attention of Punong Barangay Eleuterio L. Magayones for the incident transpired on 6 January 2024 per Letter dated 8 January 2023;
- (e) **Unfortunately, Mayor Angel A. Sia Jr. allegedly failed to come up with a responsive letter within the period allowed under Section 5(a) of Rep. Act no. 6713;** (*underscoring for emphasis*)
- (f) On the last week of January 2024, he went to Mayor Sia's office to reiterate his desire to have a meeting with Eleuterio L. Magayones before his office and reminded him that he had not yet received a copy of his answer and thereafter threatened that if he will not be able to receive any, he might be compelled to seek recourse before higher authorities; Mayor Sia told him that he can go ahead and file whatever he wish to file since it is his right to do so;
- (g) Hence, this case for grave misconduct and neglect of duty selectively against Mayor Sia only;

3. In evidence of his unsupported allegations, he attached blurred copies of irrelevant, immaterial and incompetent documents that do not prove the alleged offenses, to wit:

- a) Annex "A" – Extrajudicial Settlement of the Estate with Sale;
- b) Annex "B" – Tax Declaration of Real Property;
- c) Annex "C" – Pictures showing the bamboo-made fence;
- d) Annex "D" – Alleged Picture of Charlito A. Badion;
- e) Annex "F" – Letter-Request dated 8 January 2023 received on 8 January 2024;
- f) Judicial Affidavit of Raymart P. Marticio dated 19 August 2024;

DENIAL

4. All the allegations in the complaint are categorically, vehemently, and vigorously DENIED; specifically, paragraphs I, II, III, IV, and V refer to allegations not involving the herein respondent;

5. Insofar as par. VI is concerned, Respondent has no knowledge if complainant instructed Emy P. Marticio to hire a lawyer to send a formal letter to him for a certain request, but admits that his office received a copy of a letter dated 8 January 2023 (Annex E) on 8 January 2024 at 11:16AM, specifically requesting to know about an agreement that involved respondent and Mr. Magayones that concerned the property Emy bought from the legal owners.

6. Paragraph VII and IX are legal issues to be discussed thoroughly in the Defenses hereunder.

7. Paragraph VIII is denied, the real story is discussed in the Defenses hereunder.

SOLE ISSUE

7. WHETHER OR NOT RESPONDENT VIOLATED R.A. 6713, SEC. 5(a)?

DEFENSES

8. It is not true that respondent failed to respond to the request of Atty. Jerome A. Tenebro.

9. Technically, Marvin Marticio has no legal personality in the demand letter sent by Atty. Tenebro in behalf of client Emy P. Marticio.

10. Technically also, the Mayor has no jurisdiction over such controversy under RA 7160 Chapter III, Art. I, Section 444; nevertheless, in compliance with RA 6713, Rule VI, Section 3(b), even if such communication was outside his jurisdiction, he entertained the request of Marvin to schedule a mediation between him and Punong Eleuterio Magayones, who was his political rival for said position in the previous barangay elections in October 2023.

11. The mediation session was set on 10 January 2024 to clarify about the alleged agreement between the mayor and PB Magayones mentioned in said letter request. PB Magayones was absent while complainant Marvin was present. In said meeting, the mayor that he is not aware of any agreement with Magayones, and said that this is a case of “name-dropping” by PB Magayones, as clearly quoted verbatim in said letter, to wit: *“Hino it nagsugo ha iyo pagpaguba? Kay ano niyo pag-gubaa? Mayda na namon ton agreement ni Mayor (Hon. Sia) ngan nakablotter na ito kan Mayor. Diri na dinhi pinapagbalay hi Marvin”*. Further, it must be noted that no police certification was attached to support said letter.

12. Subsequent meetings were set on 11 January 2024, 12 January 2024 and 16 January 2024. To ensure the attendance of PB Magayones, the Office of the Municipal Mayor of La Paz, Leyte sent verbal radio invitations coursed thru Local Disaster Risk, Reduction and Management Office (LDRRMO) Radio, stationed at the Barangay Hall of Brgy. Pansud, La Paz, Leyte, because said Barangay is a mountain Barangay with difficulty in sending communications thereat for him to shed light on the issue raised by Marvin Marticio.

13. Through no fault of the Mayor, PB Magayones repeatedly failed to attend the scheduled meetings relaying multiple excuses of Loose Bowel Movement (LBM) and sickness coursed thru one of his Barangay Kagawad.

14. The truth of the foregoing acts is attested and corroborated by the **Affidavit of Michael Y. Rapada**³, and the Local Assessment Operations Officers and **Affidavit of Froilan R. Pundavela**⁴, Executive Secretary.

ARGUMENTS / DISCUSSION

NO GRAVE MISCONDUCT

15. Marvin Marticio alleged that Mayor Sia committed grave misconduct just because he allegedly failed to respond to the Letter

dated 8 January 2023 sent by Atty. Jerome A. Tenebro at the instance of Emy De Paz Marticio the alleged owner of a purchased real property (Lot no. 3046) being claimed also by Barangay Pansud, La Paz, Leyte thru PB Eleuterio L. Magayones.

16. From this perspective, Mayor Sia posits that the word “**respond**” as contemplated by Section 5(a) of Rep. Act no. 6713 not to literally mean verbal or written response, because in this instant case, he in fact responded by way of action through setting the case for mediation, as alleged in paragraphs 8 to 15 hereinabove.

17. Since Magayones failed to attend this first meeting, Marvin Marticio requested Mayor Sia to order PB Magayones to attend the next meeting on 11 January 2024, 12 January 2024, and 16 January 2024. An invitation was sent to Magayones thru the LDRRMO radio, considering the difficulty of the terrain of Brgy. Pansud, La Paz, Leyte, which is a mountain barangay. Unfortunately, PB Magayones failed to heed the first call, because of his excuse that he was suffering from LBM thru the information from Brgy. Kagawad, Melmer A. Quillotes. On the second attempt on 12 January 2024, only Barangay Kagawad, Arsenio S. Alcuetas, Jr. represented PB Magayones, relaying information that the latter is still not feeling well. The last meeting supposed to be on 16 January 2024 was terminated when Marvin Marticio informed the office that he already filed a case against PB Magayones in court.

18. To show that Marvin Marticio already filed a case against PB Magayones over the incidents of this instant case, the **Judicial Complaint Affidavit of Marvin T. Marticio against Eleuterio Magayones, et al.**⁵, received on 15 January 2024 with the same attachments of **Tax Declaration of Real Property**⁶, **Extrajudicial Settlement of the Estate with Sale**⁷ and **Picture of Charlito A. Badion**⁸ with **Judicial Affidavit of Raymart P. Marticio**⁹ and **PNP Blotter with no. 2024-01-257 dated 12 January 2024**¹⁰ represented by the same Lawyer, Atty. Ferdinand Arthur B. Diaz and the **Resolution**¹¹ dismissing the case filed by Marvin Marticio.

19. The act of Mayor Sia in acting on the Letter via complainant, Marvin Marticio by action is sufficient response in

contemplation of Section 5(a) of Rep. Act no. 6713 that negates his administrative liability for Grave Misconduct.

20. His act of going thru the extra mile in entertaining possible settlement between the parties over their land dispute though not his enumerated duties under Section 444 of Rep. Act no. 7160 otherwise known as the Local Government Code, is response to comply with the law. – Said actions should not be taken against Mayor Sia who immediately treated the Letter by action as Mayor Sia is a man of action and not of speech.

21. *Misconduct is a transgression of some established and definite rule of action, particularly, as a result of a public officer's unlawful behavior, recklessness, or gross negligence.¹² It generally means wrongful, improper or unlawful conduct motivated by a premeditated, obstinate or intentional purpose.¹³*

22. *The Supreme Court defined grave misconduct is defined as the transgression of some established and definite rule of action, more particularly, unlawful behavior or gross negligence by a public officer coupled with the elements of corruption, willful intent to violate the law or to disregard established rules.¹⁴ In other words, the misconduct is grave if it involved any of the additional elements of corruption, clear willful intent to violate the law, or flagrant disregard of established rules, supported by substantial evidence.*

23. Here, Mayor Sia complied with Section 5(a) of Rep. Act no. 6713 by immediately responding by acting by way of amicably settling the dispute between the parties and such compliance is not an unlawful behavior, recklessness, gross negligence, wrongful, improper or unlawful conduct motivated by a premeditated, obstinate, intentional purpose coupled with the elements of corruption, willful intent to violate the law or to disregard established rules.

NO NEGLECT OF DUTY

24. Mayor Sia repleads and adopts all the truthful allegations above as corroborated by clear and convincing evidence as part of the arguments and discussions hereinunder.

25. Marvin T. Marticio posits that Mayor Sia's alleged failure to respond to the Letter of Atty. Jerome A. Tenebro at the instance of his client Emy De Paz Matricio is a violation of Section 5(a) of Rep. Act no. 6713 as allegedly Marvin did not receive any verbal or written answer from the good mayor. However, he forgets that Mayor Sia's act of

immediately conducting mediation in an attempt to amicably settle matters with PB Magayones is the response contemplated by the law and serves its legal purposes.

26. *Dereliction of duty may be classified as gross or simple neglect of duty or negligence. **Gross neglect of duty or gross negligence "refers to negligence characterized by the want of even slight care, or by acting or omitting to act in a situation where there is a duty to act, not inadvertently but willfully and intentionally, with a conscious indifference to the consequences, insofar as other persons may be affected. It is the omission of that care that even inattentive and thoughtless men never fail to give to their own property." It denotes a flagrant and culpable refusal or unwillingness of a person to perform a duty. In cases involving public officials, gross negligence occurs when a breach of duty is flagrant and palpable. In contrast, simple neglect of duty means the failure of an employee or official to give proper attention to a task expected of him or her, signifying a "disregard of a duty resulting from carelessness or indifference."***¹⁵.

27. As discussed above, Mayor Sia accommodated Marvin Marticio, Raymart Marticio and Raffy Marticio over their request to have the Letter of Atty. Jerome A. Tenebro at the instance of Emy De Paz Marticio be set for series of mediation meetings with PB Magayones.

28. *Gross neglect of duty or gross negligence "refers to negligence characterized by the want of even slight care, or by acting or omitting to act in a situation where there is a duty to act, not inadvertently but willfully and intentionally, with a conscious indifference to the consequences, insofar as other persons may be affected. It is the omission of that care that even inattentive and thoughtless men never fail to give to their own property." It denotes a flagrant and culpable refusal or unwillingness of a person to perform a duty. In cases involving public officials, gross negligence occurs when a breach of duty is flagrant and palpable*¹⁶.

29. Inferred from what actually transpired herein, Mayor Sia's action is the response in contemplation of Section 5(a) of Rep. Act no. 6713 which is in no way to be interpreted as Neglect of Duty be it grave or simple since doing it by action and not by verbal or written is still response in compliance of the law to finally aid the public of its predicaments which is the natural purpose of the enactment of the law.

30. There being no evidence to indict Mayor Sia for violation of Section 5(a) of Rep. Act no. 6713 that may result to alleged Grave Misconduct and Neglect of Duty then the quantum of substantial evidence in administrative cases is not met and therefore dismissal

becomes ministerial by nature consistent with *National Bureau of Investigation v. Conrado M. Najera*¹⁷ which states that:

The quantum of proof in administrative proceedings necessary for a finding of guilt is **substantial evidence or such relevant evidence as a reasonable mind may accept as adequate to support a conclusion. The burden to establish the charges rests upon the complainant. The case should be dismissed for lack of merit if the complainant fails to show in a satisfactory manner the facts upon which his accusations are based. The respondent is not even obliged to prove his exception or defense.** (Underlining & Emphasis Ours)

OUTRIGHT DISMISSAL OF THIS CASE ON THE FOLLOWING VALID GROUNDS:

1. COMPLAINANT IS GUILTY OF FORUM-SHOPPING

31. Marvin Marticio willfully and deliberately instituted two (2) actions against herein respondent Mayor Angel Aras Sia, Jr. of La Paz, Leyte by filing a complaint-affidavit dated 7 February 2024¹⁸ in the Office of the Ombudsman (Visayas) and docketed as IC-OVT-24-0016 and a similar complaint-affidavit dated 19 August 2024¹⁹ in this Honorable Sangguniang Panlalawigan of Leyte, seeking identical reliefs of suspension and removal from public office and perpetual disqualification to hold office in the government for Grave Misconduct and Neglect of Duty due to alleged violation of R.A. No. 6713, Sec. 5(a) by allegedly failing to respond within 15 days from receipt of a demand letter of Atty. Jerome Tenebro in behalf of client Emy P. Marticio (Annex "E" of complaint) – requesting to know if the good mayor was involved in an alleged Agreement with Brgy. Pansud, LaPaz, Leyte Punong Barangay Eleuterio Magayones concerning a disputed property which she bought from the Heirs of Maximo Magayones.

32. Forum shopping is committed by filing multiple cases based on the same cause of action and with the same prayer, the previous case not having been resolved yet, and filing multiple cases based on the same cause of action and the same prayer (*pendente lite*), the previous case having been resolved (*res judicata*).

33. *Forum shopping is the filing of multiple suits involving the same parties for the same cause of action, either simultaneously or successively, for the purpose of obtaining a favorable judgment. A party violates the rule against forum shopping if the elements of litis pendentia are present; or if a final judgment in one case would amount to res judicata in the other. xxx xxx There is forum shopping when the following elements are present: "(a) identity of parties, or at least such parties as represent the same interests in both actions; (b) identity of rights asserted and relief*

prayed for, the relief being founded on the same facts; and (c) the **identity of the two preceding particulars**, is such that any judgment rendered in the other action will, regardless of which party is successful, amount to *res judicata* in the action under consideration; said requisites [are] also constitutive of the requisites for *auter action pendant* or *lis pendens*²⁰.

32. The filing of these cases is to vex the courts and the respondent by asking different fora to rule on the same or related causes and grant the same or substantially the same reliefs and in the process, creates the possibility of conflicting decisions being rendered by the different fora upon the same issues.

33. Forum shopping is a ground for summary dismissal of both initiatory pleadings without prejudice to the taking of appropriate action against the counsel or party concerned. This is a punitive measure to those who trifle with the orderly administration of justice.

34. Further, complainant and his counsel violated Rule 7, Section 5 of the Rules of Court when they submitted false certifications of non-forum shopping and did not observe the undertakings therein mandated by Rule 7, Section 5, *“that he has not therefore commenced any action or filed any claim involving the same issues in any court, tribunal, or quasi-judicial agency and to the best of his knowledge, no such other action or claim is pending therein; (b) if there is such other pending action or claim, a complete statement of the present status thereof; and (c) if he should thereafter learn that the same or similar action or claim has been filed or is pending, he shall report that fact within 5 days therefrom to the court wherein his aforesaid complaint or initiatory pleading has been filed.” (underscore ours)*

35. As an aside, the filing of this case is **politically motivated**, obviously shown by the filing of this second complaint before this Honorable SP-Leyte, anent an alleged incident that occurred on January 2024, received by the respondent on 27 September 2024 or proximately closed to the filing of certificates of candidacy by the national and local government elective officials.

2. NO LOCUS STANDI

36. Moreover, there is an apparent contrast in the admitted interest between complainant Mr. Marvin Marticio and the alleged owner of the land Emy De Paz Marticio (client represented in the Letter). The purported evidence of the complainant does not reveal that he has a legal interest over the land in dispute. Thus, it is readily understood that this instant complaint deserve scant consideration from

this Honorable Office for failure of Marvin Marticio to comply with the rule on *locus standi* as mandated in *Ernesto L. Ching, vs. Carmelita S. Bonachita-Ricablanca*²¹ which states that:

[Locus standi or legal standing is defined as] a personal and substantial interest in the case such that the party has sustained or will sustain direct injury as a result of the governmental act that is being challenged. The term "interest" means a material interest, an interest in issue affected by the decree, as distinguished from mere interest in the question involved, or a mere incidental interest. The gist of the question of standing is whether a party alleges such personal stake in the outcome of the controversy as to assure that concrete adverseness which sharpens the presentation of issues upon which the court depends for illumination of difficult constitutional questions. (Underlining & Emphasis Ours)

37. The defective complaint does not show that the real party-in-interest (Emy) authorized Marvin Marticio to file this complaint. Otherwise stated, Marvin Marticio has no material and substantial interest over the land subject of this dispute by his mere admission that this land was purchased by his daughter Emy de Paz Marticio.

38. Further, the admission of Raymart P. Marticio in his Judicial Affidavit that Emy De Paz Marticio is the lawful owner of the parcel of land in issue reinforced the defense that this instant complaint should be outrightly dismissed because the complainant has no *locus standi* as enshrined in *Ernesto L. Ching vs. Carmelita S. Bonachita-Ricablanca*²², absent showing that it was part of the exception to the rule which are: (a) constitutional issue of critical significance or (b) subject of transcendental import, to wit:

To have legal standing, therefore, a suitor must show that he has sustained or will sustain a "direct injury" as a result of a government action, or have a "material interest" in the issue affected by the challenged official act. However, the Court has time and again acted liberally on the locus standi requirements and has accorded certain individuals, not otherwise directly injured, or with material interest affected, by a Government act, standing to sue provided a constitutional issue of critical significance is at stake. The rule on locus standi is after all a mere procedural technicality in relation to which the Court, in a catena of cases involving a subject of transcendental import, has waived, or relaxed, thus allowing non-traditional plaintiffs, such as concerned citizens, taxpayers, voters or legislators, to sue in the public interest, albeit they may not have been personally injured by the operation of a law or any other government act. In David, the Court laid out the bare minimum norm before the so-called "non-traditional suitors" may be extended standing to sue, thusly:

1.) For taxpayers, there must be a claim of illegal disbursement of public funds or that the tax measure is unconstitutional;

2.) For voters, there must be a showing of obvious interest in the validity of the election law in question;

3.) For concerned citizens, there must be a showing that the issues raised are of transcendental importance which must be settled early; and

4.) For legislators, there must be a claim that the official action complained of infringes their prerogatives as legislators (Underlining & Emphasis Ours)

RESERVATION TO FILE COUNTER-CHARGE

39. Based on the evidence presented it is clear that complainant, Marvin T. Marticio and his witness, Raymart P. Marticio committed perjury in openly lying under oath in their respective executed Judicial Affidavits to maliciously indict Mayor Sia over this harassment suit for Grave Misconduct and Neglect of Duty before this Honorable Office, aside from the Ombudsman.

40. Harassment suit: Based on the evidence presented herein, it clearly shows that Mayor Sia was never remiss of his duty to respond to the subject Letter of Atty. Jerome A. Tenebro for client Emy De Paz by action, despite not being duly represented by complainant Marvin T. Marticio. On the other hand, by filing this second suit with non-compliance of the non-forum shopping rule, and the timing of the filing of this suit within the political season reveals his political motive to harass the respondent.

41. Hence it is but proper that a counter-charge for violation of Art. 183 of the Revised Penal Code or Perjury in solemn statement be filed against Marvin T. Marticio and Raymart P. Marticio who executed sworn statements under oath in incriminating the innocent Mayor Sia also in violation of Art. 383 all defined under the Revised Penal Code, especially that they made a declaration under oath, the relevant provisions of Art. 183 and Art. 383 all under the Revised Penal Code states as follows:

*ARTICLE 183. False Testimony in Other Cases and Perjury in Solemn Affirmation. — The penalty of arresto mayor in its maximum period to prisión correccional in its minimum period shall be imposed upon **any person who, knowingly making untruthful statements** and not being included in the provisions of the next preceding articles, shall **testify under oath, or make an affidavit, upon any material matter before a competent person authorized to administer an oath in cases in which the law so requires.***

*Any person who, **in case of a solemn affirmation made in lieu of an oath, shall commit any of the falsehoods** mentioned in this and the three preceding articles of this section, shall suffer the respective penalties provided therein.*

xxx xxx xxx

*ARTICLE 363. Incriminating Innocent Person. — Any person who, by any act not constituting perjury, shall **directly incriminate or impute to an innocent person the commission of a crime**, shall be punished by arresto mayor. (Underlining & Emphasis Ours)*

PRAYER

WHEREFORE, in view of the foregoing, it is respectfully prayed before this Honorable Office to give its most appropriate resolution, that the complaint against me be **DISMISSED** forthwith for **UTTER LACK OF MERIT, UNSUBSTANTIATED EVIDENCE, AND FORUM-SHOPPING.**

Other relief and remedies as may be equitable in the premises are also prayed for.

AFFIDAVIT


I, **MICHAEL Y. RAPADA**, of legal age, Filipino, and in his capacity as Local Assessment Operations Officer of the Municipality of La Paz, Leyte with office at LGU-La Paz, Leyte, after being sworn according to law hereby depose and state: THAT---

1. I am the Local Assessment Operations Officer and the focal person for the Municipality of La Paz, Leyte over its real properties;
2. Around 9 January 2024, I learned of the Letter of Atty. Jerome A. Tenebro prepared for his client, Emy De Paz Marticio which was represented by Mr. Marvin T. Marticio, Raymart P. Marticio and Raffy P. Marticio about the alleged involvement of Mayor Sia over any agreement with Punong Barangay Eleuterio L. Magayones of Barangay Pansud, La Paz, Leyte and was requested by Mayor Sia to attend the set meeting on 10 January 2024 at around 9 in the morning;
3. Coming to that date, in attendance to the meeting was Mr. Marvin T. Marticio, Raymart P. Marticio, Raffy P. Marticio, Froilan R. Pundavela and Mayor Angel A. Sia Jr. at the Office of the Mayor of La Paz, Leyte;
4. During the meeting, it was Marvin T. Marticio who opened to Mayor Sia about the alleged agreement between PB Magayones and him over the parcel of land allegedly purchased by Emy De Paz Marticio in Brgy. Pansud, La Paz, Leyte which was outrightly denied by Mayor Sia since he did not enter into any agreement with PB Magayones over any parcel of land in Brgy. Pansud, La Paz, Leyte;
5. Having cleared the issue, Marvin calmed himself and allowed Raymart and Raffy to exhibit the Plan of the land in question to point the location of the property as well as its boundaries but considering that it was a land dispute, Mayor Sia advised Marvin that they need to invite PB Magayones so that we can also hear his side of the story so as not to be biased over the issues;

9. The meeting was again set on 16 January 2024 but before the meeting could pursue, Mayor Sia and I chanced upon Marvin, Raymart and Raffy Marticio along the stairs of the Municipal Hall of La Paz, Leyte and heard Mr. Marvin Marticio told the good mayor that he already filed a case against PB Magayones over the subject property in this case to which Mayor Sia replied that he respects his decision and that he made Marvin understand that he can no longer continue with the mediation since there is already a case between the parties.


I, **FROILAN R. PUNDAVELA**, of legal age, Filipino, and in his capacity as Executive Secretary of the Municipality of La Paz, Leyte with office at LGU-La Paz, Leyte, after being sworn according to law hereby depose and state: THAT---

1. I am the Executive Secretary of the Office of the Municipal Mayor for the Municipality of La Paz, Leyte;
2. Around 9 January 2024, I learned of the Letter of Atty. Jerome A. Tenebro prepared for his client, Emy De Paz Marticio which was represented by Mr. Marvin T. Marticio, Raymart P. Marticio and Raffy P. Marticio about the alleged involvement of Mayor Sia over any agreement with Punong Barangay Eleuterio L. Magayones of Barangay Pansud, La Paz, Leyte and was requested by Mayor Sia to attend the set meeting on 10 January 2024 at around 9 in the morning after our executive meeting on that day;
3. Coming to that date, in attendance to the meeting was Mr. Marvin T. Marticio, Raymart P. Marticio, Raffy P. Marticio, Michael Y. Rapada and Mayor Angel A. Sia Jr. at the Office of the Mayor of La Paz, Leyte;
4. During the meeting, it was Marvin T. Marticio who opened to Mayor Sia about the alleged agreement between PB Magayones and him over the parcel of land allegedly purchased by Emy De Paz Marticio in Brgy. Pansud, La Paz, Leyte which was outrightly denied by Mayor Sia since he did not enter into any agreement with PB Magayones over any parcel of land in Brgy. Pansud, La Paz, Leyte;
5. Having cleared the issue, Marvin calmed himself and allowed Raymart and Raffy to exhibit the Plan of the land in question to point the location of the property as well as its boundaries but considering that it was a land dispute, Mayor Sia advised Marvin that they need to invite PB Magayones so that we can also hear his side of the story so as not to be biased over the issues;
6. Marvin became agitated and rushed Mayor Sia to immediately call PB Magayones so in order to accommodate such request PB Magayones was called thru the Local Disaster Risk Reduction and Management Office Radio which is direct to the Barangay Hall of Brgy. 9. I learned that a meeting was set on 16 January 2024 at the Office of the Mayor with the Marticios' with a standing invitation to PB Magayones but I was not able to attend the same due to some equally important executive matters at the Municipality of La Paz, Leyte.

JUDICIAL COMPLAINT AFFIDAVIT OF
MARVIN T. MARTICIO

This Judicial Counter Affidavit of **MARVIN T. MARTICIO** was taken and recorded based on the examination made by Atty. Ferdinand Arthur B. Diaz of Ticoy, Diaz, Cercado, Tutaan & Partners Law & Notarial Offices with business and official address at Rm. 101, Ground Floor, M.B. Yu Bldg., Real St., Tacloban City, Philippines 6500 on January 15, 2024 at the office of the herein examiner.

Purpose of the Witness' Testimony:

The testimony of the herein complainant is being offered to prove the following material points, to wit:

- (1) That her daughter Emy De Paz Marticio is the lawful owner of a parcel of land designated as Lot No. 3046 which she acquired by way of sale and purchase from the heirs of Maximo Magayones and Aquilina Gara;
- (2) That on January 06, 2024 at around 10:55 in the morning of the same date, he together with his other two sons namely Raymart De Paz Marticio and Raffy De Paz Marticio went to check the said lot of Emy De Paz Marticio at Brgy. Pansud, La Paz, Leyte on which their residential house is erected;
- (3) That when they arrived there, they were surprised to see and discover that their house is being fenced by herein respondents led by Punong Barangay Eleuterio Magayones and several other barangay officials like Barangay Kagawad Charlito Agustin Badión, Barangay Kagawad Emilinda Sevillano Alvero, Brgy. Kagawad Arsenio Sinining Alcuetas Jr., Brgy. Kagawad Melmer Acebo Quillotes, Brgy. Tanod Erwin Tila-on Antido, Brgy. Tanod Darmie Sevillano Alvero, Brgy. Tanod Leonido Tila-on Nebaliza, Brgy. Tanod Ariel Suyom Solibar, Brgy. Tanod Virgelio Solibar Quillotes, Brgy. Tanod Dominador Ganalon Solibar, Brgy. Tanod Arturo Lino Sevillano, Brgy. Tanod Gina Dazo Quillotes, Brgy. Tanod Edgardo Magayones Quillotes, Brgy. Tanod Romulo Onate Espejo, Lupon Member Virginia Ramos

Sevillano and several other private individuals identified as Alejandro Laluna Espejo, Luis Sevillano Alvero Jr., Joel Aralar Naboya, Felisa Cinco Naboya, Julius Sevillano Monterola, Julie Alvero Nebaliza, Vilma Sevillano Mostacisa and Glecelyn Alvero Nebaliza;

- (4) That complainant and his other two sons were prevented from entering the premises of their land including their house which is erected on thereon;
- (5) That when complainant and his two sons tried to prevent herein respondents from doing so, a commotion ensued as the latter did not heed complainant and the latter was overpowered by the numbers of herein respondents;
- (6) That instead, respondents particularly Punong Barangay Eleuterio Magayones and Charlito Agustin Badion acted violently and even challenged complainant and his two sons for a fight which then prompted Raymart De Paz Marticio to video record the entire incident with the use of his cell phone;
- (7) That Charlito Agustin Badion even unsheathed a long bladed weapon locally known as "sundang";
- (8) That respondents only retreated and calmed down a bit when they saw complainant's sons filming them;
- (9) That complainant reported the said incident to the police for records purposes.

R E S O L U T I O N

Filed before this court is an INFORMATION which read as follows:

"The undersigned Senior Assistant Provincial Prosecutor of Leyte accuses ELEUTERIO MAGAYONES, CHARLITO BADION, EMILINDA VERSOZA, ARSENIO ALCUETAS JR.,

ERWIN ANTIDO, ROMULO ESPEJO, ALEJANDRO ESPEJO, MELMER QUILLOTES, DARMIE ALVERO, LUIS ALVERO JR., JOEL NABOYA, FELISA NABOYA, JULIUS MONTEROLA, LEONIDO NEBALIZA, ARIEL SOLIBAR, VIRGELIO QUILLOTES, DOMINADOR SOLIBAR, ARTURO SEVILLANO, JULIE NEBALIZA, VILMA MOSTACISA, GINA QUILLOTES, GLECELYN NEBALIZA, EDGARDO QUILLOTES of the crime of GRAVE COERCION committed as follows:

That sometime on the 6th day of January 2024 in La Paz, Leyte, Philippines and within the jurisdiction of the Honorable Court, the above-named accused, conspiring, confederating and mutually helping each other without any authority of law and there being no right to do so, through violence, threats, and intimidation, did then and there willfully, unlawfully, and feloniously prevented Marvin Marticio from entering their house. The latter who was outnumbered was placed under the control of the accused and was left with no choice but to submit to the latter's will.

After personal evaluation of the Information together with the Judicial Complaint Affidavit of Marvin Marticio as well as the supporting evidences attached to the record of this case, this Court finds that the evidence on record clearly fails to establish probable cause to indict the above-named accused of the crime of Grave Coercion.

For grave coercion to lie, the following elements must be present:

1. that a person is prevented by another from doing something not prohibited by law, or compelled to do something against his will, be it right or wrong;
2. that the prevention or compulsion is effected by violence, threats or intimidation; and

3. that the person who restrains the will and liberty of another has no right to do so, or in other words, that the restraint is not made under authority of law or in the exercise of any lawful right¹.

First, in the Judicial Affidavit Complaint of Marvin Marticio it was alleged that he was prevented from entering the premises of their lot including their house by the above-named accused by erecting a bamboo fence in the area, however, in the photo and video presented it was only a three-pole bamboo which was erected in a vacant lot that could not restrain complainant from going in and out of his house. The mere presence of the above-named accused in the premises without overt act negates the statement that they were being prevented by them to enter their house.

Second, there was no indication that complainant and his sons were intimidated or there was violence employed by the above-named accused. In fact, complainant and his sons were confrontational with the people present during that time. They confronted the accused, Eleuterio Magayones and all other accused present, without being prevented by them or being harmed by them. They only alleged that the above-named accused acted violently but no specific overt act was mentioned in the complaint. The fact that Charlito Badion was in possession of a long bladed weapon does not per se concludes that they were acting violently. There was no mention also as to how they conspire with one another in preventing the complainant from entering his house nor was there a mention of how they perpetrate those acts. It could be seen in the videos that they were the one being aggressive and not the other way around.

In the crime of grave coercion, violence through material force or such a display of it as would produce intimidation and, consequently, control over the will of the offended party is an essential ingredient.²

There is intimidation when one of the parties is compelled by a reasonable and well-grounded fear of an imminent and grave evil upon his person or property, or upon the person or property of his spouse, descendants or ascendants, to give his consent.³ Material violence is not indispensable for there to be intimidation. Intense fear produced in the mind of the victim which restricts or hinders the exercise of the will is sufficient.⁴

In the instant case, clearly there was absence of the second element of the crime of Grave Coercion. There was no showing that the above-named accused control over the will of the complainant.

Lastly, Probable cause demands more than suspicion; it requires less than evidence that would justify conviction.⁵ While probable cause should be determined in a summary manner, there is a need to examine the evidence with care to prevent material damage to a potential accused's constitutional right to liberty and the guarantees of freedom and fair play, and to protect the State from the burden of unnecessary expenses in prosecuting alleged offenses and holding trials arising from false, fraudulent or groundless charges.⁶ It is, therefore, imperative upon the prosecutor to relieve the accused from the pain of going through a trial once it is ascertained that no probable cause exists to form a sufficient belief as to the guilt of the accused⁷.

In the present case, this Court cannot turn a blind eye and have the above-named accused indicted of a crime of Grave Coercion even though the evidence presented did not clearly establish the existence of probable cause.

WHEREFORE, In view of the foregoing, this Court finds that there is no probable cause to indict the above-named accused for Grave Coercion and hereby **DISMISS** the case.

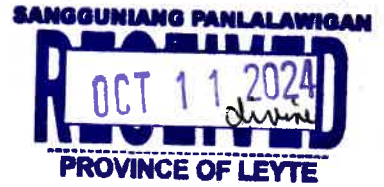

JUDICIAL AFFIDAVIT

I, **ANGEL ARAS SIA JR.**, Filipino, of legal age, married, a resident of Poblacion District IV, La Paz, Leyte, incumbent Municipal Mayor of LGU-La Paz, Leyte with Salary Grade 27, after having been duly sworn to in accordance with law, depose as follows:

PRELIMINARY STATEMENT

It was **ATTY. LEO S. GIRON**, who personally conducted the examination of undersigned affiant in his office located at Leo S. Giron and Associates 2/F Wenzhuan Bldg., Quezon Blvd., Brgy 91, Abucay, Tacloban City and I am answering his questions fully conscious that I do so under oath and may face criminal liability for false testimony or perjury.

PURPOSE OF TESTIMONY

This Judicial Affidavit of **ANGEL ARAS SIA JR.** will constitute as his direct testimony in this case and specifically to prove the following facts: THAT –

1. To prove that he did not commit grave misconduct and neglect of duty as mentioned in Rep. Act no. 7160 (Local Government Code of 1991) in relation to Section 5(a) of Rep. Act no. 6713;
2. To prove that he is in no way involved in any form of agreement with Punong Barangay Eleuterio Magayones over any parcel of land in Brgy. Pansud, La Paz, Leyte to which he has a real property dispute of with Emy De Paz Marticio, Marvin Marticio, Raymart Marticio and Raffy Marticio;
3. He received the Letter of Atty. Jerome Tenebro at the instance of his client, Emy De Paz Marticio on 8 January 2024 and immediately acted on the same on 10 January 2024 by way of action in successively conducting a mediation meeting over the parties per request of Marvin Marticio though not his duties under Section 444 of Rep. Act no. 7610;
4. At the instance of his office he sent verbal radio invitations to PB Magayones coursed thru Local Disaster Risk, Reduction and Management Office (LDRRMO) Radio, stationed at the Barangay Hall of Brgy. Pansud, La Paz, Leyte for him to appear on 11 January 2024 for a mediation meeting, because said Barangay is a mountain Barangay with difficulty in sending communications thereat for him to shed light on the

issue raised by Marvin Marticio but failed to appear due to Loose Bowel Movement (LBM);

5. Another communication was sent to PB Magayones to appear on 12 January 2024 for a mediation meeting with the Marticios but still failed to appear since allegedly he is still not feeling well;
6. He and Michael Y. Rapada met with the Marvin Marticio on the last meeting set on 16 January 2024 but before they met at the office, Marvin said to him that Marvin decided to file a case against PB Magayones in a court of law to which Mayor Sia could no longer continue with the mediation;
7. He will testify and identify relevant and material documents and such allied matters to amplify his supported allegations.

QUESTIONS & ANSWERS

1. Q-. Please state your work?

A-. I am the incumbent Municipal Mayor of La Paz, Leyte.

2. Q-. Do you know the complainant, Marvin T. Marticio in this case?

A-. Yes Sir, he was the former Punong Barangay of Brgy. Pansud, La Paz, Leyte until he lost in the last Barangay and Sangguniang Kabataan Election held last October 2023 to winning candidate PB Eleuterio Magayones.

3. Q-. What is your purpose in executing this Judicial Affidavit?

A-. To explain that I responded by action to the of Letter of Atty. Jerome A. Tenebro dated 8 January 2023 received on 8 January 2024 in compliance with Section 5(a) of Rep. Act no. 6713 as attached to the Complaint of Marvin Marticio and other attachments hence, I did not commit grave misconduct or neglect of duty over the same.

4. Q-. What complaint of Marvin Marticio are you referring to?

A-. It is the complaint he filed against me initially with the Office of the Ombudsman on 8 February 2024 and the Complaint before the Office of the Sagguniang Panlalawigan for the Province of Leyte filed on 21 August 2024 which practically alleged the same charge and allegation.

5. Q-. I am showing you the Complaint-Affidavit of Marvin Marticio dated 19 August 2024 and the Complaint-Affidavit of Marvin Marticio dated 7 February 2024, what is the relation of these documents to the one you earlier mentioned?

A-. These is the same documents that I am referring to sir.

(Atty. Giron: I respectfully move that the Complaint Affidavit of Marvin Marticio dated 19 August 2024 and the Complaint Affidavit of Marvin Marticio dated 7 February 2024 be marked as our Exhibits "1" & "2", respectively.)

6. Q-. And what is that charge, if you know?

A-. It is for **Grave Misconduct and Neglect of Duty in relation to violation of Section 5(a) of Rep. Act no. 6713.**

7. Q-. What did you mean when you said that both complaints alleged the same charge and information ?

A-. I mean sir that I was charged twice by Marvin Marticio over the same alleged incident and because of it he violated his oath in both complaints that he did not file the same or similar action before any tribunal or quasi-judicial agency.

8. Q-. Why do you say that you were charged twice by Marvin Marticio, if you know?

A-. I was charged twice sir since apart from the stamp receive by the Office of Sangguniang Panlalawigan for the Province of Leyte is dated 21 August 2024 this complaint is dated 19 August 2024 (See Exh. 1) while the other complaint the stamp receive was from the Office of the Ombudsman dated 8 February 2024 and this complaint is dated 7 February 2024 (See Exh. 2).

9. Q-. With this observation, what can you say about this?

A-. It shows sir that there are 2 complaints that are separate from each other but alleges the same charge, subject and refers to the same incident hence, Marvin Marticio violated his oath in not declaring that he had filed the same charge before another tribunal or quasi-judicial bodies.

10. Q-. Moving aside, according to these complaints you are administratively charged because you failed to respond within 15 workings day from receipt of the Letter communication of complainant, Marvin Marticio, do you know about this Letter?

A-. Per record sir, Marvin Marticio did not submit any letter to my office but on file at our office there is a Letter made at the instance of Emy De Paz Marticio his alleged daughter signed by Atty. Jerome A. Tenebro.

10. Q-. I am showing you a Letter dated 8 January 2023 by Atty. Jerome A. Tenebro, what is the relation of this document to the one you earlier mentioned?

A-. This is the one sir

(Atty. Giron: The Letter dated 8 January 2023 by Atty. Jerome A. Tenebro is marked as Exhibit "F" for the complainant.)

11. Q-. Was there any administrative charge filed by Emy De Paz Marticio against you, if you know?

A-. **To the best of my personal knowledge sir, I did not receive any administrative charge filed by Emy De Paz Marticio because of the Letter of Atty. Jerome A. Tenebro.**

12. Q-. So it is clear that only Marvin Marticio filed these administrative charges against you for failure to respond to the Letter made at the instance of Emy De Paz Marticio as signed by Atty. Jerome A. Tenebro?

A-. **Yes sir only Marvin Marticio for both Complaints marked as Exh. 1 and 2.**

13. Q-. If you know when your office receive this Letter dated 8 January 2023?

A-. **Per Letter sir, my office received the same on 8 January 2024.**

14. Q-. If any, what was the response of your office pertaining to this Letter?

A-. **I immediately set a meeting with the Emy De Paz Marticio in the morning of 10 January 2024 with notice to PB Magayones but it was Marvin T. Marticio who arrived with his 2 sons, Raymart Marticio and Raffy Marticio who later joined us.**

15. Q-. Who were in attendance to this meeting?

A-. **It was Marvin T. Marticio, Raymart Marticio, Raffy Marticio, my executive secretary Froilan Pundavela and Local Assessment Operations Officer and focal person of the Municipality of La Paz, Leyte, Michael Y. Rapada who attended upon my request since the Letter was about a real property while PB Magayones was absent despite invitation.**

15. Q-. How did this meeting on 10 January 2024 start?

A-. **It started sir when Marvin Marticio immediately asked me about the alleged agreement with PB Magayones over their disputed parcel of land in Brgy. Pansud, La Paz, Leyte to which I denied since I have not entered into any agreement with him and that I was just name-dropped by PB Magayones without my consent and authority.**

16. Q-. What happened next, if any?

A-. **Marvin Marticio talked about the property purchased by his daughter, Emy De Paz Marticio in Brgy. Pansud, La Paz, Leyte which was claimed also by Brgy. Pansud, La Paz, Leyte thru PB Magayones by showing a plan of the property, the Extrajudicial Settlement of the**

Estate with Sale, Tax Declaration of Property and pictures about the fencing incident on 6 January 2024.

17. Q-. If any, what was your response to the allegation of Mr. Marvin Marticio?

A-. To accommodate him sir, I told him that considering that the subject involves conflicting claims over the subject property, I told him to that we need the attendance of PB Magayones and set a mediation meeting since PB Magayones was not able to come today but Marvin became agitated and rushed me to immediately set the meeting the next day, so I cleared my calendar on the afternoon of 11 January 2024 to accommodate his request just to expedite the mediation process.

18. Q-. Was PB Magayones able to attend the 11 January 2024 mediation meeting?

A- No sir he was not despite contact thru Local Disaster Risk Reduction and Management Office (LDRRMO) Radio direct to the Barangay Hall of Brgy. Pansud considering that it's a mountain barangay.

19. Q-. If you know, what was the reason why PB Magayones was not able to attend the 11 January 2024 mediation meeting?

A- I learned that a certain Barangay Kagawad of Brgy. Pansud, Melmer A. Quillotes was sent by PB Magayones to inform our office that he could not attend the meeting since he is suffering from Loose Bowel Movement (LBM) so without PB Magayones the meeting pushed thru with the same set of attendees.

20. Q-. If you recall, what was discussed during the 11 January 2024 meeting?

A- The same discussion that we had on 10 January 2024 meeting but I told Marvin that we will again invite PB Magayones on 12 January 2024 for him to shed light on this disputed property and maybe come up with an amicable settlement so the mediation meeting was set on said date.

21. Q-. How did you invite PB Magayones for the meeting on 12 January 2024, if any?

A- The same process was made for his invitation having been contacted thru the LDRRMO Radio sir.

22. Q-. What happened during the set 12 January 2024 mediation meeting?

A- Prior to the meeting sir, I learned that a certain, Arsenio S. Alcuetas a barangay kagawad of Brgy. Pansud, was instructed by PB

Magayones to inform our office that he could not attend the meeting since he is still not feeling well, so despite this information, the meeting still pushed through considering that the Marticios' were already there and it was too late to recall the scheduled date.

23. Q-. And if you recall, what was discussed during the 12 January 2024 meeting?

A- We just repeated the same discussion we had in the previous meetings sir since PB Magayones still could not attend the meeting but at its conclusion, we set another mediation meeting on 16 January 2024 to give PB Magayones time so as not to waste the meeting schedules set between the parties.

24. Q-. And how was PB Magayones invited for the meeting on 16 January 2024, if you recall?

A- He was invited on the same LDRRMO Radio sir.

25. Q-. What happened next, if any?

A- On the day of 16 January 2024 but before the start of the meeting I and Michael Rapada chanced upon Marvin Marticio, Raymart Marticio and Raffy Marticio along the stairs of the Municipal Hall of La Paz, Leyte and told me that he already filed a case against PB Magayones over the incidents of the mediation meeting heard by us.

26. Q-. What was your reply to them, if any?

A- I told them that I respect their decision as it is their right to file an appropriate charge against PB Magayones over the incidents of the property in dispute but I made Marvin understand that because of his decision I could no longer proceed with the mediation proceeding as I would be interfering with the legal process.

27. Q-. Was Marvin Marticio able to understand your reply, Mayor Sia?

A- Yes sir.

28. Q-. Do you have any proof that Marvin Marticio already filed a case against PB Magayones over the incidents of the disputed property in Brgy. Pansud, La Paz, Leyte?

A- Yes sir I request for a copy of his Complaint with attachments against PB Magayones et al., before the Office of the Assistant Provincial Prosecutor of Abuyog, Leyte received on 15 January 2024 narrating the incidents over the disputed property in Brgy. Pansud, La Paz, Leyte.

29. Q-. I am showing you the Judicial Complaint Affidavit of Marvin T. Marticio against Eleuterio Magayones et al., received on 15 January 2024 with attached Tax Declaration of Real Property, Extrajudicial Settlement of the Estate with Sale, Picture of Charlito A. Badion, Judicial Affidavit of Raymart P. Marticio, PNP Blotter with no. 2024-01-257 dated 12 January 2024 and Resolution of the case entitled People v. Eleuterio Magayones et al., docketed as Crim. Case no. 122712 dated 15 April 2024, what is the relation of these documents to the one you earlier mentioned?

A-. These are the ones sir.

(Atty. Giron: I respectfully move that the Judicial Complaint Affidavit of Marvin T. Marticio against Eleuterio Magayones et al., received on 15 January 2024 with attached Tax Declaration of Real Property, Extrajudicial Settlement of the Estate with Sale, Picture of Charlito A. Badion, Judicial Affidavit of Raymart P. Marticio, PNP Blotter with no. 2024-01-257 dated 12 January 2024 and Resolution of the case entitled People v. Eleuterio Magayones et al., docketed as Crim. Case no. 122712 dated 15 April 2024 be marked as our Exhibits "5", "6", "7", "8", "9", "10", & "11", respectively.)

30. Q-. After narrating to the Honorable Court these facts, will you affirm and confirm the veracity and truthfulness of these statements?

A-. Yes, sir. I do confirm and affirm the veracity and truthfulness of my statements.

31. Q-. Do you wish to add some more to these statements?

A-. I have none for the moment, sir.

32. Q-. Below this Judicial Affidavit is your printed name. Are you willing to sign voluntarily this document?


