On 22 July 2024, Leyte V Electric Cooperative (LEYECO V) and KEPCO SPC Power Corporation (KSPC) filed a *Joint Application* dated 02 May 2024, seeking the Commission's approval of their Power Supply Agreement (PSA), with prayer for confidential treatment of information and motion for provisional authority.

On 01 August 2024, the Commission issued an *Order* and a *Notice of Virtual Hearing*, both of even date, setting the instant case for hearing on the following dates: (1) 04 September 2024 for the determination of compliance with jurisdictional requirements and expository presentation; and (2) 11 September 2024 for Pre-trial Conference and presentation of evidence.

On 22 August 2024, LEYECO V and KSPC filed a *Motion to Reset* Virtual Hearing of even date, wherein they alleged that given the proximity of the scheduled hearing dates, Applicants will not be able to

comply with the prescribed periods for the publication requirement pursuant to the *Order* dated 01 August 2024. In view thereof, LEYECO V and KSPC prayed for the resetting of the scheduled hearings in the instant case.

The Commissions finds the Motion to Reset Virtual Hearing filed by LEYECO V and KSPC in order. Hence, the same is hereby GRANTED. In view thereof, the hearings set on 04 September 2024 and 11 September 2024, pursuant to the Order dated 01 August 2024, are cancelled.

ACCORDINGLY, the Commission sets anew the hearings for the instant *Joint Application* for the determination of compliance with jurisdictional requirements, expository presentation, Pre-trial Conference, and presentation of evidence on the following dates and online platform for the conduct thereof, pursuant to Resolution No. 09, Series of 2020¹ and Resolution No. 01, Series of 2021² (ERC Revised Rules of Practice and Procedure):

Furthermore, LEYECO V and KSPC are hereby directed to host the virtual hearings at LEYECO V's principal office located at Brgy. San Pablo, Ormoc City, Leyte, as the designated venue for the conduct thereof, and ensure that the same is open to the public. Moreover, LEYECO V and KSPC shall guarantee that, during the conduct of the expository presentation, the participation of the public shall not be impaired.

**RELATIVE THERETO**, LEYECO V and KSPC are hereby directed to:

A Resolution Adopting the Guidelines Governing Electronic Applications, Filings and Virtual Hearings Before the Energy Regulatory Commission.

- 1) Cause the publication of the attached Notice of Virtual Hearing in two (2) newspapers of nationwide circulation in the Philippines at their own expense, twice (2x) within two (2) successive weeks, the dates of publication not being less than seven (7) days apart, and the date of the last publication to be made not later than ten (10) days before the date of the scheduled initial virtual hearing;
- 2) Furnish with copies of this Order and the attached Notice of Virtual Hearing the Offices of the Provincial Governor, the Mayors, and their respective Local Government Unit (LGU) legislative bodies within LEYECO V's franchise area for the appropriate posting thereof on their respective bulletin boards;
- 3) Inform the consumers within LEYECO V's franchise area, by any other means available and appropriate, of the filing of the *Joint Application*, its reasons therefor, and of the scheduled virtual hearings thereon;
- 4) Furnish with copies of this Order and the attached Notice of Virtual Hearing, the Office of the Solicitor General (OSG), the Commission on Audit (COA), and the Committees on Energy of both Houses of Congress. They are hereby requested, if they so desire, to send their duly authorized representatives and attend at the scheduled hearings; and
- 5) Furnish with copies of the *Joint Application* and its attachments, except those subject of a motion for confidential treatment of information, all those making requests therefor, subject to reimbursement of reasonable photocopying costs.

Within five (5) calendar days prior to the date of the initial virtual hearing, LEYECO V and KSPC must submit to the Commission. via electronic mail (e-mail) at <a href="docket@erc.ph">docket@erc.ph</a>, and copy furnish the Legal Service through <a href="legal@erc.ph">legal@erc.ph</a>, the scanned copies of their written compliance to the aforementioned jurisdictional requirements, attaching the following methodically arranged and duly marked documents:

1) The evidence of publication of the attached *Notice of Virtual Hearing* consisting of affidavits of the Editors or Business Managers of the newspapers where the said

Notice of Virtual Hearing was published, and the complete issues of the said newspapers;

- The evidence of actual posting of this Order and the attached Notice of Virtual Hearing, consisting of certifications issued to that effect, signed by the aforementioned Governor, Mayors and LGU legislative body or their duly authorized representatives, bearing the seals of their offices;
- 3) The evidence of other means employed by LEYECO V and KSPC to inform the consumers within LEYECO V's franchise area of the filing of the *Joint Application*, their reasons therefor, and of the scheduled hearings thereon;
- 4) The evidence of receipt of copies of this Order and the attached Notice of Virtual Hearing by the OSG, the COA, and the Committees on Energy of both Houses of Congress;
- 5) The evidence of receipt of copies of the *Joint Application* and its attachments, except those subject of a motion for confidential treatment of information, if any, by all those making requests therefor; and
- 6) Such other proofs of compliance with the requirements of the Commission.

Moreover, LEYECO V and KSPC are hereby required to post on their bulletin boards the scanned copies of the foregoing jurisdictional requirements, together with the newspaper publications and certifications issued by the concerned Office of the Governor, Mayors and Local Legislative Bodies, and to submit proof of posting thereof.

Joint Applicants LEYECO V and KSPC, and all interested parties, are also required to submit to the Commission via e-mail at docket@erc.ph, and copy furnish the Legal Service through legal@erc.ph, at least five (5) calendar days before the date of the scheduled initial virtual hearing and Pre-trial Conference, their respective Pre-Trial Briefs containing, among others:

 A summary of admitted facts and proposed stipulation of facts;

- 2) The issues to be tried or resolved;
- 3) The documents or exhibits to be presented, stating the purposes and proposed markings therefor, which should also be attached to the Pre-trial Brief; and
- 4) The number and names of the witnesses, with their written testimonies in a Judicial Affidavit form attached to the Pretrial Brief.

Joint Applicants LEYECO V and KSPC must ensure that all the documents or exhibits proposed to be presented have already been duly submitted to the Commission at least five (5) calendar days before the date of the scheduled initial virtual hearing and Pre-trial Conference pursuant to the preceding paragraph.

Failure of LEYECO V and KSPC to comply with the above requirements within the prescribed period shall be a ground for cancellation of the scheduled hearings.

Joint Applicants LEYECO V and KSPC must also be prepared to make an expository presentation of the instant Joint Application, aided by whatever communication medium that they may deem appropriate for the purpose, in order to put in plain words and explain, for the benefit of the consumers and other concerned parties, the nature of the Joint Application. Relevant information and pertinent details substantiating the reasons and justifications for the Joint Application must be cited in support thereof.

Joint Applicants LEYECO V and KSPC are hereby directed to file a copy of their Expository Presentation via e-mail at <a href="docket@erc.ph">docket@erc.ph</a>, and copy furnish the Legal Service through <a href="legal@erc.ph">legal@erc.ph</a>, at least five (5) calendar days prior to the scheduled virtual hearing. LEYECO V and KSPC shall also be required, upon the request of any stakeholder, to provide an advance copy of their expository presentation, at least five (5) calendar days prior to the scheduled virtual hearing.

Joint Applicants LEYECO V and KSPC are further directed to submit, either through personal service, registered mail or ordinary mail/private courier, one (1) set of the original or certified true hard copies of their Jurisdictional Compliance, Expository Presentation, Pre-Trial Brief, and Judicial Affidavits of witnesses within five (5) working days from the date that the same were electronically

submitted, as reflected in the acknowledgment receipt e-mail sent by the Commission.

The Commission will send the access link/s to the aforementioned hearing platform within five (5) working days prior to the scheduled hearings.



#### TO ALL INTERESTED PARTIES

Notice is hereby given that on 22 July 2024, Leyte V Electric Cooperative (LEYECO V) and KEPCO SPC Power Corporation (KSPC) filed a *Joint Application* dated 02 May 2024, seeking the Commission's approval of their Power Supply Agreement (PSA), with prayer for confidential treatment of information and motion for provisional authority.

The pertinent allegations of the Application are hereunder quoted as follows:

#### THE APPLICANTS

 Applicant [Leyte] V Electric Cooperative ("LEYECO V") is an electric cooperative duly organized and existing under and by

virtue of Presidential Decree No. 269 (PD 269), as amended, and other laws of the Republic of the Philippines, with principal office at LEYECO V Main Office, Brgy. San Pablo, Ormoc City, Leyte, herein represented by Dir. Emmanuel S. Arpon, in his capacity as Board President of [LEYECO V], and/or Atty. Jannie Ann J. Dayandayan, in her capacity as General Manager, evidenced by Board Resolution No. 30, Series of 2024. A copy of which is hereto attached as Annex "A-31 and A-32".

- 2. Applicant KEPCO SPC Power Corporation ("KSPC") is a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal address at the 7th Floor, Cebu Holdings Center, Cebu Business Park, Cebu City, Philippines, herein represented by its Marketing Assistant Manager, Jude Francis Alphaeus Rendon, and its Market Analysis Assistant Manager, Rovel Tangkay, who has been authorized by its Board of Directors to file the Joint Application as evidenced by the Secretary's Certificate dated February 9, 2023, attached hereto as Annex "E".
- 3. Applicant KSPC owns and operates a 2x103 MW Circulating Fluidized Bed Combustor (CFBC) Boiler Coal-Fired base load power plant in the City of Naga, Cebu, which became operational in 2011.
- 4. Applicants may be served notices, orders, and other processes of the Honorable Commission through their respective counsels at their addresses indicated below.

#### NATURE OF THE APPLICATION

5. This is an application for the approval of the Power Sales Agreement ("PSA") between LEYECO V and KSPC executed on April 17, 2024. A copy of the PSA is attached hereto as Annex "A"

#### STATEMENT OF FACTS

- 6. LEYECO V is a duly franchised Distribution Utility engaged in the distribution of electricity with its franchise areas in the city of Ormoc and municipalities of Albuera, Calubian, Isabel, Kananga, Leyte-Leyte, Matag-ob, Merida, Palompon, San Isidro, Tabango, and Villaba, all in Leyte.
- 7. The subject Energy and Capacity of the PSA is needed by LEYECOV to meet the demand of the captive market in a least cost manner. A copy of its Supply and Demand Scenario, Details of Existing Suppliers, Contract Utilization, and the Average Daily Load Curve are attached as Annex "Q and series".
- 8. In addition, LEYECO V Single Line Diagram is attached as Annex "R", Performance Assessment is attached as Annex "S",

and the Estimated Load Qualified Contestable Customer Under RCOA is attached as Annex "LL".

- 9. Pursuant to DOE Circular No. DC2018-02-0003 as amended by DOLE (sic) Department Circular No. DC2021-09-0030 ESAMELCO entered into a Joint Competitive Selection Process ("CSP") with other FRECOR 8 DUs. A copy of the Memorandum of Agreement between FRECOR 8 Electric Cooperatives is attached as Annex "RR".
- 10. FRECOR 8 sent a letter dated March 22, 2022 including the proposed "Captive Customer Representative for the Third Party Bids and Awards Committee (TPBAC) Selection Process", copies of the same are hereto attached as Annex "SS and SS-1", respectively, to the Energy Virtual One-Stop Shop ("EVOSS") portal of the Department of Energy ("DOE").
- 11. The DOE issued a letter dated April 25, 2022 addressed to Mr. Joey L. Talon, President of FRECOR 8, approving the proposed selection process, a copy of which is attached as Annex "SS-2".
- 12. After approval of the proposed selection process, FRECOR 8 then started accepting applications for the captive customer representatives who will constitute the two (2) other members of the Joint TPBAC of which Mr. Vida O. Ureña and Atty. Kenneth B. Fabila, a member of the Philippine Institute of Certified Public Accountants (PICPA) Tacloban City Chapter, were recommended. Copies of their submitted resume are hereto attached as Annex "TT and series".
- 13. FRECOR 8 thereafter duly constituted its JTPBAC, the composition of which was approved by the Board of Directors of FRECOR 8 in Resolution Nos. 2021-06-001, 2022-01-003, 2022-03-002, and 2022-08-001, copies of which are also attached as Annex "TT and series".
- 14. FRECOR 8 JTPBAC then prepared and submitted for approval to the Department of Energy (DOE) through the National Electrification Administration (NEA) the Power Supply Procurement Plan¹ (PSPP), Distribution Development Plan² (DDP) and Bid Documents which include the Terms of Reference (TOR), Invitation to Bid (ITB) and Instructions to Bidders.
- 15. Finding the TOR for the procurement of power supply in accordance with the comments and recommendations of the DOE and NEA, NEA then issued a Notice to Proceed dated July 19, 2023 including the approved TOR, and Certificate of Posting issued by the DOE dated July 11, 2023, hereto attached as Annex "UU and series".

- 16. Copies of the issued bidding documents are attached as *Annex "VV and Series"*.
- 17. With the said Notice to Proceed, the JTPBAC then proceeded with the publication of the ITB in the Philippine Daily Inquirer on July 24, 2023 and July 31, 2023. Likewise, the ITB was posted on the CSP e-based Portal of the DOE website and NEA website on July 24, 2023, as well as in LEYECO V's website and office premises on August 14, 2023. Copies of the pertinent pages of the Philippine Daily Inquirer with the ITB and Affidavit of Publication, as well as the Certificate of Posting issued by LEYECO V including photos of actual posting on the CSP e-based Portals of DOE, NEA, and LEYECO V websites and office premises are hereto attached as Annex "WW and series" and "XX and series", respectively.
- 18. Within 14 days from publication and posting, the JTPBAC conducted its Pre-Bid Conference on August 4, 2023 at the Summit Hotel, Tacloban City together with potential bidders and CSP Observers, copies of the attendance sheets are hereto attached as Annex "YY to YY-3". Thereafter, several bid and supplemental bid bulletins were issued in the course of the CSP to clarify all queries and concerns raised during the Pre-Bid Conference, copies of the said bid bulletins as well as the Minutes of the Pre-Bid Conference are hereto attached as Annex "ZZ and series".
- 19. Thereafter, the submission and opening of bids were then held on August 31, 2023 with CSP observers. Attached as Annex "YY-4 to YY-11" are the Invitation to Observers, print-out of emails confirming receipt of the invitation, and copies of the attendance sheets. Attached as Annex "ZZ-1-a" is the portion of the Minutes showing that representatives from NEA virtually attended the activity.
- 20. A total of three participants GNPower Kauswagan Ltd. Co., KEPCO SPC Power Corp., and Sual Power Inc. purchased bid documents and submitted complete proposals. Copies of their respective Eligibility Requirements and Submission of Bids are hereto attached as Annex "AAA and series" and Annex "BBB and series", respectively.
- 21. After careful evaluation, KSPC was found to have submitted the lowest computed bid proposal and was subjected to the next stage of evaluation, which is Post Qualification and Detailed Evaluation of Technical Proposal, wherein it was found to be compliant and responsive to all the specified requirements and conditions. - 24. Consequently, LEYECO V and KSPC executed a Power Supply Agreement ("PSA"), subject of this Joint Application.
- 25. Thus, this instant Joint Application for the approval of the PSA between LEYECO V and KSPC.

#### SALIENT FEATURES OF THE PSA

- 26. Salient Features of the PSA.
  - a. Contracted Capacity shall mean a capacity of 5 MW (2024), 4MW (2025), and 3MW (2026) reserved by the seller for LEYECO V for the duration of the contract period.
  - b. Contract Period and Effectivity. The Agreement shall take effect immediately from execution date and shall remain in force and effect until December 25, 2026 (the "Contract Period")
  - c. The obligation of the Seller to supply and deliver the Contracted Capacity shall commence on the date specified on the Initial "Day Ahead Nomination" issued by the Buyer and duly received by the Seller, subject to the provisions of Item 2 of the PSA.
  - d. Effective Date means the date of the execution of the agreement.
  - e. Outages and Replacement Power. The Seller shall guarantee supply and provide the Buyer with the Replacement power sourced from other generating facilities or third parties, including WESM, during Outages of the plant or facility.
  - f. A copy of the Computation of Generation Fee and Contract Price is included in the Power Supply Agreement attached as Annex "A".
- 23. Estimated Rate Impact. A Rate Impact Analysis based on the latest available rates would show that hat there would be a decrease in the rates amounting to Po.0534/kWh (a decrease from a blended rate of P6.2397/kWh to a blended rate of P6. 1863/kWh). A copy of the Rate Impact Simulation is hereto attached as Annex "V".

# ALLEGATIONS IN SUPPORT OF THE MOTION FOR PROVISIONAL AUTHORITY

- 32. LEYECO V and KSPC replead, by reference, all the foregoing allegations.
- 33. LEYECO V and KSPC pray for the issuance of a provisional authority prior to final decision pursuant to Section 1, Rule 14 of the ERC Revised Rules of Practice and Procedure, which provides:

Section 1. Provisional Authority or Interim Relief. – For applications or petitions covered by Section 1, Rule 6 of these Rules, the Commission may grant either a provisional authority or an interim relief, upon motion included in the application or petition and indicated in the caption thereof that such relief is requested x x x.

34. In view of the foregoing, there is a need for the issuance of a Provisional Authority in the meantime that this Joint Application is still pending evaluation and resolution of Honorable Commission, for the immediate implementation of this PSA for the benefit of LEYECO II's member consumers.

#### **PRAYER**

WHEREFORE, the foregoing premises considered, it is respectfully prayed that this Honorable Commission:

- 1. Give due course to the instant application.
- 2. Issue an Order:
  - a. Treating the Confidential Documents and the information contained therein as confidential
  - b. Directing their non-disclosure pursuant to Rule 4 of the ERC Rules, and
  - c. Prescribing guidelines for the protection of the said documents.
- 3. - 4. After trial on the merits, issue a Decision approving the PSA, thereby confirming the compliance by LEYECO V and KSPC to the rules governing power supply, and further confirming the effective rate charged, collected, and paid in connection with this PSA.
