day. If the LGU will agree that there will be another P50,000.00, for as long as the budget
permits, the LGU is required to give it to the centenarian that day of birthday. And based on
experience, Mr. Chair, there is not a single Leyteño that will disapprove of movement like this
because most of us, if not all, have one senior citizen in our homes that is why I completely
agree with BM Ina's proposal. As a matter of fact I would like to be a part of this and I would
like to co-author this endeavor. It only takes a budget, Mr. Chair, for as long as there is a
budget for it which I think any and every Municipality will try to look for it. Not necessarily P
50,000.00. It could start on how much budget that is set aside. That's all, Mr. Chair. Thank
you.

Thank you very much, Honorable Presiding Chair and Honorable Floor Leader.

The Leyte Sab-a Basin Peat Land Forest is actually situated in the 1st District in the Province of Leyte consisting of the towns of Palo, San Miguel, Sta Fe and Alangalang. It's actually one of the two major peat lands in the whole country. The first is the Agusan Marsh, and this is the 2<sup>nd</sup> largest next to Agusan Marsh out of the 9 identified peat lands within the country. From 2018 to 2021, the Provincial Government of Leyte, to include the Local Government Units of Santa Fe, Palo, San Miguel and Alangalang were part of the project called Leyte Sab-a Basin Peat Land Restoration Initiative involving the Academe, the Visayes State University and other civil society organization. The project aims to protect, restore and manage the Leyte Sab-a Basin Peat Land area in the town of Santa Fe, Palo, San Miguel and Alangalang where in it was able to produce legal and scientific studies. hence, this ordinance, Mr. Chair. The latest of the basin exhibits after the study disclosed that our Peat land forest has diverse vegetation boogey areas and grass land has a lot of Flora and Fauna which were identified during the study. In fact, there were 7 Amphibians identified, 14 species of Reptiles, 11 are endemic only to the Philippines with 7 threatened species and 1 new record which is possible that it can only be found here in the Visayas Region. This study also discloses that the latest of the basin is a habitat of 7 mammals, 3 are endemic and 4 are threatened. There are 67 species of birds, 12 endemic to Philippines, 13 are migratory birds, and 4 of those are already threatened species. The reason why we came up with this Peat land conservation local conversion ordinance which is entitled "An Ordinance Providing For The Management And Conservation Of The Leyte Sab-A Basin Peatland And Allother Peatland Resources Within The Province Of Leyte, Defining Its Scope And Coverage And For Other Purposes". And last year sometime in April, the DENR, which is also the partner of Province of Leyte and other LGUs concerned, actually requested us to draft a Local

For the very first time, the Ombudsman has decided to dismiss the Former Vice mayor of Palompon, Leyte together with five sitting councilors namely Margarito Bensig, Jr., Esperanza Sumalinog, Emmanuel Laurente, Consuelo Bonghanoy, Ranulfo Gaspan, Sr., Jonathan Yap, and Rene Camposano together with the sitting Mayor Ramon Oñate. The reason why I'm bringing this up Mr. Presiding Officer, this decision for dismissal was made on September 26, 2024. Now based on experience, most of the times, the secretariat of municipality will keep on sending us matters to be entertained here not knowing that on that specific date they were no longer supposedly the sitting officials so I am just raising this for awareness most especially to our Secretariat, Ma'am Jill, to take note that on September 26, 2024,a decision of dismissal was already handed to the Municipality of Palompon and I think our Governor is already making a move on who will be replacing them. So now we are just waiting for the Governor to decide who will be replacing all six councilors because the process of succession is the Vice Mayor will take over but in another note, another unfortunate decision came out yesterday which includes the sitting vice mayor on the criminal aspect so have a dismissal decision that came out on the September 26 excluding the vice mayor. Now, in the criminal aspect, he was included. There are two words, Mr. Presiding Officer, Legislative Crisis in Palompon. My concern is since it belongs to our area of responsibility, we should be very careful in receiving information or any documents from that council after September 26 for us not to be place in a dilemma for entertaining something that was not supposed to be valid. It's just aninformation I'd like to share but I really confirmed with the Provincial Legal Office this morning, it's really the first time that this has happened in the Province of Leyte where in a sitting Mayor and majority of the sitting councilors have been dismissed. So that is just for the information of all.
