Referred to this Committee per SP Resolution No. 2024-406, is the draft Ordinance from the Office of the Provincial Agriculture institutionalizing the Katuwang sa Diwa at Gawa para sa Masaganang Ani at Kita (KADIWA) ng Pangulo, per Memorandum Circular No. 2024-003 of the DILG which calls for the participation of the Local Government Units in KADIWA ng Pangulo.

This Ordinance seeks to empower the farming community by providing a direct and effective farm-to-consumer food supply chain. With the implementation of this program, the KADIWA ng Pangulo system will enable the public to buy goods at cheaper rates and the farmers to sell their crops without having to worry about transportation costs. This will further abet localities and communities to determine, develop, support, and promote products or services that are rooted in its local culture, community resource, creativity, connection, and competitive advantage, in line with the Province of Leyte's policy to promote the well-being of the citizen, their livelihood and for a just and fair environment for trade and other economic activities.

The Committee conducted a committee meeting with the Provincial Agriculturist and the Provincial Social Welfare Officer as resource persons. Their inputs were used in enhancing the draft ordinance so as to more effectively achieve the laudable objectives thereof.

This Committee hereby recommends the enactment of the Enhanced Version of the Ordinance institutionalizing the Katuwang sa Diwa at Gawa para sa Masaganang Ani at Kita (KADIWA) ng Pangulo.

**COMMITTEE REPORT**

Referred to this Committee through SP Resolution No. 2023-504, is the Opposition of Villaba Mayor, Engr. Carlos G. Veloso, to the Proposed Provincial Ordinance No. 20230. series of 2023 entitled: "An Ordinance Regulating the Use of Provincial Roads, Municipal Roads and Barangay Roads Within the Territorial Jurisdiction of the Province of Leyte, Prescribing Penalties, Fees for Violation thereof and for Other Purposes."

The Opposition letter submitted by Hon. Carlos G. Veloso cited that the Ordinance violated twelve (12) Constitutional provisions and is violative of R.A 7160 or the Local Government Code and Executive Order No. 41, S. 2023.

While the Local Government Units (LGUs) are empowered to enact ordinances for the purposes set forth in R.A. 7160 or the Local Government Code. It is expressly vested with police powers delegated to LGUs under the general welfare clause of R.A. 7160. With this power, LGUs may prescribe reasonable regulations to protect the lives, health, and property of their constituents. LGUs have the power to exercise and discharge such functions and responsibilities as may be necessary, appropriate or incidental to efficient and effective provisions of the basic services and facilities which are financed by their own funds. Likewise, the Ordinance does not contravene with Executive Order 41 considering that what Section 1 of E.O 41, S. 2023 prohibits is the collection of toll fees and charges upon all motor vehicles transporting goods or merchandise passing through the national roads and roads not constructed and funded by LGUs.

In view thereof, the Committee deems it proper to refer the opposition of the Villaba Mayor, Engr. Carlos G. Veloso to the Provincial Legal Office, for comment and recommendation.

Referred to this committee is Ordinance No. 474 of the Sangguniang Bayan of Babatngon, Leyte entitled, *"AN ORDINANCE RECLASSIFYING CADASTRAL LOT NO.1208, MEASURING 1,091 HECTARES COVERED BY CERTIFICATE OF TITLE NO. 115-2019003430 AND TAX DECLARATION NO. 2008-04001-00689 LOCATED AT BRGY. DISTRICT 1, BABATNGON, LEYTE FROM AGRICULTURAL LAND TO COMMERCIAL LAND IN CLASSIFICATION."*

The said ordinance was referred to this Committee for further study in relation to the comments and observation of the Provincial Legal Office (PLO) per its second endorsement, dated September 2, 2024. The latter while finding that the subject ordinance to be within the corporate powers of the local government unit and that the latter can validly reclassify a land, the PLO opined however that the ordinance must articulate the reason for the reclassification of the subject lot and shall provide the proper certifications pursuant to Section 20 of the Local Government Code.

The PLO also recommended that the title of the Ordinance be revised to "Barangay Bacong Reclassification of Land Ordinance".

Perusal of the ordinance and the documentary attachments accompanying the same, this Committee opines that the reason for the reclassification has already been clearly established. This is based on the accompanying certifications pursuant and in compliance with Section 20 of the Local Government Code. Attached to this report are the following:

1. Certification that the reclassification of the subject property from agricultural land to commercial would be more economically profitable as issued by SB Committee Chair Federico P. Elizaga, Jr.;
2. Certification from the Municipal Planning and Development Office that the reclassification of the subject land is still within the prescribed limit set, which is 5% of the total agricultural land land area for 4<sup>th</sup> class municipality.

As to recommendation of the PLO to revise the title of the Ordinance, the SB of origin, after consultation made before it, confirms that the exact location of the subject property is Barangay District 1, Babatngon, Leyte and not Brgy. Bacong. It is for this reason that the title of the ordinance will be retained as submitted.
