¹;(4) Regulate activities relative to the use of land, buildings and structures within the municipality in order to promote the general welfare and for said purpose shall:

⁽ii) Require that buildings and the premises thereof and any land within the municipality be kept and maintained in a sanitary condition; impose penalties for any violation thereof, or upon failure to comply with said requirement, have the work done and require the owner, administrator or tenant concerned to pay the expenses of the same; or require the filling up of any land or premises to a grade necessary for proper sanitation;

"AN ORDINANCE CONVERTING THE MAT-E MATERIALS RECOVERY FACILITY (MRF) OF THE MUNICIPAL GOVERNMENT OF MERIDA SITUATED IN BARANGAY MAT-E SLAUGHTERHOUSE OF THE MUNICIPALITY OF MERIDA, PROVINCE OF LEYTE."

WHEREAS, the Municipal Government of Merida recognizes the need to diversify local economic activities and promote sustainable development initiatives;

WHEREAS, the Materials Recovery Facility (MRF) located at Barangay Mat-e, this Municipality has been closed as recommended by the Department of Environment and Natural Resources (DENR) due to environmental issues and concerns;

WHEREAS, there is an increasing demand for local meat processing facilities to support the agricultural sector and ensure food security within the community;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN (18TH COUNCIL) OF MERIDA, LEYTE, AS FOLLOWS:

SECTION 1. CONVERSION OF MATERIALS RECOVERY FACILITY (MRF)

The Materials Recovery Facility (MRF) currently situated at Barangay Mat-e, Merida, Leyte, shall be converted into a Slaughterhouse Facility.

The purpose of this conversion is to enhance the economic viability of the facility and address local agricultural needs by providing meat processing services within the Municipality.

SECTION 2. **OPERATIONAL GUIDELINES**

- 2.1 The slaughterhouse facility shall comply with all relevant local and state regulations and policies pertaining to food safety, environmental standards, and animal welfare.
- 2.2. Adequate measures shall be implemented to mitigate any potential environmental impacts associated with the operation of the slaughterhouse.

SECTION 3. **FUNDING AND RESOURCES**

- 3.1 The Executive Department shall allocate necessary funds and resources to facilitate the conversion of the MRF into a fully operational slaughterhouse.
- 3.2 The Municipal Government of Merida may seek partnerhsips with private enterprises or government agencies to secure additional funding for infrastructure improvements and operational upgrades.

SECTION 4. **EFFECTIVE DATE**

4.1 This Ordinance shall take effect immediately upon approval by the Sangguniang Bayan (18th Council) and publication in accordance with RA No. 7160.

SECTION 5. **SEPARABILITY**

5.1 If any provision of this Ordinance is declared invalid or unenforceable, the remaining provisions shall remain in full force and effect.

SECTION 6. REPEAL OF CONFLICTING ORDINANCES

6.1 All Ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 7. PUBLICATION

The Municipality of Merida shall cause this Ordinance to be published once in a newspaper of general circulation within the Municipality within Ten (10) days after its passage.
