¹(viii) Determine the positions and salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs. projects, services, and activities of the municipal government;

² Section 76. Organizational Structure and Staffing Pattern. - Every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission.

AN ORDINANCE CREATING THE POSITION OF LOCAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICER II, SALARY GRADE 15 UNDER THE OFFICE OF THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE (MDRRMO).

BE IT ORDAINED by the Sangguniang Bayan of Javier, Leyte, **THAT**:

SECTION 1. The plantilla position of Local Disaster Risk Reduction and Management Officer II, Salary Grade 15 under the Office of the Municipal Disaster Risk Reduction and Management Office of the Municipality of Javier, Leyte is hereby created.

SECTION 2. The qualification for the position herein created is subject to the Minimum Standards, Guidelines, Rules and Regulations and Laws of the Civil Service Commission.

SECTION 3. The plantilla position of Local Disaster Risk Reduction and Management Officer II shall perform the following duties and functions:

- 1. Assist in preparing and updating the Annual Training and Development Plan;
- 2. Assist in the preparation and submission, through the LDRRMC and the LDC, the report on the utilization of the LDRRMF and other dedicated DRRM resources to the Local COA, copy furnished the Regional Director of the Office of Civil Defense (OCD) and the Local Government Operations Officer of the DILG;
- 3. Maintain Data Base on human resource, equipment, directories, and or location of critical infrastructures ad their capacities such as hospitals and evacuation centers.
- 4. Assist in designing program and coordinate DRRM activities, consistent with the NDRRMC's standards and guidelines;

Assist and facilitate the support risk assessments and contingency planning activities at the

- 6. Assist in consolidation of local disaster risk information which includes natural hazards, vulnerabilities, and climate change risks, and maintain a local risk map.
- 7. Will be part of the Rescue Team if needed especially if nursing care is required,
- 8. Quickly assessing patient/victim needs.
- 9. Teach the rescue members about the basic and fundamental health care management
- 10. Perform tasks as directed by the immediate supervisor.

SECTION 4. The salary, benefits, and other emoluments of the aforementioned plantilla position shall be appropriated in the Local Government Unit of Javier, Leyte.

SECTION 5. This Ordinance shall take effect upon approval.
