AN ORDINANCE CREATING THE ITEMS OF TWO (2) ADMINISTRATIVE AIDE I, (SG 1) UNDER THE MUNICIPAL TREASURER'S OFFICE, THIS MUNICIPALITY.

WHEREAS, RA 7160 known as The Local Government Code of 1991 provides the power and function of the sangguniang bayan which among others, determine the positions and the salaries, wages, allowances and other emoluments and benefits of its officials and employees;

WHEREAS, the sanggunian sees it proper to create positions at the Office of the Municipal Treasurer's Office;

NOW THEREFORE, on motion by Hon. Jinky E. Gamez and unanimously seconded;

BE IT RESOLVE, as it is hereby resolved to enact/approve Municipal Ordinance No. 04 Series of 2024 entitled "AN ORDINANCE CREATING THE ITEMS OF TWO (2) ADMINISTRATIVE AIDE I, (SG 1) UNDER THE MUNICIPAL TREASURER'S OFFICE, THIS MUNICIPALITY";

BE IT ORDAINED by the Honorable Sangguniang Bayan, in its Regular Session assembled, that:

SECTION 1. Title: This ordinance shall be known as "AN ORDINANCE CREATING THE ITEMS OF TWO (2) ADMINISTRATIVE AIDE I, (SG 1) UNDER THE MUNICIPAL TREASURER'S OFFICE, THIS MUNICIPALITY."
