

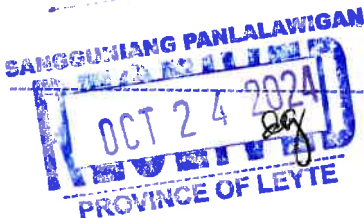

 36th Regular Session

"AN ORDINANCE NAMING THE NEW STREET CONNECTING R. MAGSAYSAY AVE. AND ML QUEZON STREET AS SAN MIGUEL STREET."

WHEREAS, Section 13 of the Local Government Code (RA 7610) provides that the Sanggunians of component cities may name or change the name of city roads, avenues, boulevards, thoroughfares, and bridges;

WHEREAS, a new road was opened and constructed by the City Government that connects R. Magsaysay Avenue and ML Quezon Street to ease the traffic on city roads;

WHEREAS, the land where the new road traverse was donated to the City Government by San Miguel Corporation, thus, it is but fitting that the said new road will be named as San Miguel Street as a sign of gratitude to the generosity of the donor;

NOW THEREFORE, BE IT ORDAINED, as it is hereby ordained by the *6th Sangguniang Panlungsod* of the City of Baybay, Province of Leyte, in its 36th Regular Session duly assembled that:

Section 1. The new road connecting R. Magsaysay Avenue and ML Quezon Street situated at Barangay Poblacion Zone 17 of the City shall be named as "SAN MIGUEL STREET".

Section 2. Repealing Clause. – Pertinent provisions of all other laws, decrees, executive orders and rules and regulations contrary to or inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 3. Effectivity – This Ordinance shall take effect upon due compliance with all the requirements as provided for under R.A. 7160, otherwise known as the Local Government Code of 1991.

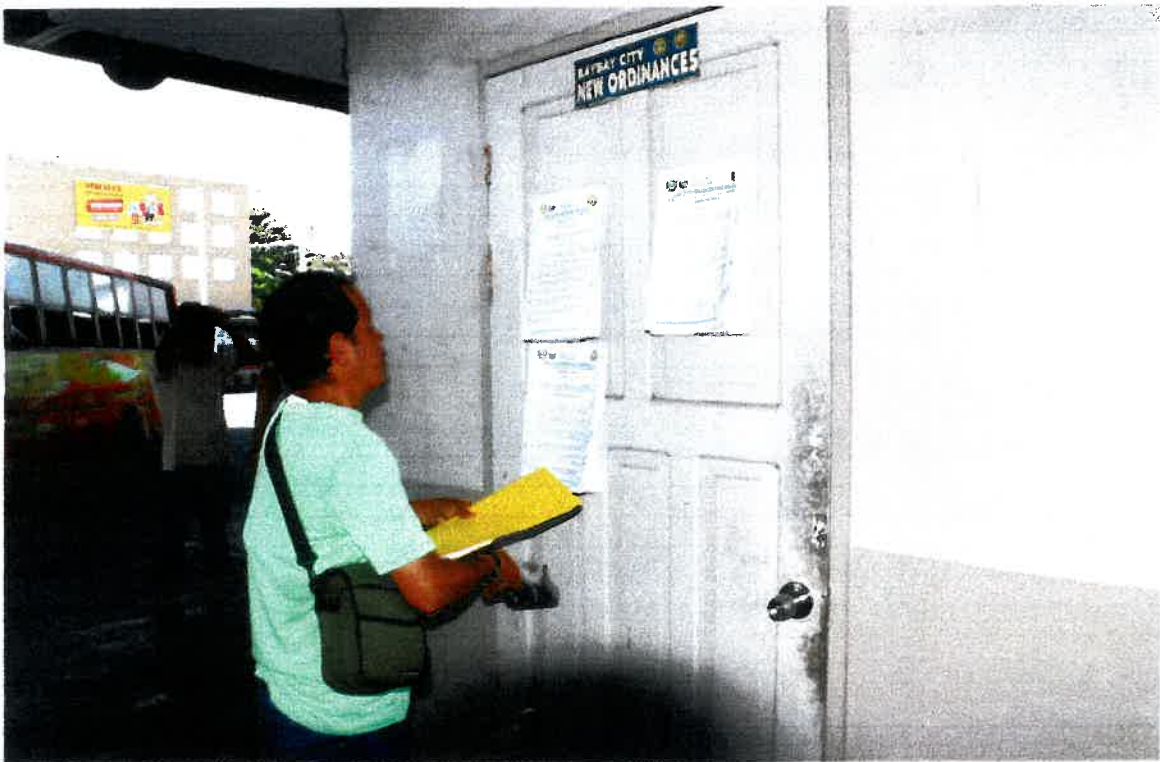
