AN ORDINANCE CREATING VARIOUS PLANTILLA POSITIONS IN THE MUNICIPAL **GOVERNMENT OF HILONGOS AND APPROPRIATING FUNDS THEREFOR**

WHEREAS, Section 447(1)(viii) of the Local Government Code of the Philippines or RA 7160 empowers the Sangguniang Bayan to determine the positions, salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the Municipal Government;

WHEREAS, on the other hand, Section 76 of the same code provides that every local government unit shall design and implement its own organizational structure and staffing pattern;

WHEREAS, to meet the needs of the present demand for a very functional and responsive government institution, it is imperative for additional various plantilla positions will be created;

NOW THEREFORE, on motion of Hon. Manuel M. Gabisan in unanimous accord;

BE IT ENACTED by the 16th Sangguniang Bayan of Hilongos in its regular session assembled that:

TITLE - This Ordinance shall be known as "Ordinance Creating Various SECTION 1. Plantilla Positions in the Municipal Government of Hilongos and Appropriating Funds Therefor in the Municipality of Hilongos".

PURPOSE - to meet the needs of the present demands of a very functional SECTION 2. and responsive government institution.
