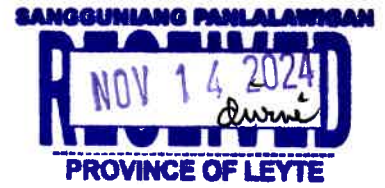

NOTICE OF HEARING

Applicant, **PIONEER CABLE VISION, INCORPORATED**, is a domestic corporation duly organized and existing under and by virtue of Philippine Laws, registered with the Securities and Exchange Commission (S.E.C.), and pursuant to the provisions of Executive Order No. 436 and Executive Order No. 205, request for the issuance of a **Certificate of Authority (CA)** to install, operate and maintain a **Cable Television (CATV) System** in **HINDANG, LEYTE**.

Applicant, further requests for the issuance of a **Provisional Authority (PA)** pending final determination of the application.

In view thereof, this will be heard by this Commission on **NOVEMBER 18, 2024, (Monday) at nine thirty o'clock in the morning (9:30 A.M.)** at the Legal Branch, 3rd Floor, NTC Building, National Telecommunications Commission, BIR Road, East Triangle, Diliman, Quezon City, via zoom hearing; wherein applicant shall present its compliance with the Commission's jurisdictional requirements, as well as its evidences, if warranted.

In lieu of face to face hearing, a virtual hearing shall be conducted. A link to join the virtual hearing will be sent to your e-mail address on the same day of hearing at least 15 minutes before the scheduled time. In connection to this, you are hereby ordered to send your e-mail address through legal@ntc.gov.ph and secretariat@ntc.gov.ph.

However, should the hearing date be declared a holiday or non-working day due to force majeure, the said hearing shall be held on the NEXT regular working day.

At least fifteen (15) days before the date of hearing, applicant shall have published the Notice of Hearing once in one (1) newspaper of general circulation and have served copies of the Notice of Hearing and the application including all annexes attached therewith to all affected parties by registered mail or through personal delivery, as furnished by the Commission.

Any party opposed to the granting of the application is hereby directed to appear at the scheduled hearing and must file its verified opposition, on or before the date of hearing, furnishing the applicant with a copy of the same. Failure on the part of any affected party to file its opposition on time and to appear at the scheduled hearing shall be construed as a waiver of its right to be heard and the Commission shall proceed to hear and decide the application on its merit.

APPLICATION

APPLICANT, through the undersigned counsel and unto the Honorable National Telecommunications Commission, respectfully alleges that:

1. The Applicant is a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines with address at D. Veloso St., Zone 7, Baybay City, Leyte where it may be served with summons, orders, notices, and other legal processes by the Honorable Commission. *(Copies of its SEC Certificate of Incorporation, Article of Incorporation, By-Laws are hereto attached as ANNEX "A", "A-1" and "A-2" respectively, which are all made integral parts hereof);*
2. Pursuant to the provisions enunciated under Section 5 of Article 14 of the 1997 Constitution of the Philippines, Section 15 of Executive Order No. 546 series of 1987, and provisions of other pertinent laws, applicant seeks to secure from this Honorable Commission a Certificate of Authority to install, operate and maintain a CATV System in Hindang, Leyte.
3. Applicant is legally, financially, and technically qualified to establish, operate and maintain the service herein being applied for.
 - 3.1. The legal qualification of the applicant is proven by the fact that the applicant is a 100% Filipino corporation duly organized and existing in accordance with Philippine laws. And it is authorized and allowed to install, construct, maintain, and operate a CATV System.
 - 3.2 Applicant is also financially and economically qualified to establish, operate and maintain the service herein being applied for. The Financial and Economic Feasibility Studies supporting the instant application, as well as all the relevant financial requirements shall be submitted to the Honorable Commission and presented in the course of the hearing on the merits of the instant case.
 - 3.3 Likewise, applicant is technically qualified to establish, operate and maintain the service herein being applied for. The Technical Feasibility Studies supporting the instant application, as well as the technical plans and diagrams and other specifications for this project, shall be submitted to the Honorable Commission and presented in the course of the hearing on the merits of the instant case.

3.4 Applicant also reserves the right to submit additional or supplemental evidence, if necessary, in support of its prayer for issuance of Provisional Authority pending the final determination of the present application.

4. Applicant undertakes to operate the CATV System in Hindang, Leyte in accordance with the appropriate laws, policies, and the required standards in programming, and the rules and regulations promulgated by this Honorable Commission. It likewise binds itself to provide ample public service through the broadcast of quality programs.
5. Applicant is also seeking, relative to and in connection with all the foregoing, of the approval of all the necessary permits to purchase, possess and construct the equipment that shall be used for the installation, operation, and maintenance of the service subject of the instant application.
6. Public good and interest urgently require the immediate approval of the service herein applied for, and applicant also warrants that it will operate the CATV System in LICAB, Nueva Ecija being applied for in accordance with the appropriate laws, policies, standards, rules and regulations promulgated by this Honorable Commission.


PRAYER

1. Granting or issuing in favor of the applicant a Certificate of Authority to install, operate and maintain a CATV System in Hindang, Leyte, after due notice and hearing.
2. Issuing or granting in favor of the applicant a Provisional Authority to operate the CATV System in Hindang, Leyte subject of this application, pending release or issuance in its favor of a Certificate of Authority.

This is to certify that the Articles of Incorporation and By-Laws of:

This Certificate grants juridical personality to the corporation but does not authorize it to undertake business activities requiring a Secondary License from this Commission such as, but not limited to acting as: broker or dealer in securities, government securities eligible dealer (GSED), investment adviser of an investment company, close-end or open-end investment company, investment house, transfer agent, commodity/financial futures exchange/ broker/ merchant, financing company, pre-need plan issuer, general agent in pre-need plans and time shares / club shares/ membership certificates issuers or selling agents thereof. Neither does this Certificate constitute as permit to undertake activities for which other government agencies require a license or permit.

As a registered corporation, it shall submit annually to this Commission the reports indicated at the back of this Certificate.
