| 326 | Mr. Chair, I seconded the motion because I think it is proper and it is within the bounds     |
| 327 | of the mandate of the Local Government Unit of Tanauan to regulate passage of trucks and      |
| 328 | roads so it was proper for the Sangguniang Barangay to request the Sangguniang Bayan of       |
| 329 | Tanauan. However, I think there is an exception, as far as the Mayor is concerned. The        |
| 330 | exercise of police power is, clearly, legislative in nature. It falls within the ambit of the |
| 331 | mandate of the Sangguniang Bayan, not the Mayor. The Mayor will only execute legislation      |
| 332 | passed by the Sangguniang Bayan in regulating the use of the rules. The Provincial Legal      |
| 333 | Office cites Section 17 which provides for the powers of the Sangguniang Bayan. With that, I  |
