 126 dated November 13, 2024, it was disclosed that there were comments and
 127 recommendations from line government agencies that were attached to the
 128 subject resolution. in connection therewith, and for the municipality of Jaro to be
 129 able to address and comply with the said comments and recommendations,
 130 respectively, it was resolved that Resolution No. 2024-01 together with attached
 131 comments and recommendations be endorsed to the CLUP Municipal
 132 Technical Working Group of the Local Government Unit of Jaro, Leyte and to its
 133 Sangguniang Bayan, hence SP Resolution No. 2024-488.
