• Ordinance No. 479 entitled: "An Ordinance on the protection and conservation of wildlife in the Municipality of Babatagon, Levte."

REVIEW/RECOMMENDATION/LEGAL OPINION:

This office is of the opinion that the subject Ordinance is generally in accordance with its power under Section 447(a)(1)(vi)¹ and Section 447(5)(i)² of the Local Government Code of 1991 (R.A 7160). However, we recommend the inclusion of the following provisions; Sec 3(d) and all other illegal acts as reflected in Sec. 27 of R.A. 9147; Sec 4(c) and all other instances excepted by R.A. no. 9147; Sec. 5 "Nothing in this Ordinance bars prosecution under the provisions of R.A. no 9147". Hence, this office recommends further review and revision of said Ordinance.

We hope to have assisted you with this request. Please note that the opinion rendered by this Office are based on the facts available and may vary or change when additional facts and documents are presented or changed. This opinion is likewise without prejudice to the opinions rendered by higher and competent authorities and/or the courts.



WHEREAS, the Municipality of Babatngon recognizes the importance of protecting and conserving its wildlife and their habitats;

WHEREAS, this municipality acknowledges also the need to regulate the hunting, killing, capturing, and trading of wildlife within its jurisdiction;

WHEREAS, the Municipality of Babatngon recognizes the need to promote awareness and education on the importance of wildlife conservation;

NOW, THEREFORE, be it Ordained by the Sangguniang Bayan of the Municipality of Babatngon, Leyte in session assembled, THAT:

<u>SECTION 1. TITLE</u>. This ordinance shall be known as the "Wildlife Protection and Conservation Ordinance of the Municipality of Babatngon, Leyte."

SECTION 2. DEFINITION OF TERMS. For purposes of this ordinance, the following terms shall mean:

- (a) Wildlife refers to all wild animals living in their natural habitat, including but not limited to, mammals, birds, reptiles, amphibians, and invertebrates.
- (b) Habitat refers to the natural environment where wildlife lives, including but not limited to, forests, grasslands, wetlands, and marine areas.
 - (c) Hunting refers to the act of pursuing, shooting, killing, or capturing wildlife.
 - (d) Trading refers to the act of buying, selling, or exchanging wildlife or their parts.

<u>SECTION 3. PROHIBITED ACTS</u>. The following acts are prohibited within the jurisdiction of the Municipality of Babatngon, Leyte.

- (a) Hunting, killing, capturing, or trading of wildlife, except as provided in Section 4 of this ordinance.
- (b) Destruction, disturbance, or pollution of wildlife habitats.
- (c) Possession, transport, or sale of wildlife or their parts, except as provided in Section 4 of this ordinance.

<u>SECTION 4. EXCEPTIONS</u>. The following acts are allowed within the jurisdiction of the Municipality of Babatngon, Leyte, subject to the conditions set forth in this section:

(a) Hunting, killing, capturing, or trading of wildlife, for scientific, educational, or management purposes, and only with the necessary permits and licenses from the appropriate government agencies.

(b) Possession, transport, or sale of wildlife or their parts, for scientific, educational, or management purposes, and only with the necessary permits and licenses from the appropriate government agencies.

SECTION 5. PENALTY CLAUSE. Any person found to have committed any of the prohibited acts under Section 3 hereof shall be penalized as follows:

(a) First Offense

- A fine of One Thousand Five Hundred Pesos

(PhP 1,500.00)

(b) Second Offense

- A fine of Two Thousand Pesos

(PhP 2,000.00)

(c) Third Offense

- A fine of Two Thousand Five Hundred Pesos

(PhP 2,500.00)

<u>SECTION 7. REPEALING CLAUSE</u>. All ordinances, rules, regulations, or parts thereof, which are inconsistent with the provisions of this ordinance, are hereby repealed or modified accordingly.

<u>SECTION 8. EFFECTIVITY</u>. This ordinance shall take effect fifteen (15) days following its posting in at least three (3) conspicuous places in the local government unit.


