MUNICIPAL ORDINANCE NO. 24-22 SERIES OF 2024

AN ORDINANCE CREATING THREE (3) MANDATORY PLANTILLA POSITIONS AND ONE (1) MUNICIPAL OFFICE, IN THE MUNICIPAL GOVERNMENT OF BURAUEN, LEYTE AND APPROPRIATING FUNDS THEREOF

AUTHOR: HON. FE S. RENOMERON Chairman, Committee on Personnel Matters

WHEREAS, Section 5 of the Civil Service Memorandum Circular 12 Series of 2022 states that, "LGUs shall create mandatory positions. It may create optional positions, provided that all mandatory positions shall have been created, and in accordance with the limitations provided under the law and these Guidelines. It is understood that the creation of positions shall have the corresponding budget, approved by the sanggunian, to be considered valid. The creation of mandatory positions shall likewise comply with the 45%-55% budgetary limitations for personnel services."

WHEREAS, it is imperative that the Local Government Unit of Burauen sets priority on the creation of these mandatory positions, for the agency to be allowed to open other positions (Optional Positions), needed to satisfy the required workforce of each department.

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of Burauen in regular session assembled that:

SECTION 1 – The following Mandatory Plantilla Positions and the Office of the Municipal Agricultural and Biosystems Engineer of the Local Government Unit of Burauen are hereby created and appropriating the necessary funds thereof, to wit:

SECTION 2 – The powers and functions of the said positions and office shall be in accordance with the guidelines and standards set forth by the Civil Service Commission (CSC).

**SECTION 3** – *Repealing Clause.* All ordinances, resolutions, executive orders and all other issuances inconsistent herewith are deemed to be repealed or modified accordingly.

SECTION 4 - Effectivity. This ordinance shall take effect upon its approval.
