Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 1 FY 2024** of the **Municipality of Dagami, Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 2 S. 2024** with a total appropriation in the amount of **P21,471,075.72** reveals compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

- That the appropriation for salaries to officials and employees implementing the First Tranche Compensation Adjustment for Local Government Personnel under SSL VI is in accordance with the provisions of LBC 160 dated August 12, 2024 and the authorized rates thereof under Annex "A-5" (3rd class salary schedule) and Annex A-1.
- 2. That all positions in the plantilla are incorporated in the Organizational Structure and Staffing Pattern of the LGU as approved by the Sangguniang Bayan;
- 3. That the reversion are duly authorized by the concerned officials and is backed up by cash collections from the estimated income and shall be utilized to fund the expenditures under Supplemental No. 1;
- 4. That the procurement of Equipment and Civil Works and other related services shall be made in accordance with the provisions of RA 9184 and its Implementing Rules and Regulations;
- 5. That funds are actually available to pay these proposed expenditures and shall be disbursed for the specific purpose(s) for which they have been appropriated pursuant to Section 336 of RA 7160.

Compliance with DBM issuances, CSC rules, and accounting and auditing rules and regulations and all other pertinent laws shall be the responsibility of the implementing Local Government Unit.




