Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 2 FY 2024** of the **Municipality Jaro**, **Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 3**, **S. 2024**, with a total appropriation in the amount of **Php9,315,848.64** reveals compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

- 1. That the Savings from PS as funding source is duly certified with cash back up and is not restricted by law or other obligations and are made available to support the expenditures under Supplemental Budget No. 02. The Unutilized Personal Services appropriation in 2023 must have formed part of the Unappropriated Surplus or Balance at the end of CY 2023 after the closing of the books of accounts. Hence, the funding source should have been Unappropriated Balance;
- 2. That the appropriation for salaries to officials and employees implementing the First Tranche Compensation Adjustment under SSL VI for Local Government Personnel from September to December 2024 is in accordance to the provisions of Local Budget Circular No. 160 dated August 12, 2024 and the authorized rates thereof under Annex "A-1" or First Class Province rate. Further, that the LGU can sustain the said salary schedule adoption and the provisions of all other Personal Services (PS) cost requirements authorized by law are fully provided for;
- 3. That the grant of the following benefits shall be made pursuant to the corresponding guidelines relative thereto:
 - a) RATA Local Budget Circular No. 157
 - b) Clothing Allowance Budget Circular No. 2024-1
 - c) Hazard Pay establishment of this benefit/incentive shall be based on the conditions enumerated under the Magna Carta for Public Health Workers and Magna Carta for Public Social Workers and payment shall likewise strictly adhere to the said requirements 4.
- 4. That disbursement of funds shall be for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

Compliance with DBM issuances, and all other accounting and auditing rules and regulations shall be the responsibility of the implementing Local Government Unit.


