Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 01 FY 2024** of the **Municipality of Julita**, **Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 2024-09** with a total appropriation in the amount of **P8,995,827.02** reveals compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

- 1. That the appropriation for salaries to officials and employees implementing the First Tranche Compensation Adjustment under SSL VI for Local Government Personnel is in accordance with the provisions of Local Budget Circular No. 160 dated August 12, 2024 and the authorized rates thereof under Annex A-6 or for Fourth Class Municipalities and Annex A-1 for the Public Health Workers of the LGU.
- 2. That the reversion of appropriations is duly authorized by the concerned officials and is backed up by cash collections and are made available to support the expenditures under Supplemental Budget No. 01. Further, that said reversion shall not adversely affect the fiscal standing of the LGU upon the closing of the books of accounts.
- That the projects under 20% Development Fund (DF) shall strictly adhere to DBM-DOF-DILG Joint Memorandum Circular No. 1 dated November 4, 2020;
- 4. That the LGU created the following positions:
 - a. Planning Officer III SG 18
 - b. Midwife I SG 9

Attention is hereby invited to Section 5 of the Civil Service Commission (CSC) Memorandum Circular (MC) No. 12, series of 2022 which provides that the creation and funding of optional positions may be allowed after the mandatory positions have been created. Thus, the said positions created and funded herein are hereby deferred until the mandatory positions are duly created first pursuant to said Memorandum Circular No. 12 of the Civil Service Commission.

5. That funds are actually available to pay these proposed expenditures and shall be disbursed for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

Compliance with DBM issuances, and accounting and auditing rules and regulations and all other existing laws shall be the responsibility of the implementing Local Government Unit.

A RESOLUTION RETURNING TO THE SANGGUNIANG BAYAN OF ORIGIN GENERAL FUND SUPPLEMENTAL BUDGET NO. 01 CY 2024 OF JULITA, LEYTE.

WHEREAS. Section 327 of Republic Act 7160 otherwise known as The Local Government Code of 1991, mandates the Sangguniang Panlalawigan to review the ordinance authorizing annual or supplemental appropriations of component cities and municipalities, in the same manner and within the same period for the review of other ordinances;

WHEREAS, submitted to the Sangguniang Panlalawigan of Leyte is the General Fund Supplemental Budget No. 01 CY 2024 of Julita, Leyte under Appropriation Ordinance No. 2024-09;

WHEREAS, the Local Finance Committee, upon evaluation of the budget documents, observed the following, to wit:

Implementation of a Modified Salary Schedule
 The Local Government Unit (LGU) of Julita, Leyte has formulated a modified salary schedule through Municipal Ordinance No. 2024-08, as outlined in the following "whereas" clause:

"WHEREAS, the Sangguniang Bayan of the Municipality of Julita, Leyte decides to formulate a modified salary schedule by adopting a seventy-five percent (75%) of the authorized Salary Schedule for National Government Agencies (NGA's) prescribed in Section 3 as authorized in Section 4 of Executive Order No. 64".

The Department of Budget and Management (DBM) issued Local Budget Circular No. 160 on August 12, 2024, implementing Office of the President (OP) Executive Order No. 64 dated 01 August 2024 entitled "Updating the Salary Schedule for Civilian Government Personnel and Authorizing the Grant of an Additional Allowance, and for other purposes", to provide rules, guidelines and regulations for the implementation of the First Tranche of the Updated Salary Schedule for Civilian Personnel stipulated under EO No. 64.

Section 5.1 of LBC No. 160 provides 3 options for the LGUs to adopt, to wit:

- 5.1.1 Fully adopt the Salary Schedule in Section 3 of EO No. 64 (Annex A-1 of this Circular), notwithstanding the ceilings provided under Section 4 thereof, subject to compliance with the PS limitation and budgetary authorization requirements of RA No. 7160;
- 5.1.2 Follow the percentage of the Salary Schedule corresponding to the LGU's current income classification; or
- 5.1.3 If funds are insufficient to implement fully the salary schedule for the LGU level and income class, or for purposes of complying with the PS limitation, the Sanggunian may formulate a modified salary schedule with lower rates but at a uniform percentage of the rates in the applicable salary schedule in Annexes A-1 to A-8 across all positions.

It is important to emphasize that the adoption of the Salary Schedule in Section 3 of Executive Order No. 64 must be **implemented in full**. The Sanggunian concerned may only formulate a lower modified salary schedule in accordance with the applicable salary schedule based on the LGU's income classification.

The LGU-Julita also created the following positions:

- (1) Planning Officer III SG 18
- (1) Midwife I-SG 9
- (1) Administrative Officer II (HRMO I) -SG-1)

3. Reversion of Appropriations

The reversion of appropriations from Personal Services does not indicate the Items or positions where the salaries are being taken from and for what period and year.

In view of the foregoing findings, we are returning the said Supplemental Budget No. 1 CY 2024 of the Municipality of Julita, Leyte, without preliminary review action on the following grounds: 1. The implementation of the First Tranche Salary adjustment, if the LGU will choose to implement option (1), is to fully adopt the salary schedule in Annex A-1 of LBC No. 160 pursuant to Section 5.1.1 thereof, not on a percentage basis.

2. The creation of New Positions shall be allowed only after the creation of the Mandatory Positions outlined in CSC MC No. 12.

 The reversion of positions shall be properly identified, as to positions, the office and the period.

Dear Honorable Vice Governor:



This letter is in response to Resolution No. 2024-465 dated October 15, 2024 coming from the Sangguniang Panlalawigan of Leyte, entitled "A Resolution Returning to the Sangguniang Bayan of Origin General Fund Suplemental Budget No. 01 CY 2024 of Julita, Leyte." This resolution returns our Supplemental Budget No. 01 CY 2024 based on three (3) observations made by the Local Finance Committee to wit: 1) The implementation of the first Tranche Salary adjustment, if the LGU will choose to implement option, (1). Is to fully adopt the salary achedule in Annex A-1 of LBC No. 160 pursuant to Section 5.1.1 thereof, not on a percentage basis. 2) The creation of New Positions shall be allowed only after the creation of the Mandatory Positions outlined in CSC MC No. 12. and 3) The reversion of positions shall be properly identified, as to positions, the office and the period.

With regards to the *first observation,* the Local Government Unit of Julita, Leyte had decided to adopt the First Tranche Monthly Salary Schedule for Local Government Personnel based on Section 5.1 of LBC No. 160 specifically subsection 5.1.3 to quote "*If funds are insufficient to implement fully the salary schedule for the LGU level and income class, or for purposes of complying with PS limitations, the Sanggunian may formulate a modified salary schedule with lower rates but at a uniform percentage of the rates in the applicable salary schedule in Annex A-1 to A-8 across all positions."*

Although our Local Government Unit is considered a fifth class municipality, it is financially capable of fully implementing the Salary Schedule in Section 3 of Executive Order No. 64, but since it would exceed the allowed Personnel Services (PS) limitation, our Local Government Unit through our Sangguniang Bayan had exercised the authority granted under Section 5 of LBC No. 160, specifically Subsection 5.1.3 by enacting Municipal Ordinance No. 2024-08 dated September 02, 2024 entitled, "AN ORDINANCE ADOPTING A MODIFIED SALARY SCHEDULE BY ADOPTING A SEVENTY-FIVE PERCENT (75%) OF THE AUTHORIZED SALARY SCHEDULE FOR NATIONAL GOVERNMENT AGENCIES (NGA'S) AS PRESCRIBED IN SECTION 3 AND AUTHORIZED IN SECTION 4 OF

EXECUTIVE ORDER NO. 64, DATED AUGUST 2, 2024 ENTITLED, "UPDATING THE SALARY SCHEDULE FOR CIVILIAN GOVERNMENT PERSONNEL AND AUTHORIZING THE GRANT OF AN ADDITIONAL ALLOWANCE AND FOR OTHER PURPOSES" INTENDED FOR NON-PUBLIC HEALTH WORKERS AND FURTHER ADOPTS THE SALARY RATES AUTHORIZED FOR PERSONNEL OF SPECIAL CITIES/FIRST CLASS PROVINCES AND CITIES (ANNEX A-1 LBC 160 DATED AUGUST 12, 2024) FOR PUBLIC HEALTH WORKERS (PHW) OF THE RURAL HEALTH UNIT OF THIS LOCAL GOVERNMENT UNIT." This Municipal Ordinance No. 2024-08 dated September 02, 2024 which was our legal basis in adopting the Salary Schedule in Section 3 of Executive Order No. 64 was endorsed to the Sangguniang Panlalawigan of Leyte last September 18, 2024 for its appropriate action.

Furthermore, last **October 15, 2024** the members of the Sangguniang Panlalawigan of Leyte had unanimously declared the validity and the approval of **Municipal Ordinance No. 2024-08** through **Resolution No. 2024-464** which is our legal basis for our salary increase as explained and elaborated on the Supplemental Budget No. 01 CY 2024 of our municipality.

It not be overemphasized that the effectivity and applicability of Supplemental Budget No. 01 CY 2024 when its legal basis, the Municipal Ordinance No. 2024-08, was declared valid and approved by the distinguished members of the Sangguniang Panlalawigan of Leyte.

On the *second observation* to quote, "The creation of New Positions shall be allowed only after the creation of the Mandatory Positions outlined in CSC MC No. 12". The three (3) concerned positions namely: 1) Planning Officer III-SG 18, 2) Midwife I-SG 9 and 3) Administrative Officer II (HRMO I) - SG- 11 were created by our municipality with the obvious reason that they are currently needed by the municipality for its day to day operations. With regards to the position of the Municipal Planning and Development Officer (MPDO) a mandatory position, which is considered the brain of the municipality when it comes to crafting its plans and programs, there is no qualified individual that can meet its qualification standards as prescribed by the Civil Service Commission, thus the position of Planning Officer III was created. In addition, majority of the Mandatory Positions of our municipality were already created.

With regards to the *third observation* to quote, "The reversion of positions shall be properly identified, as to positions, the office and the period." Our Local Government Unit is furnishing your good office with the detailed and complete list of the source of funds through a diagram utilized in Supplemental Budget No. 01 CY 2024, specifically the concerned positions, the particular offices and the period of salaries utilized.





BE IT ENACTED by the Sangguniang Bayan of Julita, Leyte, in session duly assembled, that:

SECTION 1. Title. This Municipal Ordinance shall be known as AN ORDINANCE ADOPTING A MODIFIED SALARY SCHEDULE BY ADOPTING A SEVENTY-FIVE PERCENT (75%) OF THE AUTHORIZED SALARY SCHEDULE FOR NATIONAL GOVERNMENT AGENCIES (NGA'S) AS PRESCRIBED IN SECTION 3 AND AUTHORIZED IN SECTION 4 OF EXECUTIVE ORDER NO. 64, DATED AUGUST 2, 2024 ENTITLED, "UPDATING THE SALARY SCHEDULE FOR CIVILIAN GOVERNMENT PERSONNEL AND AUTHORIZING THE GRANT OF AN ADDITIONAL ALLOWANCE AND FOR OTHER PURPOSES" INTENDED FOR NON-PUBLIC HEALTH WORKERS AND FURTHER ADOPTS THE SALARY RATES AUTHORIZED FOR PERSONNEL OF SPECIAL CITIES/FIRST CLASS PROVINCES AND CITIES (ANNEX A-1 LBC 160 DATED AUGUST 12, 2024) FOR PUBLIC HEALTH WORKERS (PHW) OF THE RURAL HEALTH UNIT OF THIS LOCAL GOVERNMENT UNIT.

SECTION 2. Modified Salary Schedule. There is hereby created a Modified Salary Schedule of the Local Government Unit of Julita, Leyte for its Non-Public Health Workers: (**75%** of the Authorized Salary Schedule for Local Government Personnel Annex A-1 of LBC 160 dated August 12, 2024 and Section 3 of Executive Order No. 64 dated August 2, 2024.)

SECTION 8. Separability Clause. If, for any reason or reasons, any part or provision of this Ordinance is held to be unconstitutional or invalid, other parts or provisions hereof which are not affected shall continue to be in full force and effect.

SECTION 9. Repealing Clause. All ordinances, rules and regulations, or parts thereof, in conflict with or inconsistent to the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 10. Effectivity. This Ordinance shall take effect immediately after its approval.
