Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the General Fund Supplemental Budget No. 5 CY 2024 of the Municipality of Tabango, Leyte duly enacted by the Sangguniang Bayan through Appropriation Ordinance No. 2024-05 series of 2024 with a total appropriation in the amount of P1,445,116.78, reveals compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

- 1. That the reversion of appropriations is duly authorized by the concerned officials and are made available to support the expenditures under Supplemental Budget No. 5. - 3. That disbursement of funds shall be for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

Compliance with DBM issuances, accounting and auditing rules and regulations and all other existing laws shall be the responsibility of the implementing Local Government Unit.





SECTION 1. The SUPPLEMENTAL BUDGET NO. 05 for FY 2024 of the Municipality of Tabango, Province of Leyte, in the total amount of ONE MILLION FOUR HUNDRED HUNDRED SIXTEEN PESOS THOUSAND ONE æ (₱1,445,116.78), covering the various expenditures of the Municipal Government for FY 2024 and appropriating funds for the purpose is hereby enacted.




