
AN ORDINANCE AUTHORIZING THE MAYOR AND/OR THE PRESIDING OFFICER OF THE SANGGUNIAN TO USE SAVINGS FOR AUGMENTATION IN ACCORDANCE WITH THE LOCCAL GOVERNMENT CODE OF 1991

BE IT ORDAINED in the Regular Session assembled:

SECTION 1. Use of Savings and Augmentation. In accordance with Section 336 of Republic Act No. 7160 or the Local Government Code of 1991, the Mayor and/or the Presiding Officer of the Sanggunian is/are authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

For this purpose, "savings" refer to portions or balances of any programmed appropriation free from any obligation or encumbrance still available after the satisfactory completion or unavoidable discontinuance or abandonment of the work, activity or purpose for which the appropriation is authorized, or arising from unpaid compensation and related costs pertaining to vacant positions and leaves of absence without pay.

"Augmentation" implies the existence in the budget of an item, project, activity or purpose with an appropriation which, upon implementation or subsequent evaluation of needed resources, is determined to be deficient.

SECTION 2. Priority in the Use of Personal Services (PS) Savings. Priority shall be given to the personnel benefits of local employees in the use of PS Savings.

SECTION 3. Separability Clause. If, for any reason, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected thereby shall continue to be in full force and effect.

SECTION 4. Effectivity. The provisions of this Appropriation Ordinance shall take effect upon its approval and shall remain in effect unless otherwise provided by the Honorable Sangguniang Panlalawigan.
