- 4. That disbursement of funds shall be for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

SECTION 1. The Supplemental Budget No. 02 of the Municipality of Albuera Leyte for Fiscal Year 2024 in the total amount of FOUR MILLION THREE HUNDRED SEVENTY-SEVEN THOUSAND NINE HUNDRED PESOS (PHP4,377,900.00) for purposes specified in the accompanying schedules, is hereby approved;



At 1:48 p.m., the Local Development Council meeting was called to order by the Municipal Administrator, Mr. Mario I. Cubi and was followed by a prayer and the singing of the Philippine National Anthem and Albuera Hymn. The MPDC then read the minutes of the previous meeting dated October 29, 2024, and without correction, on motion by Ms. Rolando S. Maskariño, duly seconded by Hon. Delia E. Batistis, the said minutes was approved.

## **Business Arising from the Minutes:**

The MPDC announced that the proposed seminar originally scheduled for November 13-15, 2024, will be rescheduled to an indefinite date. This adjustment is due to a scheduling conflict with the Barangayan, a community event requiring the presence of key speakers, including the Municipal Agriculturist and the Municipal Environment and Natural Resources Officer. The MPDC highlighted the importance of ensuring the availability of these key personnel for both events, and the rescheduling will allow for better coordination and participation once a suitable date is identified.

## Presentation of the Proposed CY 2024 2<sup>nd</sup> Supplemental Investment Program:

The MPDC then proceeded to the presentation of the proposed CY 2024 2nd Supplemental Investment Program. The funding source for this program includes savings from the Community-Based Monitoring System (CBMS) allocation, originally budgeted in the 2024 Annual Investment Plan and Annual Budget. These funds were declared as savings since the expenses for the CBMS implementation in the municipality were covered by the national government through the Philippine Statistics Authority.

The proposed PPAs under this 2nd Supplemental Investment Program include allocations for terminal leave benefits, electricity expenses, and gasoline, fuel, and lubricants expenses. Additionally, infrastructure projects such as the construction of a drainage canal along the Sabang area, construction of a drainage canal at the Municipal Slaughterhouse, and the improvement of the multipurpose building at Barangay San Pedro were also outlined. The MPDC emphasized that these allocations would address priority needs while maximizing available resources from the CBMS-related savings.

## Presentation and Approval of Proposed LDC Resolution No. 2024 - 06:

On motion by Ms. Asteria Marita C. Villar and duly seconded by Hon. Nilda A. Jabon, LDC Resolution No. 2024 – 06 entitled: "A Resolution Approving and Endorsing to the Sangguniang Bayan, Albuera, Leyte the C.Y. 2024 Second Supplemental Investment Program of this Municipality Including the Priority Programs, Projects and Activities Funded Under the General Fund in the Amount of Six Million Seventy-Seven Thousand Nine Hundred Pesos (Php 6,077,900.00) Only", was approved and acted accordingly by Local Development Council.

## Other Matters:

The Municipal Administrator announced to the council that LGU Albuera has been honored with the prestigious Gawad KALASAG Seal and Special Awards for Excellence in Disaster Risk Reduction and Management and Humanitarian Assistance. The awarding ceremony is set for December 2, 2024

 With this announcement, he encouraged the barangays to look to the municipality as a model of excellence, particularly in DRRM practices. He expressed his gratitude to the dedicated individuals and groups who contributed to this achievement, including the municipal employees, barangay officials, and various stakeholders. Their combined efforts were recognized as pivotal in establishing a resilient and responsive community, setting a high standard for others to follow.

The Municipal Mayor urged all barangays to remain alert and prepared as the rainy season progresses. He stressed that, given the municipality's limited resources, it is not feasible for him to oversee every area. He specifically called on barangay officials in landslide-prone areas to stay vigilant and take precautionary measures to safeguard their communities, and encouraged them to reach out proactively should they need assistance, particularly regarding disaster response efforts. By staying coordinated, the mayor emphasized that the municipality and barangays should work together to minimize risks and respond effectively to potential hazards.

Lastly, the Municipal Administrator announced that a relocation survey will be conducted along the boundary between Albuera and Baybay City. He emphasized the importance of this survey to collect essential data and documentation to address the encroachment by Baybay City into Albuera's territory. This issue of boundary encroachment, impacting approximately a thousand hectares, is documented in Baybay City's Forest Land Use Plan (FLUP).

He also reminded the council that, as per protocol, territorial disputes between component cities and municipalities are to be resolved at the Sangguniang Panlalawigan of Leyte, where Albuera intends to formally file its case. He reiterated Albuera's stance in upholding its territorial integrity and firmly rejecting the territorial claims made by Baybay City.

## Adjournment:

And with no other business to be discussed by the council, on motion by Hon. Rufino Y. Valdez and duly seconded by Hon. Francisco L. Manatad, Jr., the meeting was adjourned at 3:11 p.m.
