Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 03 FY 2024** of the **Municipality of Tunga**, **Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 04**, **Series of 2024** with a total appropriation in the amount of **P2,726,263.34** reveals compliance with the same law and its implementing Rules and Regulations.

- 4. That funds are actually available to pay these proposed expenditures and shall be disbursed for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

Compliance with DBM issuances, and accounting and auditing rules and regulations and all other existing laws shall be the responsibility of the implementing Local Government Unit.
