#### **ORDINANCE NO. 2024 – 26**

AN ORDINANCE INSTITUTIONALIZING THE COMMEMORATION OF WORLD WAR II IN THE MUNICIPALITY OF TANAUAN, LEYTE AND HONORING LOCAL WORLD WAR II VETERANS; PRESCRIBING ACTIVITIES IN THE COMMEMORATION THEREOF AND PROVIDING FUNDS THEREFOR.

## BE IT ENACTED BY THE SANGGUNIANG BAYAN OF TANAUAN, LEYTE IN REGULAR SESSION ASSEMBLED THAT:

WHEREAS, THE MUNICIPALITY OF TANAUAN LEYTE HAS PLAYED AN IMPORTANT PART IN THE SECOND WORLD WAR AS IT SERVED AS AN AIRFIELD DURING THE LIBERATION OF THE COUNTRY.

WHEREAS, IT IS THE DECLARED POLICY OF THE STATE, AS PROVIDED FOR IN REPUBLIC ACT NO. 6948, "TO HELP FOSTER THE SOCIOECONOMIC SECURITY AND GENERAL WELL-BEING OF THE COUNTRY'S VETERANS IN RECOGNITION OF THEIR PATRIOTIC SERVICES IN TIMES OF WAR AND PEACE FOR THE CAUSE OF FREEDOM AND DEMOCRACY; FOR THE ATTAINMENT OF NATIONAL UNITY, IDEPENDENCE, AND SOCIOECONOMIC ADVANCEMENT; AND THE MAINTENANCE OF PEACE AND ORDER, IN KEEPING WITH THE GOALS OF THE GOVERNMENT AND ASPIRATIONS OF THE PEOPLE".

WHEREAS, HONORING WORLD WAR II VETERANS OF TANAUAN LEYTE AND THE HISTORIC EVENTS THAT TRANSPIRED ARE CRUCIAL IN SHAPING THE TOWN'S HISTORY. THESE VETERANS FOUGHT VALIANTLY AND MADE IMMEASURABLE SACRIFICES TO DEFEND OUR TOWN AND THE COUNTRY.

WHEREAS, COMMEMORATING THESE HISTORIC EVENTS AND LOCAL HEROES IS A MOST PRECIOUS TRIBUTE FOR THE MUNICIPALITY TO PAY HOMAGE TO THEIR LEGACY AND ENSURE THAT THEIR BRAVERY WILL NEVER BE FORGOTTEN.

**SECTION 1. TITLE –** THIS ORDINANCE SHALL BE KNOWN AS THE "TANAUAN LEYTE WORLD WAR II COMMEMORATION ORDINANCE".

SECTION 2. DECLARATION OF POLICY – THE LOCAL GOVERNMENT UNIT OF TANAUAN LEYTE RECOGNIZES THE SIGNIFICANT CONTRIBUTIONS AND SACRIFICES MADE BY WORLD WAR II VETERANS AND THE HISTORICAL EVENTS THAT TRANSPIRED IN THE DEFENSE OF THE TOWN. IT IS THE POLICY OF THE MUNICIPALITY TO RECOGNIZE THESE EFFORTS AND EVENTS AND ENSURE THAT THEY ARE ACCORDED WITH RESPECT AND REMEMBRANCE.

**SECTION 3. COMMEMORATION** – THE LOCAL GOVERNMENT UNIT OF TANAUAN LEYTE SHALL ANNUALLY OBSERVE THE COMMEMORATION OF THE WORLD WAR II AT THE TOWN PLAZA EVERY OCTOBER 18TH OF THE YEAR IN LINE WITH THE LEYTE LANDINGS COMMEMORATION.

A WREATH LAYING CEREMONY SHALL BE HELD AT THE WORLD WAR II MARKER.

#### SECTION 4. RECOGNITION OF LIVING VETERANS AND HISTORIC EVENTS -

- A. ALL LIVING WORLD WAR II VETERANS SHALL BE DECLARED AS LIVING TREASURES AND SYMBOLS OF COURAGE, BRAVERY AND SACRFICE.
- B. DESCENDANTS OF WORLD WAR II VETERANS ARE ENCOURAGED TO TAKE PART IN THE COMMEMORATION.
- C. HISTORIC EVENTS OF WORLD WAR II THAT TRANSPIRED IN THE MUNICIPALITY OF TANAUAN LEYTE SHALL BE RECOGNIZED ALONG WITH THE SACRIFICES MADE BY OUR VETERANS AND TOWNS PEOPLE IN REGAINING OUR FREEDOM.

**SECTION 5. BENEFITS** – These benefits are hereby accorded in favor of living World War II veterans, to wit:

Benefits	Entitlement/Coverage	Details/Description
Rice Subsidy	Living Veterans	Php3,000 – 3 times a year
	Spouse of Deceased Veterans  – provided they present a legal marriage certificate	Php1,500 – 3 times a year
Cash Assistance	Living Veterans	Php15,000 — yearly on the occasion of the World War II Commemoration.
Prioritization	Living Veterans	Priority in accessing healthcare, financial assistance and other applicable benefits and services.

Benefits mentioned above shall not be applicable to any living sons and daughters or heir of WWII veterans except for their living spouse.

SECTION 6. WORLD WAR II MARKER – A WORLD WAR II MARKER SHALL BE INSTALLED AT THE CENTER OF THE TOWN PLAZA AND SHALL BE MAINTAINED AND PROTECTED BY THE LOCAL GOVERNMENT UNIT.

SECTION 7. WORLD WAR II VETERANS MEMORIAL — A SPECIAL MEMORIAL LOT AT THE TANAUAN CIVIC CEMETERY SHALL BE DEDICATED TO THE DECEASED LOCAL WORLD WAR II VETERANS AND THEIR SPOUSES WHICH SHALL BE MAINTAINED AND PROTECTED BY THE LOCAL GOVERNMENT UNIT.

**SECTION 8. APPROPRIATION –** THE AMOUNT NECESSARY TO IMPLEMENT THIS ORDINANCE SHALL BE SOURCED FROM APPROPRIATIONS WHICH MAY BE ALLOCATED THROUGH THE ANNUAL APPROPRIATIONS OR SUPPLEMENTAL ORDINANCES AS MAY BE NECESSARY.

**SECTION 9. SEPARABILITY CLAUSE** — IF FOR ANY REASON, ANY PART OR PROVISION OF THIS ORDINANCE IS DECLARED INVALID OR UNCONSTITUTIONAL, THE REMAINING PARTS OR PROVISIONS NOT AFFECTED SHALL REMAIN IN FULL FORCE AND EFFECT.

**SECTION 10. REPEALING CLAUSE** – ALL ORDINANCES, RESOLUTIONS WHICH ARE INCONSISTENT WITH THE PROVISIONS OF THIS ORDINANCE ARE HEREBY REPEALED OR MODIFIED ACCORDINGLY.

**SECTION 11. EFFECTIVITY** – THIS ORDINANCE SHALL TAKE EFFECT AFTER COMPLIANCE WITH THE RELEVANT PROVISIONS OF THE LOCAL GOVERNMENT CODE ON POSTING AND PUBLICATION.
