Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 01 FY 2025** of the **Municipality of Mahaplag**, **Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 25-001** with a total appropriation in the amount of **P25,134,346.00**, reveals compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

- That the procurement of Goods, Supplies, Equipment, Civil Works and other related services shall be made in accordance with the provisions of RA 9184 and its Implementing Rules and Regulations;
- 2. That the utilization of 20% Development Fund (DF) shall strictly adhere to DBM-DOF-DILG Joint Memorandum Circular No. 1 dated November 4, 2020;
- That the allocation and utilization of the 5% Local Disaster Risk Reduction and Management Fund (LDRRMIF) shall conform with the provisions of NDRRMC-DBM and DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013;
- 4. That the procurement of Motor Vehicles under Capital Outlay shall be made pursuant to the guidelines on the requisition and use of Government Vehicles under Budget Circular No. 2019-3 dated May 16, 2019;
- 5. That the grant of Terminal Leave Benefits shall be subject to the provisions of Budget Circular No. 2016-2 dated March 29, 2016; and
- 6. That disbursement of funds shall be for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

Compliance with DBM issuances, and all other accounting and auditing rules and regulations shall be the responsibility of the implementing Local Government Unit.

MUNICIPAL ORDINANCE NO. 25-001

AN ORDINANCE **APPROVING** THE **SUPPLEMENTAL BUDGET NO. 1 OF THE MUNICIPAL LOCAL GOVERNMENT** UNIT OF MAHAPLAG, LEYTE FOR FISCAL YEAR 2025 IN THE AMOUNT OF TWENTY-FIVE MILLION ONE HUNDRED THIRTY-FOUR THOUSAND THREE HUNDRED FORTY-SIX PESOS (\$\mathbb{P}25,134,346.00).

BE IT ENACTED, as it is hereby enacted, by the Sangguniang Bayan of Mahaplag, Leyte, in session assembled:

Section 1. AUTHORITY AND PURPOSE. This appropriation ordinance is in accordance to the provisions of Republic Act 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Bayan of Mahaplag, Leyte, hereby enact through this Ordinance the declaration of savings and the appropriation of funds under this Supplemental Budget No. 1 for Fiscal Year 2025 of the Municipal Local Government Unit of Mahaplag, Leyte to allocate funds for the following:



- 1. To fund the Terminal Leave Benefits of qualified Municipal Employees and Officials in the Executive and Legislative Departments of the Local Government Unit of Mahaplag;
- 2. To fund the Procurement of Fuel, Oil, and Lubricants;
- 3. To fund the Protection of Children Program (Local Council for the Protection of Children)/Feeding Program.



- 5. To fund the Procurement of X-ray Machine;
- 6. To fund the Travelling Expenses of the Legislative Department;
- 7. To fund the Procurement of Service Vehicle for the Legislative Department;
- 8. To fund the Wages of Five (5) Nurses Hired by the Local Government Unit of Mahaplag thru Contract of Services;
- 9. To fund the Procurement of Tri-Cab (Motorcycle with Cab) for the Mahaplag Municipal Waterworks System (MMWS);
- 10. To fund the Procurement of Garbage Truck;
- 11. To fund the Procurement and Installation of Solar Streetlights;
- 12. To fund the Provision of Basic Commodities and Other Emergency Necessities During Disaster or Calamity; and
- 13. To fund the Procurement/Stockpiling of Basic Emergency Supplies.
- Section 2. DECLARATION OF SAVINGS OF UNOBLIGATED BALANCE FROM THE PREVIOUS YEARS. The amount of SEVEN MILLION TWO HUNDRED FORTY-ONE THOUSAND NINE HUNDRED EIGHTY-TWO PESOS (\$\mathbb{P}7,241,982.00)\$ as part of the Unobligated Balance from the Previous Years' General Appropriations (Fiscal Year 2022 and prior years) as indicated in the Status of Appropriation, Allotment, Obligation and Balances as of December 31, 2022 as well as from the Savings from Calendar Year 2023 that were declared as Savings by the Local Finance Committee under a Certification dated 3 January 2025 are hereby officially declared as Savings by virtue of this Ordinance.
- NATIONAL TAX ALLOTMENT (NTA) DIFFERENTIAL FOR CALENDAR YEAR 2025. The unappropriated funds from the National Tax Allotment (NTA) Differential for Calendar Year 2025 in the amount of SEVENTEEN MILLION EIGHT HUNDRED NINETY-TWO THOUSAND THREE HUNDRED SIXTY-FOUR PESOS (P17,892,364.00) is hereby declared as New Revenue Source/Savings by virtue of this Ordinance.
- Section 4. AVAILABLE FUNDS FOR APPROPRIATION. The total funds actually available for appropriation under this Supplemental Budget No. 1 for the current Fiscal Year 2025 amounts to TWENTY-FIVE MILLION ONE HUNDRED THIRTY-FOUR THOUSAND THREE HUNDRED FORTY-SIX PESOS (\$\mathbb{P}\)25,134,346.00) in accordance to the Statement of Funding Sources duly certified by the Municipal Treasurer and Municipal Accountant Designate, as follows:

Section 6. The Local Chief Executive and the Presiding Officer of the Sangguniang Bayan, pursuant to Section 336 of the Local Government Code of 1991 and Article 454 (b) of the Implementing Rules and Regulations of the Local Government Code of 1991, are authorized by this Ordinance to augment any item in this supplemental budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

For that purpose, "Savings" is defined as the portions or balances as of any given point in the fiscal year of any programmed or allotted appropriation which remain free of any obligation or encumbrance and which are still available after the satisfactory completion or the unavoidable discontinuance or abandonment of the work, activity, or purpose for which the appropriation was originally authorized, or which result from unobligated compensation and related costs pertaining to vacant positions and leaves of absence without pay.

On the other hand, "Augmentation" implies the existence in the budget of an item, project, activity, or purpose with an appropriation which, upon implementation or subsequent evaluation of needed resources, is determined to be deficient.

Section 7. The disbursement of the funds under this Ordinance shall be in accordance with law and with the existing accounting and auditing rules and procedures.

Section 8. SEPARABILITY CLAUSE. If, for any reason, any item, section or provision of this Ordinance is declared invalid or unconstitutional, the other items, sections or provisions

- **Section 9. REPEALING CLAUSE.** All ordinances, resolutions or parts thereof, whose provisions are in conflict with or contrary to the provisions of this ordinance are hereby repealed, amended or modified accordingly.
- Section 10. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval by the Local Chief Executive.
