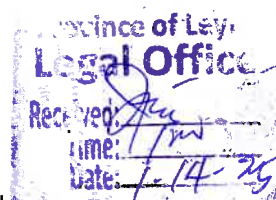

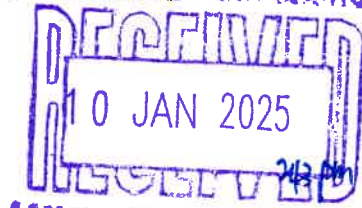



WHEREAS, the Maritime Authority (MARINA) is mandated under Section 12(f) Executive Order No., 125 as amended Executive Order 125-A, to register vessel;

WHEREAS, former president Gloria M. Arroyo signed Executive Order No. 305 dated April 02, 2004, entitled, "Devolving to Municipal and City Government the Registration of Fishing Vessel Three Gross Tonnage and Below" in line with Section 149 (b.3) of Republic Act (R.A) No. 7160 otherwise known as the "Local Government Code of 1991" which provides that the Sangguniang Bayan shall issue license for the operation of fishing vessels three tons or less and Sections 16, 17 and R.A No. 8550 known as "the Philippine Fisheries Code of 1998," which also provides



WHEREFORE, on motion of Honorable Xandrix P. Pantin duly seconded by en masse, be it

Ordained by the Sangguniang Bayan of the Municipality of MacArthur, Leyte that:

Section 1. Section 7 (d) of Municipal Ordinance No. 04, Series of 2012 is read as follows:

d. Local PNP clearance

Section 2. Amendment. Section 7 (d) of Municipal Ordinance No. 04 Series of 2012 shall now amended as follows:

Section 7. Requirements: An applicant for fishing vessel registration shall submit the following requirements for evaluation of the Municipal Agriculture Office.

"xxx"

d. PNP-Maritime Group clearance or Local PNP clearance (if the former is not available).

"xxx"

Section 3. SEPARABILITY CLAUSE. If for any reason, any provision, section or any part of this ordinance is declared invalid by a court of competent jurisdiction or suspended or revoked by the Sangguniang Panlalawigan, such judgment shall not affect or impair the remaining provisions, sections or parts hereof which shall remain and continue to be in full force and effect.

Section 4. REPEALING CLAUSE. All ordinances, rules and regulations or parts thereof in conflict or inconsistent herewith are hereby repealed or modified accordingly.

Section 5. EFFECTIVITY- This ordinance shall take effect after the approval from the Sangguniang Panlalawigan and the requirements of posting prescribed in RA 7160 is complied with.

ENACTED by the Sangguniang Bayan in session assembled on December 2, 2024, at MacArthur, Leyte, Philippines.

ORDINANCE NO. 04
Series of 2012

AN ORDINANCE PROVIDING THE GUIDELINES FOR THE REGISTRATION OF
MUNICIPAL FISHING BOATS/FISHING VESSELS THREE (3) GROSS TONNAGE AND
BELOW IN THE MUNICIPALITY OF MacARTHUR, LEYTE.

Be it enacted by the Sangguniang Bayan of the Municipality of MacArthur, Leyte in its
regular session assembled that:

SECTION 1. TITLE. This ordinance shall be known as, "AN ORDINANCE PROVIDING
THE GUIDELINES FOR THE REGISTRATION OF MUNICIPAL FISHING BOATS/FISHING
VESSELS THREE (3) GROSS TONNAGES AND BELOW IN THE MUNICIPALITY OF
MacARTHUR, LEYTE."

SECTION 2. SCOP. This ordinance shall be applicable to all fishing vessels three (3)
gross tonnages and below owned or operated by the resident of this municipality or if its
principal office of the operator is located in the municipality.

Section 3. DEFINITION OF TERMS. As used in this ordinance, the following terms
and phrases shall mean:

1. Admeasurement - means the measure of the volumetric capacity of the
fishing vessel to determine its gross tonnage.
2. BFAR - Bureau of Fisheries and Aquatic Resources
3. Fishing Vessel - any watercraft used for fishing or in support to fishing
operations in municipal waters weighing three (3) gross tons and below.
4. Gross Tonnage - the product of vessel tonnage length, tonnage depth and
tonnage breadth modified by a factor of 0.70 divided by 2.83.
5. Homeport - refers to the LGU where the fishing vessel is registered.
6. License/Permit to Fish - the privilege to fish in its municipal waters granted to
registered fisherfolk by the LGU.
7. MARINA - Maritime Industry Authority





8. Motorized Fishing Vessel - a fishing vessel propelled by mechanical means.
9. Municipal Waters - include not only streams, lakes, inland bodies of water and tidal waters within the municipality which are not included within the protected areas as defined under RA # 7586, public forest, timber lands, forest reserves, or fishery reserves, but also marine waters included between two (2) lines drawn perpendicular to the general coastline from points where the boundary lines of the municipality touch the sea at low tide and a third line parallel with the general coastline including offshore islands and fifteen (15) kilometers from such coastline. Where two (2) municipalities are so situated on opposite shores that there is less than thirty (30) kilometers of marine waters between them, the third line shall be equally distant from the opposite shore of the respective municipalities.
10. Net Tonnage - The Gross Tonnage modified by a factor 0.32
11. Person - natural or juridical person.
12. PCG - Philippine Coast Guard
13. Registration - an act/process of enlisting a fishing vessel three (3) gross tons and below for the purpose of establishing its identity and ownership by assigning it a permanent number.
14. Registered Breadth - the transverse distance taken at a widest part of the hull, excluding rub rails from the outer board side of the skin on one side of the hull to the outboard side of the skin on the other side of the hull.
15. Registered Depth - the vertical distance taken at or near midships from a line drawn horizontally through the gunwale of the skin of the sides of the hull (excluding the rail) to the outboard face of the bottom skin of the hull, excluding the keel.
16. Registered Length - the horizontal distance between the outboard side of the foremost part of the stem and the outboard side of the aftermost part of the stem, excluding fittings and attachments.
17. Tonnage Length - the length measured at the centerline of the fishing vessel from the point forward where the line of the tonnage deck intersects the line of the inboard faces at the stem to the point aft where the line of the tonnage deck intersects the inboard face of the stem.
18. Tonnage Depth - measured at the centerline from a point below the line of the tonnage deck. Measurement taken at right angle to the vessel centerline of the vessel down to the inboard of the bottom skin of the hull.
19. Tonnage Breadth - measured at the mid-part from the gunwale inside of the skin of the hull to the inside of the skin on the other side of the hull.

Section 4. Registration of Fishing Boats. - No fishing boat, three (3) gross tons or below, shall be allowed to be licensed or be issued with fishing boat license without first registering the said fishing boat to the municipality; or allow transient fisherfolk with appropriate fishing permit to operate within the jurisdiction of the municipality to fish using unregistered fishing boat. Likewise, no vessel of any size or built shall be allowed to operate or be used for any purpose within the jurisdiction of the municipality without first registering the said vessel to appropriate government agency.

Section 5. Application. Application for registration shall be submitted and processed in Municipal Agriculture Office. Application for Municipal Fishing Vessel Registration shall be in proper form (MFVR Form 1)

Section 6. Eligibility to Apply for Vessel Registration. Any person, of Filipino citizenship, single proprietorships, partnerships and / or corporations, duly registered or accredited fisherfolk associations, or cooperatives are eligible to apply for registration.

Section 7. Requirements. An applicant for fishing vessel registration shall submit the following Requirements for evaluation of the Municipal Agriculture Office.

- a. Properly accomplished application form (MFVR Form 1)
- b. Certificate of Inspection or Admeasurements Form (MFVR Form 2)
- c. Two (2) 5R size (4x6) picture of the boat (1 shot side view, full-length and 1 shot with the applicant on the side)
- d. Local PNP clearance
- e. Payment of appropriate fees (inspection fee)

The duly designated admeasuring officer of the municipality shall conduct an inspection of the fishing vessel to determine its gross tonnage using the metric formula. The Inspector or Admeasuring Officer shall certify the correctness of the admeasurements in the standard tonnage measurement form (MFVR Form 2)

Section 8. Issuance of Certificate Number. The municipality shall issue a Certificate Number (MFVR Form 3) once all the documentary requirements are fully complied with and upon payment of the inspection fee. The certificate number shall indicate the official serial number of the boat and its official name. The certificate number shall serve as the proof of ownership of the boat.

Section 9. Assignment of Official Number. The municipality shall assign an official number to a registered fishing vessel which shall correspond to the assigned code of the province (Ley-17) followed by the zip code of the municipality and the serial number (not less than 4 digits. Example: Ley-17-6509-0001) The number shall be painted permanently not less than 4 inches in height, on both sides of the forward portion of the fishing vessel.

Section 10. Assignment of Name. The owner/operator shall propose a name to be assigned to the fishing vessel. The municipality shall ensure that the name shall be assigned only to one (1) fishing vessel regardless of type of fishing gear being used, design or size of the vessel. If the proposed name has already been assigned to another registered vessel, the owner/operator may add letters of the alphabet, any Arabic number or Roman numeral to the proposed name. *The fishing vessel shall be painted yellow while the name of the fishing*

vessel shall be painted red and shall not be less than 4 inches in size on both sides and mid portion of the fishing vessel.

Section 11. Issuance of New Certificate Number (CN). The municipality may issue a new Certificate Number to a fishing vessel registered to another city or municipality if the fishing vessel transfers or changes its homeport to this municipality. A change of homeport may occur if the owner/operator of the said fishing vessel decides to transfer its residence or its principal office to this municipality or a resident of this municipality acquired ownership of a fishing vessel registered to other LGU.

Section 12. Re-Issuance of Certificate Number. In cases where the fishing vessel is already registered in the municipality, re-issuance of Certificate Number shall only be made if:

- a. the fishing vessel changes its ownership through a valid sale or any other legal means;
- b. the fishing vessel changes its engine; or
- c. the fishing vessel change its name.

Section 13. Requirements for Re- Issuance of Certificate Number.

a. Change of Ownership

- (a) Properly accomplished application form (MFVR Form 1)
- (b) Copy of duly notarized deed of absolute sale or any legal instrument for transfer of ownership.
- (c) Affidavit of publication executed by the Barangay Captain or Mayor that a notice had been posted for seven (7) consecutive days in the premises and that there is no opposition filed against the fishing vessel's sale or transfer of ownership.
- (d) Copy of the notice posted in the Barangay Hall or City/Municipal Hall for seven (7) consecutive days that the fishing vessel has been sold or transferred to the new owner.
- (e) Copy of the original Certificate Number.
- (f) MFVR Form 2
- (g) Payment of appropriate fees (inspection fee)

B. Change of Engine

- (a) Properly accomplished application form (MFVR Form 1)
- (b) Copy of the original Certificate Number
- (c) Copy of the official receipt of the engine purchased, and/or
- (d) Police clearance that the engine purchased or used is not from a carnapped/stolen vehicle
- (e) MFVR Form 2
- (f) Payment of appropriate fees (registration and inspection fees)

Section 14. Publication Requirement. - In any of the circumstances enumerated in Section 12 of this ordinance, the owner/operator shall notify the Municipal Agriculture Officer (MAO) and file a request for publication of the said act, by posting a notice in the Barangay Hall or Municipal Hall of this municipality for seven (7) consecutive days upon payment of publication fee.

Section 15. Deletion or Cancellation of Registration. In cases of loss or decay of the fishing vessel, or its involvement in the marine/maritime incident which rendered the fishing vessel unseviceable, the owner/operator shall immediately inform the municipality and formally request for deletion or cancellation of registration of the said fishing vessel.

The municipality may also cancel or delete the registration of any fishing vessel, after due notice for lawful causes to the owner/operator have been served and appropriate due process have been complied with, without prejudice to filing of separate criminal complaint to proper court if found appropriate. Registration of the fishing vessel may be cancelled or deleted due to any of the following reasons.

1. Utilizing the fishing vessel as coastwise commercial passenger vessel.
2. Involvement in any illegal or criminal activities.
3. Failure to renew the vessel's registration for one year.
4. Giving false information in the application form.
5. Continued failure to display the vessel's official number and name in violation of Sections 9 & 10 of this ordinance.

Section 16. Renewal of Vessel's Registration. Registration of all fishing vessels registered to this municipality is subject for renewal every year. Application for registration shall be submitted and processed in the Municipal Agriculture Office (MAO) not later than the last working day of January every year. Applicants for renewal of vessel's registration shall present to the MAO the copy of Certificate Number of the vessel for assessment.

Section 17. Record Keeping and Submission of Reports. The Municipal Agriculture Office shall maintain updated records of all fishing vessels three (3) gross tons and below registered to the municipality including those deleted and/or cancelled; and prepare the appropriate reports to be submitted to the regional office of the MARINA on the first week of April every year, copy furnished the PCG and BFAR.

Section 18. Registration, Inspection and other Charges.

A. Initial/Renewal of Registration and Issuance/Re-issuance of Certificate Number

a. Motorized and Non-motorized Free

B. Inspection and Documentation Fee P100.00

Section 19. Appointment of Admeasuring Officer. The Municipal Mayor, upon the approval of this ordinance shall appoint an Admeasuring Officer, who shall be coming from the existing permanent employee of the municipality, shall be responsible in conducting an orientation seminar for the fishing vessel owners/operators prior to the issuance of Certificate Number. The admeasuring Officer/s shall undergo the necessary training from the MARINA.

Section 20. Penalty. Any person caught operating an unregistered fishing vessel within the jurisdiction of this municipality in violation of Section 4 of this ordinance shall be fined by not more than Two Thousand Five Hundred Pesos (P2,500.00) for motorized vessels, and One Thousand Pesos (P1,000.00) but not less than Five Hundred Pesos (P500.00) for non-motorized vessels. Failure to comply with the provisions in Section 9 and 10 of this Ordinance within 60 days after the issuance of the Certificate Number shall be fined by not more than One Hundred Pesos (P100.00). Provided that the Municipal Mayor is hereby authorized to impose such administrative fines and penalty.

Section 21. Implementation. The Philippine National police (PNP), Maritime Command (MARICOM), Philippine Coast Guard (PCG), Fishery Law Enforcers, Deputized Fish Wardens and all other law enforcement agents authorized by existing laws to enforce fishery law, rules and regulations are hereby empowered to enforce this ordinance.

Section 22. Repealing Clause. Previously approved ordinances or parts thereof, which is in conflict with any provision of this ordinance, are hereby repealed.

Section 23. Transitory Provision. To maximize the response to fishing vessel registration, the Municipal Mayor is hereby authorized to waive the cost of the Inspection and Documentation Fees for all fishing vessels applied within six (6) months upon the effectivity of this ordinance after which, the usual rate of fees as provided in Section 18 shall be applied.

Section 24. Separability Clause. If for any reasons, any part of this ordinance shall be held unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and in effect.

SECTION 25. Effectivity. This ordinance shall take effect following its review and approval of the Sangguniang Panlalawigan.




