

Ordained by the Sangguniang Bayan of the Municipality of MacArthur, Leyte that:

Section 1. Title. This Ordinance shall be known as "Guidelines for the Availment of Assistance to Individuals in Crisis Situation (AICS).

Section 2. Declaration of Policy. It is the policy of the Municipality of MacArthur Leyte to ensure better and improved quality of life for the citizenry. Priority attention shall be given to the poor, vulnerable and marginalized sectors of society.

> a.) Indigent- those individual living below the poverty line bracket as determined by the MSWDO and Punong Barangay.

> b.) Beneficiary- refers to the legal surviving spouse of the decedent, his or her legitimate and/or illegitimate children, parents, brothers or sisters, or to any of his nearest kin, in the order so provided; poor sick person and poor students.

c.) Death- means the cessation of life.

d.) LGU- refers to the Local Government Unit of MacArthur,

e.) Mortuary or Death Aid- refers to the amount given to beneficiary upon the death of an indigent individual.

f.) Monetary Aid- refers to the amount given to individuals in crisis.

Section 4: Monetary Assistance Program

The Municipal Social Welfare Development Office is hereby authorized to establish a Strengthened Monetary Assistance Program to provide financial aid or assistance based on the individuals needs and the available budgetary provisions.

Section 5. Coverage. The beneficiary shall be entitled to receive the following:

Section 6. Application and Processing of Claims.

1. For Mortuary Aid- In the event of death, the beneficiary/ies shall immediately notify the Office of the Municipal Mayor through the MSWDO regarding such circumstance. The MSWDO shall thereafter assist the beneficiary/ies on processing the claim to further ensure expeditious and prompt release of the cash/checks.

To establish the relationship of beneficiary/claimant to the deceased, one (1) copy each of the following documents are to be submitted to the MSWDO:

Indigent Individual:

- a.) Death Certificate duly certified by the Local Civil Registrar
- b.) Sufficient identification and proof of relationship to the claimant and/or beneficiary to the deceased indigent
- c.) Funeral Contract
- d.) Certificate of Indigency

Punong Barangay/Barangay Kagawad/SK Chairman and SK Members/Barangay Secretary/Barangay Treasurer:

- a.) Death Certificate duly certified by the Local Civil Registrar
- b.) Oath of Office
- c.) Certification from the Office of the MLGO
- 2. Monetary Aid for Medical check-up with referrals for laboratory
- a.) Certificate of Indigence from respective Punong Barangay
- b.) Medical Certificate
- c.) Referrals for laboratory
- d.) Valid ID
- 3. For Hospitalization
- a.) Certificate of Indigency
- b.) Prescription
- c.) Clinical Abstract/Medical Certificate
- d.) Biopsy Result (if cancer patient)
- e.) Hospital bill/Quotation
- f.) Valid ID of patient and client
- 4. For Medicine
- a.) Certificate of Indigency from respective Punong Barangay
- b.) Prescription
- c.) Medical Certificate
- d.) Valid ID of patient and client
- 5. Indigent College Students from Private or Public School

Section 7. Requirement. The MSWD office may provide additional requirements if it is needed by COA rules and regulations.

Section 8. Payment. The mortuary aid and monetary aid shall be payable to the beneficiary/ies, in the order of preference as above stated, only after completion of the requirements in the immediately preceding section.

Section 9. Limit of Availment. All qualified individuals can avail the assistance every 6(six) months.

Section 10. Confidentiality. All information provided by the applicants shall be kept confidential in accordance with applicable laws and regulations.

Section 11. Exclusions. The LGU shall not render any mortuary assistance subject of this ordinance to those whose death is caused or resulting from, whether directly or indirectly, wholly or partly:

- a.) Accident while under the influence of prohibited drugs
- b.) While committing or attempting to commit any crime punishable by the Revised Penal Code, Special Penal Laws, or ordinance.

Section 12. Funding. The Municipal Social and Development Office shall allocate funds for the implementation of this Ordinance, in accordance with the COA accounting, auditing rules and regulations.

Section 13. Separability Clause. Should any provision of this Ordinance be declared unconstitutional or illegal by any court of competent jurisdiction, those parts that are not so declared shall remain in full force and effect.

Section 14. Repealing Clause. All laws, rules and regulations inconsistent herewith are hereby likewise repealed or modified accordingly.

Section 15. Effectivity Clause. This ordinance shall take effect upon its approval from the Sangguniang Panlalawigan and the requirement of posting prescribed in RA 7160 is complied with.
