#### MUNICIPAL ORDINANCE NO. 07 Series of 2024

AN ORDINANCE GRANTING DEATH AID/BURIAL ASSISSTANCE TO BARANGAY OFFICIALS WHO DIED DURING THEIR INCUMBENCY

SPONSORED BY

On motion of Honorable Jonathan T. Barquin duly seconded by en masse, be it

Ordained by the Sangguniang Bayan of the Municipality of MacArthur, Leyte that:

SECTION 1. All elected barangay officials who died during their incumbency as barangay official shall receive death aid/burial assistance from the Municipality.

SECTION 2. A Punong Barangay who lost his/her life during his/her incumbency shall be granted an amount of Ten Thousand Pesos (PhP10,000.00) as death aid/burial assistance to be given to the spouse or the son/daughter in the case of the absence or incapacity of the spouse, or to the nearest family member if single.

SECTION 3. A Barangay Kagawad, Sangguniang Kabataan Chairman, Barangay Secretary and Barangay Treasurer who lost his/her life during his/her incumbency shall be granted an amount of Seven Thousand Five Hundred Pesos (PhP7,500.00) as death aid/burial assistance to be given to the spouse or to the son/daughter in the case of the absence of incapacity of the spouse or to the nearest family member if single.

SECTION 4. A Sangguniang Kabataan Member, who lost his/her life during his/her incumbency shall be granted an amount of Five Thousand pesos (5,000.00) as death aid/burial assistance to be given to the spouse or to the son/daughter in the case of the absence of incapacity of the spouse or to the nearest Family member if single.

SECTION 5. Supporting documents must include a Death Certificate, the Oath of Office and Certification from the Municipal Local Government Operations Officer that the official was an incumbent official when he/she died.

SECTION 6. This ordinance shall also cover the barangay officials who substituted the vacancies in the positions by appointment.

SECTION 7. To implement this Ordinance, funds shall be chargeable to the Aid to Individuals in Crisis Situation (AICS) allocation in accordance with the COA accounting, auditing rules and regulations.

SECTION 8. SEPARABILITY CLAUSE. If, for any reason, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected thereby shall continue to be in full force and effect.

SECTION 9. REPEALING CLAUSE. All laws, rules and regulations inconsistent herewith are hereby likewise repealed or modified accordingly.

SECTION 10. EFFECTIVITY. This ordinance shall take effect upon its approval from the Sangguniang Panlalawigan and the requirement of posting prescribed in RA 7160 is complied with.

ENACTED by the Sangguniang Bayan in session assembled on December 9, 2024, at MacArthur, Leyte, Philippines.
