

¹ **Section 336.** Use of Appropriated Funds and Savings. - Funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer of appropriations from one item to another. However, the local chief executive or the presiding officer of the sanggunian concerned may, by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

² (b) Trust Funds shall consist of private and public monies which have officially come into the possession of the local government or of a local government official as trustee, agent or administrator, or which have been received as a guaranty for the fulfillment of some obligation. A trust fund shall only be used for the specific purpose for which it was created or for which it came into the possession of the local government unit.

AN ORDINANCE AUTHORIZING THE LOCAL CHIEF EXECUTIVE HON. ANGELITA M. DELUSA AND THE MUNICIPAL TREASURER MS. PAMELA F. LUMBRE TO TRANSFER OF UNEXPENDED BALANCES OF THE DISASTER RISK REDUCTION AND MANAGEMENT (DRRM) QUICK RESPONSE FUND AND MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) FOR CY 2019 TO 2023, AMOUNTING TO PHP 24,105,077.29, TO THE TRUST FUND BOOKS OF THE MUNICIPALITY OF DAGAMI, LEYTE.

WHEREAS, under Republic Act No. 10121 or the "Disaster Risk Reduction and Management Act of 2010," Local Government Units (LGU) are empowered to effectively manage disaster risks and ensure the safety and resilience of their communities;

WHEREAS, Section 21 of the Act provides guidelines for the use of the Local Disaster Risk Reduction and Management Fund (LDRRMF), emphasizing its importance in disaster preparedness and response;

WHEREAS, the purpose of the LDRRMF, as stated in Section 4.4, is to ensure funding for emergency preparedness, response, and recovery efforts;

WHEREAS, Sections 51.2 to 51.16 detail allocations for various disaster response initiatives, including the procurement of disaster response and rescue equipment, heavy equipment, and other essential resources to enhance local disaster response capabilities;

WHEREAS, the unexpended balances of the DRRM Quick Response Fund and MOOE for the calendar years 2019 to 2023 amounting to Php 24,105,077.29, which are available for transfer to support the municipality's disaster preparedness and response initiatives;

NOW, THEREFORE, be it ordained by the Sangguniang Bayan of Dagami, Leyte, in session assembled:

SECTION 1. The Local Chief Executive Hon. Angelita M. Delusa and the Municipal Treasurer Ms. Pamela F. Lumbre are hereby authorized to transfer the unexpended balances of the DRRM Quick Response Fund and MOOE for the calendar years 2019 to 2023, amounting to Php 24,105,077.29, to the Trust Fund books of the Municipality of Dagami, Leyte.

SECTION 2. The funds shall be utilized in accordance with the provisions of the Local Government Code and the Disaster Risk Reduction and Management Act, specifically for enhancing disaster response capabilities and preparedness within the municipality.

SECTION 3. The implementation of this ordinance shall also adhere to the transitory provisions outlined in Section 61.1 of the Disaster Risk Reduction and Management Act.

SECTION 4. This ordinance shall take effect immediately upon its approval.
