**WHEREAS**, The Local Government Code of 1991 empowers the Local Chief Executive to represent the Local Government Unit in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Bayan or pursuant to the law or ordinance;

**WHEREAS**, after due deliberations by the Sangguniang Bayan Members with considerations on the best interest of its constituents and finding the Contract of Loan advantageous to the Local Government of Tabontabon, the Sangguniang Bayan Members by a majority vote hereby grant authority to the Municipal Mayor to enter into Contract of Loan in the amount of One Hundred Forty-Four Million Six Hundred Thousand Pesos (PHP 144,600,000) and sign all documents in relations thereto;
