





WHEREAS. after due deliberations by the Sangguniang Bayan Members with considerations on the best interest of its constituents and finding the Contract of Loan advantageous to the Local Government of Tabontabon, the Sangguniang Bayan Members by a majority vote hereby grant authority to the Municipal Mayor to enter into Contract of Loan in the amount of One Hundred Forty-Four Million Six Hundred Thousand Pesos (PHP 144,600,000) and sign all documents in relations thereto;

NOWTHEREFORE on motion by Hon. Jerry Gwen L. Conde, duly seconded by Hon. Danilo E. Balias and Hon. Dan Jeric S. Redoña;
