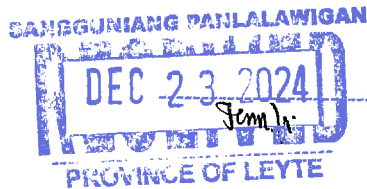

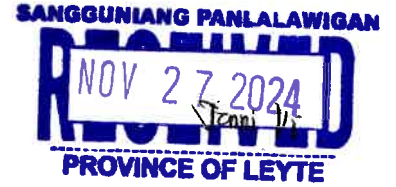

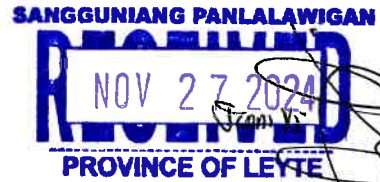

Government Code of 1991 provides that the Sangguniang Bayan as a legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of the Code;

WHEREAS, there is a need to abolish and transfer certain position/s in the different offices of the Municipal Government of Carigara for the ensuing year to maintain compliance of its budgetary limitations for personal services and to meet the required manpower necessary for the delivery of public service;

NOW, THEREFORE, IT WAS ENACTED BY THE SANGGUNIANG BAYAN OF CARIGARA, LEYTE IN A SESSION DULY ASSEMBLED, THAT:

Section 1. **ABOLITION OF POSITION** - The positions to be abolished are as follows:

POSITIONS FOR ABOLITION	OFFICE
Labor and Employment Assistant, SG 8/1	Office of the Mayor
Environmental Management Specialist I, SG 11/1	Municipal Planning & Development's Office
Administrative Aide VI (Clerk III), SG 6/1	Municipal Civil Registrar's Office
Municipal Government Assistant Department Head 1 (Assistant Municipal Treasurer), SG 22/1	Municipal Treasurer's Office
Dentist I, SG 14/1	Municipal Health Office

Section 2. **TRANSFER OF POSITION** - The positions to be transferred from the Sangguniang Bayan Office to the Municipal Health's Office is Administrative Aide III (Driver I), SG 3/1, held by Rene Boyo.

Section 3. **SEPARABILITY CLAUSE** - If any provision of this Ordinance found to be inconsistent with any law, other provisions or part/s thereof not so affected shall remain in full force and effect.

Section 4. **REPEALING CLAUSE** - All Ordinances, Rules and Regulations or part/s thereof, in conflict with, or contrary to, the Provision of this Ordinance not so affected herewith






