RESOLUTION NO. 2024 - 541

A RESOLUTION ADOPTING THE COMPREHENSIVE LAND USE PLAN (CLUP) 2023-2032 AND ENACTING THE ZONING ORDINANCE (Z.O.) 2023-2032 OF THE MUNICIPALITY OF JARO, LEYTE

WHEREAS, Section 447 paragraph 2 (vii) of the Local Government Code known as RA 7160 states that the Sangguniang Bayan shall adopt a Comprehensive Land Use plan for the municipality: Provided, that the formulation, adoption or modification of said plan shall in coordination with the approved provincial comprehensive land use plan;

WHEREAS, Article 41 of the rules and regulations implementing the Local Government Code of 1991 provides that Local Government Units shall, in conformity with existing laws, continue to prepare their respective Comprehensive Land Use Plan which shall be the primary and dominant basis for the future use of land resources;

WHEREAS, submitted to the Sanggunian was the Comprehensive Land Use Plan (CLUP) of the municipality which was formulated in compliance to the mandate of Executive Order No. 72 dated March 25, 1993 and same with the provision of Section 20 (c) of the Republic Act 7160 otherwise known as the Local Government Code;

WHEREAS, the CLUP containing the different sectoral analysis and special studies will be the prime and central basis for future use of local resources, reclassification of lands and guiding tool of the municipality in its pursuit of progress;

WHEREAS, the CLUP was reviewed by the Provincial Land Use Committee (PLUC), and Enacted Resolution NO. 2024-01, Series of 2024, dated October 02, 2024, endorsing the CLUP of the Municipality of Jaro, Leyte to the Sangguniang Panlalawigan for approval/appropriate action, and all the recommendations of PLUC were also integrated in their resolution;

WHEREAS, considering the importance of the Comprehensive Land Use Plan (CLUP) 2023-2032, as one of the vital requirements for the enactment of the Zoning Ordinance (Z.O) 2023-2032, the Honorable Sangguniang Bayan deems it imperative to adopt it;


NOW THEREFORE, on motion presented by Honorable Landilino T. Katangkatang-Chairman Committee on Environmental Protection, and Honorable Vianca Mae N. Familiar-Chairman Committee on Housing, Land Use and Utilization, duly seconded en masse by the Honorable Members present, this Sangguniang Bayan-

BE IT RESOLVED by the Sangguniang Bayan of Jaro, to adopt as it is hereby adopted the Comprehensive Land Use Plan (CLUP) 2023-2032 and enacting the Zoning Ordinance (Z.O.) 2023-2032 of the Municipality of Jaro;

RESOLVED FINALLY, to furnish copy of this resolution, the Municipal Mayor, the Honorable Sangguniang Panlalawigan, this province, for review and approval and the MPDC, this municipality for their information.

RESOLUTION NO. 2024-537

A RESOLUTION APPROVING MUNICIPAL ORDINANCE NOS. 24-15, AND 24-22, BOTH SERIES OF 2024 OF BURAUEN, LEYTE, MUNICIPAL ORDINANCE NO. 09 SERIES OF 2024 OF DAGAMI, LEYTE, ORDINANCE NO. 24 SERIES OF 2024 OF JARO, LEYTE.

WHEREAS, pursuant to Section 468 (a)(1)(i) of Republic Act 7160 otherwise known as The Local Government Code of 1991, among the powers and duties of the Sangguniang Panlalawigan is "to review all ordinances approved by the Sanggunian of component cities and municipalities;"

WHEREAS, submitted to the Sangguniang Panlalawigan are Ordinances from Burauen, Leyte, Dagami, Leyte and Jaro, Leyte, for approval, to wit:

- 1. Municipal Ordinance No. 24-15 series of 2024 of Burauen, Leyte entitled: "AN ORDINANCE INSTITUTIONALIZING KATUWANG SA DIWA AT GAWA SA MASAGANANG ANI AT MATAAS NA KITA (KADIWA) NG PANGULO (KNP) IN THE MUNICIPALITY OF BURAUEN, LEYTE AND WITH INTEGRATION OF THE ONE-CROP-ONE BARANGAY PROGRAM";**
- 2. Municipal Ordinance No. 24-22 series of 2024 of Burauen, Leyte entitled: "AN ORDINANCE CREATING THREE (3) MANDATORY PLANTILLA POSITIONS AND ONE (1) MUNICIPAL OFFICE, IN THE MUNICIPAL GOVERNMENT OF BURAUEN, LEYTE AND APPROPRIATING FUNDS THEREOF";**
- 3. Municipal Ordinance No. 09 series of 2024 of Dagami, Leyte entitled: "AN ORDINANCE ESTABLISHING AND MAINTAINING THE MIGRANT ADVISORY AND INFORMATION NETWORK (MAIN) DESK IN THE MUNICIPALITY OF DAGAMI, LEYTE";**
- 4. Ordinance No. 24, Series of 2024 of Jaro, Leyte, entitled: "The 2024 Revised Tax Code of the Municipality of Jaro, Leyte";**

WHEREAS, the Provincial Legal Office was requested to review and submit recommendation on the subject Ordinances pursuant to Section 481 (3) (vii) of R.A. 7160;

WHEREAS, the Provincial Legal Office through Atty. Jose Raymund A. Acol, Assistant Provincial Legal Officer, recommended for the declaration of its validity of the subject ordinances, to wit:

1. **Municipal Ordinance No. 24-15 series of 2024 of Burauen, Leyte**, is generally in accordance to its power under Section 17 (b)(2)(i) and Section 447 (5)(iv) of the Local Government Code of 1991 (RA 7160) in relation to DILG Memorandum Circular No. 2024-003;
2. **Municipal Ordinance No. 24-22 series of 2024 of Burauen, Leyte**, is generally in accordance with its power under Section 447 (1)(viii) of the Local Government Code of 1991 (RA 7160) in consonance with Section 76;
3. **Municipal Ordinance No. 09 series of 2024 of Dagami, Leyte**, is generally in accordance with its power under Section 447 (a) of the Local Government Code of 1991 (RA 7160) in consonance with Republic Act No. 11862;
4. **Ordinance No. 24, Series of 2024 of Jaro, Leyte**, is in accordance to its power under Section 16 General Welfare Clause, Section 132 and Section 191 of the Local Government Code of 1991 (RA 7160);

Likewise, as settled in the case of Constantino v. Desierto 288 SCRA 654, it is within the power of the local council to repeal or amend its prior acts either expressly, or by the passage of an essentially inconsistent resolutions;

WHEREAS, the August Body, upon review, finds the subject Ordinances in conformity with the existing laws, rules and regulations;

NOW, THEREFORE, on omnibus motion presented by Honorable Trinidad G. Apostol, duly seconded by Atty. Carlo P. Loreto, Honorable Raissa J. Villasin, and MJ Luinly D. Lumen, be it

RESOLVED, as it is hereby resolved, to **APPROVE APPROVING MUNICIPAL ORDINANCE NO. 24-15, AND 24-22, BOTH SERIES OF 2024 OF BURAUEN, LEYTE, MUNICIPAL ORDINANCE NO. 09 SERIES OF 2024 OF DAGAMI, LEYTE, ORDINANCE NO. 24 SERIES OF 2024 OF JARO, LEYTE.**
