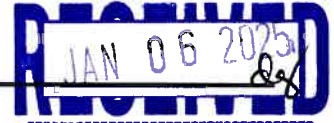

Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 3 CY 2024** of the City of Baybay, Province of Leyte duly enacted by the Sangguniang Panlungsod through **Appropriation Ordinance No. 4, S. 2024** with a total appropriation in the amount of P36,123,067.51, reveals compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

1. That the appropriation for Uniform/Clothing Allowance for the grant of increase to each qualified government personnel shall be subject to Budget Circular No. 2024-1 dated April 4, 2024;
2. That the appropriation for the 5% Local Disaster Risk Reduction and Management Fund shall contain the listing of the 30% Quick Response Fund and the PPAs for the 70% fund disaggregated into the (4) thematic areas;
3. That the procurement of Goods, Supplies, Civil Works and related services shall be made in accordance with the provisions of RA 9184 and its Implementing Rules and Regulations; and
4. That disbursement of funds shall be for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

Compliance with DBM issuances, accounting and auditing rules and regulations and all other existing laws shall be the responsibility of the implementing Local Government Unit.



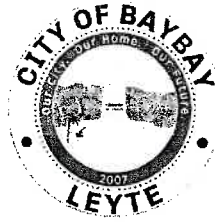

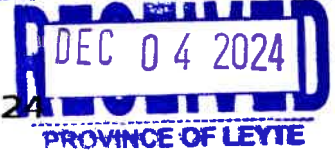

AN ORDINANCE APPROVING AND ADOPTING THE SUPPLEMENTAL BUDGET NO. 3 FOR CY 2024 OF THE CITY OF BAYBAY IN THE AMOUNT OF THIRTY SIX MILLION ONE HUNDRED TWENTY THREE THOUSAND SIXTY SEVEN PESOS AND 51/100 (P36,123,067.51).

WHEREAS, the Local Chief Executive, Honorable City Mayor Carlos L. Cari submitted the Supplemental Budget No. 3, for CY 2024 of the City of Baybay in the amount of Thirty Six Million One Hundred Twenty Three Thousand Sixty Seven Pesos and 51/100 (P36,123,067.51) to this Honorable Sangguniang for perusal and financial examination;

WHEREAS, after careful study and review, the members of this august body declared the aforementioned budget to be in accordance with existing laws, rules and regulations.

WHEREFORE, on motion of Honorable Dominic Junie F. Murillo and duly seconded by Honorable Filemon F. Avila;

BE IT ORDAINED by the 6th Sangguniang Panlungsod in its 44th Regular Session on November 20, 2024, at Baybay City, Leyte, that an Appropriation Ordinance is hereby adopted, to wit:

Section 1. TITLE - This Ordinance shall be known as "AN ORDINANCE APPROVING AND ADOPTING THE SUPPLEMENTAL BUDGET NO. 3 FOR CY 2024 OF THE CITY OF BAYBAY IN THE AMOUNT OF THIRTY SIX MILLION ONE HUNDRED TWENTY THREE THOUSAND SIXTY SEVEN PESOS AND 51/100 (P36,123,067.51)."

Section 2. APPROPRIATION - It is hereby appropriated the sum of Thirty Six Million One Hundred Twenty Three Thousand Sixty Seven Pesos and 51/100 (P36,123,067.51) and declared for Supplemental Budget from the City General Fund.
