¹ (a) The sangguniang bayan, as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the municipality as provided for under Section 22 of this Code, and shall:

⁽¹⁾ Approve ordinances and pass resolutions necessary for an efficient and effective municipal government, (iv) Adopt measures to protect the inhabitants of the municipality from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events;

MUNICIPAL ORDINANCE NO. 04 Series of 2024

AN ORDINANCE PROVIDING FOR PRE-EMPTIVE AND FORCED EVACUATION IN CASE OF DISASTER OR EMERGENCY IN THE MUNICIPALITY OR ANY PART THEREOF WHEN LOSS OF LIVES AND PROPERTIES BECOME IMMINENT.

SECTION 1. TITLE. This ordinance shall be known and cited as the MATALOM PRE-EMPTIVE AND FORCED EVACUATION ACT OF 2024.

SECTION 2. DECLARATION OF POLICY. It is hereby the declared policy of the Municipal Government to implement pre-emptive evacuation of affected inhabitants in case of disaster or emergency in the municipality or any part thereof when loss of lives and destruction or damage to properties become imminent and forced evacuation of affected inhabitants upon the declaration of disaster or emergency in the province or any part thereof when loss of lives and destruction of damage to properties become imminent.

SECTION 3. DEFINITION OF TERMS. The following terms are defined and understood as follows:

- 3.1 DISASTER The result of natural or human-induced event which causes massive injuries and loss of lives to persons and damage or destruction to properties in the municipality or any part thereof.
- 3.2 EMERGENCY sudden state of danger requiring prompt and appropriate action.
- 3.3 FORCED EVACUATION an evacuation ordered by the concerned authorities upon the declaration of disaster or emergency in the municipality or any part thereof when loss of lives and damage or destruction to properties become imminent.
- 3.4 PRE-EMPTIVE EVACUATION a proactive process of relocating inhabitants to safer ground or shelter from the areas that are forecasted or expected to be affected by a potential disaster or emergency situation.

SECTION 4. PRE-EMPTIVE EVACUATION. The Municipal Government and all local chief executives as well as authorities concerned of the component local government units shall implement the pre-emptive evacuation to safer grounds or shelters of affected inhabitants even before the declaration of disaster or emergency in the municipality or in any part thereof when loss of lives and damage or destruction to properties become imminent.

SECTION 5. FORCED EVACUATION. Upon declaration of disaster or emergency, the Local Chief Executive shall issue an Executive Order enforcing the forced evacuation.

SECTION 6. IMPLEMENTING RULES AND REGULATIONS. The Office of the Municipal Disaster Risk Reduction Management shall promulgate the implementing rules and regulations (IRR) of this ordinance in the enforcement thereof especially on the mode or

modes of carrying pre-emptive and forced evacuations and in the observance of calamity response protocols as well as after-calamity response protocols.

SECTION 7. SEPARABILITY CLAUSE. If any provision of this ordinance is declared unconstitutional then the other provisions not otherwise affected shall remain in full force and effect.

SECTION 8. AMENDING, MODIFYING, AND / OR REPEALING CLAUSE. Any ordinance, executive order and rules and regulations inconsistent herewith are hereby deemed amended, modified or repealed accordingly.

SECTION 9. EFFECTIVITY CLAUSE. This ordinance shall become effective in accordance with law.
