



#### Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 01 FY 2024** of the **Municipality of Merida**, **Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 02 Series of 2024** with a total appropriation in the amount of **P8,500,000.00** reveals compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

- That the grant of the following allowances/benefits from May to December FY 2024 shall be made pursuant to the corresponding guidelines relative to:
  - 1.1 PERA Circular No. 2009-3

  - 1.3 Subsistence & Laundry Allowance RA 7305 and AO No. 170
  - 1.4 Mid-Year Bonus Budget Circular No. 2017-2
  - 1.5 Year-End Bonus and Cash Gift Budget Circular No. 2016-4
  - 1.6 Productivity Enhancement Incentive Budget Circular No. 2017-4
  - 1.7 Hazard Pay Establishment of this benefit/incentive shall be based on the conditions enumerated under the Magna Carta for Public Health.
- 2. That the grant of Monetization of Leave Credits shall be subject to CSC Guidelines and Budget Circular No. 2016-2;
- That the procurement of Goods, Supplies, Equipment, Civil Works and related services shall be made pursuant to RA 9184 and its Implementing Rules and Regulations;
- 4. That disbursement of funds shall be for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.
- 5. The local officials is hereby reminded to observe and comply Section 56 in relation to Section 327 of the Local Government Code, on the forwarding of the approved Municipal Ordinances and Resolutions for review.

It is understood that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

Compliance with CSC rules, DBM issuances and accounting and auditing rules and regulations shall be the responsibility of the implementing Local Government Unit.
