104 to be made available for re-appropriation to fund the subject Supplemental Budget so
105 therefore, I would like to pass a resolution approving the reversion to the unappropriate
106 balance of the general fund in the total amount of One Hundred Eighteen Million Nine
107 Hundred Thirty Five Thousand Pesos from the following accounts to wit. PS Savings of
108 funded vacant positions from January to September 2023 in the amount of
109 Php53,935,000.00 and from MOOE savings from January to October CY 2024 in the amount
110 of Php65,000,000.00 and be made available to provide funding requirements under
111 Supplemental Budget No. 6 of the Provincial Government of Leyte, for the Grant of CAN
112 Incentive, Service Recognition Incentive to the Officers and Employees of the Provincial
113 Government of Leyte. I so mo
