COMMITTEE REPORT NO. 5 s 2025

This refers to the proposed Municipal Ordinance entitled "AN ORDINANCE REGULATING THE GAME MAJHONG IN THE MUNICIPALITY OF MATAG-OB, LEYTE."

Pursuant to Sec. 56 (c) of the Local Government Code of 1991, the Sangguniang Panlalawigan has the power to review ordinances submitted to it by component cities and municipalities and declare the same invalid in whole or in part, if the Sangguniang Panlalawigan finds that such ordinance is beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned.

On whether an ordinance is valid or not, such is guided by the following tests:

- 1. Constitutional: It doesn't violate the Constitution or any statute.
- 2. Fair: It's not unfair, oppressive, or discriminatory.
- 3. Trade: It doesn't prohibit trade, but may regulate it.
- 4. Public policy: It's consistent with public policy.
- 5. Reasonableness: It's not unreasonable.
- 6. Corporate powers: It's within the corporate powers of the local government unit to enact it.
- 7. **Procedure**: It's passed according to the procedure prescribed by law.

The Committee, in studying the proposed ordinance, finds no provision in the said measure which contravenes the Constitution and other existing laws. The same is within the corporate powers vested upon the Local Government Units and it is likewise consistent to public policy having been enacted pursuant to a national law. It has been enacted according to procedure prescribed by law and has undergone public consultation, evidenced by the minutes of the public hearing conducted for the said purpose.

In relation to the tests of fairness and reasonableness, the Committee opines that the said ordinance has likewise passed both tests.

As discussed in several forums, a "test of fairness" refers to a legal provision within a local law that assesses whether a particular policy, practice, or decision is considered fair and equitable, often with a focus on

preventing discriminatory impacts against specific groups based on factors like race, gender, or disability; essentially, it's a mechanism to review actions and ensure they don't unfairly disadvantage certain individuals or demographics. On the other hand, a "test of reasonableness" when applied to a local policy means evaluating whether the policy, considering all relevant factors and circumstances, is considered fair, logical, and not excessively burdensome, essentially asking if a reasonable person would agree with the policy's implementation and objectives within the context of the local community. Clearly, there is no provision which can be considered discriminatory in the ordinance based on the test of fairness and certainly there is no provision likewise which can be considered excessively burdensome based on the test of reasonableness.

In view thereof, the Committee hereby recommends the approval of the ordinance on review, reiterating however compliance of the publication requirement as stated in SP Resolution No. 2025-012. The Committee would like to stress that the proposed ordinance is a penal law which requires the same to be published pursuant to the provisions of the Local Government Code of 1991. An ordinance is considered a penal law when it establishes a prohibition against a specific action and includes a penalty for violating that prohibition, essentially defining a crime at the local level and outlining the punishment for committing it, meaning it not only regulates conduct but also has the power to punish offenders through fines or other sanctions. The submission of the minutes and other documents relative to the public hearing conducted is noted



The Honorable Artemio T. Almoroto then proceeded to present the provisions of the above-mentioned proposed municipal ordinance. The foregoing discussion transpired:

Hon. Nestor D. Cabataña: How about those that are peddling chicken? Are they not covered by this proposed ordinance? He added to expound that he raised this question because chicken can also carry viruses that may affect our poultry industry.

Chair: The poultry raisers have specific contract with a specific company.

Eugene Gonzales: The poultry raisers are operating under contract, hence, they also have their own dressing plants.

Hon. Rosalina Erasmo: Raised some clarifications on the One Hundred (100.00) Peso per head fee for sold livestock.

Eugene Gonzales: Payment of fees will be paid by livestock raisers and dealers will be paid upon completion of sales.

Hon. Rosalina Erasmo: This will be income generating for the barangay.

Hon. Rodrigo Demeterio: Hon. Demeterio asked if the local buyers/dealers are also covered by this ordinance?

Chair: Yes they must comply with the provisions of this ordinance. No more sales will be allowed outside of the Municipal Livestock Auction Market.

This ordinance was formulated to ensure that all livestock raisers in the municipality will be protected from scrupulous dealers/buyers who use defective and tampered weighing scales.

She was then informed by the Honorable Joel N. Denoy that there is an existing ordinance regulating the operation of billiard pool halls.

Hon. Rosalina Erasmo: Asked if the collection of fees both for the Barangay and the Municipal Government?

Hon. Denoy: The permit will be issued by the Municipal Government, while the barangay will be able to charge fees for barangay certification.

Hon. Nestor Cabataña: There should be time limit for the playing of mahjong provided in the ordinance which should be until 10PM only.

Hon. Rodrigo Demeterio: This may be the time limit for playing mahiong on week days which is Monday to Friday. No time limit should be imposed on weekends.

Hon. Denoy: We will present this particular proposal in the plenary for second reading.

Hon. Rosalina Erasmo: How about playing cards:

Hon. Denoy: Playing cards is strictly not allowed by virtue of a national law prohibiting illegal gambling. In playing mahjong, betting is not allowed because by principle it is a game of leisure.

Hon. Rosalina Erasmo: Are Barangay Officials allowed to play mahjong?

Hon. Denoy: No one is prohibited to play mahjong, except minors and students. Provided further that no betting is not allowed during playing of mahiong.

Hon. Viacrusis: The Sangguniang Bayan may consider the provision that no observers shall be allowed during playing of mahjong.







Be it ORDAINED, by the Sangguniang Bayan of Matag-ob, Leyte, in regular session assembled that:

SECTION 1. Definition of Terms.- The following terms when used in this ordinance, shall have the meanings respectively ascribed to them in this section, thus:

- a. MAHJONG a Chinese game for (4) players played with 144 decorated pieces called tiles; by discarding and drawing tiles each player attempts to obtain (4) sets of (3) tiles each together with one pair;
- b. PERMITTEE one permit per residential house only regardless of how many households are living in the residence.

SECTION 2. MAHJONG AREA. – there shall be established/assigned a specific mahjong area within the his/her premises/household wherein the game is conducted. The mahjong area shall be exclusively designed/designated area for playing mahjong and equipped with a comfort room for proper sanitation.

SECTION 3. MAHJONG GAME TIME. Mahjong Game shall be allowed within the following hours of play:

During Ordinary days – 10AM to 10PM; Holidays and Weekends – whole day

SECTION 4. TERMS AND CONDITIONS. The following terms and conditions shall be strictly observed by Mahjong Permittee:

4.1 Only one set of mahjong table shall be allowed for every permit holder.

4.2 The Permittee shall ensure that no betting/gambling is allowed during any mahjong game and that his/her place will not be made a gambling den.

4.3 The Permittee shall provide mahjong chips to be used by the players during a mahjong game.

4.4 Mahjong game shall not be played in open public but only in a private place not visible to the general public

4.5 An inspection shall be conducted by the Inspection Team prior to issuance of a Permit to Operate.

SECTION 5. PERMIT FEE. The permit fee in the amount of Two Thousand (P2,000.00) Pesos per table per annum shall be collected from the Permittee. The First issuance shall be on the date that the permit is secured, provided however, that the next issuance of permit shall be renewed on or before January 20 of every year.

No person shall own, maintain or operate any Mahjong game in which persons are permitted to play without first having obtained a permit.

The permit shall not be transferrable. Only residents of a certain barangay may apply for a mahjong operation permit in their respective barangay.

SECTION 6. PUBLIC DISTURBANCE. The Permittee shall ensure that the operation of

SECTION 7. PROHIBITIONS — the following prohibitions shall be observed during

7.1. No students and minors shall be allowed to play, view or observe during playing of mahjong at any time.

7.2. Strictly no smoking shall be allowed during any mahjong game.

SECTION 8. EXEMPTIONS. The playing of mahjong during wake shall be exempt from the enforcement of this ordinance. It shall be the responsibility of the bereaved family to ensure that no game shall be allowed while novena/mass is on-going.

SECTION 9. PENAL PROVISIONS. - Any person/s found violating any provision of this

- a. FIRST OFFENSE a fine of One Thousand pesos (P1,000.00);
- b. SECOND OFFENSE a fine of Two Thousand pesos (Php2,000.00);
- c. THIRD OFFENSE a fine of Two Thousand Five Hundred Pesos (P2,500.00), and cancellation of permit and perpetual disqualification to apply for a mahjong permit.

SECTION 10. ENFORCING OFFICERS

The PNP, in coordination with the Barangay Officials and Barangay Tanods are directed to strictly enforce this ordinance.

SECTION 12. DUTIES AND FUNCTIONS OF THE INSPECTION TEAM. The following shall be the duties and functions of the Inspection Team created for the purpose of implementing this ordinance:

12.1 Conduct inspection of the mahjong room/area;

12.2. Ensure that provisions stipulated in Section 2 of this ordinance are strictly followed.

12.3. Shall issue a Certificate of Compliance in pursuant to Section 2 of this ordinance.

SECTION 13. SEPARABILITY CLAUSE

If for whatever reason any section or provision of this Ordinance is declared illegal or unconstitutional, other section/s and/or provision hereof which are not affected shall continue to be in full force and effect.

SECTION 14. REPEALING CLAUSE.

All ordinances, resolutions, or executive orders not consistent with this Ordinance are hereby repealed and/or modified accordingly.

SECTION 15. AMENDMENT CLAUSE. This ordinance may be amended or modified as necessary through the appropriate legislative process.


