RESOLUTION SUPPORTING RESOLUTION NO. 667 OF THE SANGGUNIANG PANLALAWIGAN OF DAVAO DEL NORTE, REQUESTING THE **DEPARTMENT** OF BUDGET MANAGEMENT (DBM) THROUGH SECRETARY AMENAH F. PANGANDAMAN TO RECONSIDER A CERTAIN PROVISION ENSHRINED IN DBM LOCAL CIRCULAR NO. 160 BY CHANGING THE RETROACTIVE EFFECT OF THE SALARY INCREASE OF LOCAL GOVERNMENT UNIT OFFICIALS AND EMPLOYEES FROM AUGUST 02, 2024 TO JANUARY 1, 2024.

Presented for consideration of the Body was Resolution No. 667 of the Sangguniang Panlalawigan of Davao del Norte which requests the Department of Budget and Management (DBM) through Secretary Amenah F. Pangandaman to reconsider a certain provision enshrined in DBM Local Circular No. 160 by changing the retroactive effect of the salary increase of Local Government Unit officials and employees from August 02, 2024 to January 1, 2024.

WHEREAS, the Department of Budget and Management issued Local Circular No. 160 providing the guidelines, rules, and regulations for the implementation of the First Tranche of the updated Salary Schedule for Civilian Personnel stipulated under Executive Order No. 64, series of 2024;

WHEREAS, the said Circular specifies that:

"The implementation by the LGU of the First Tranche of the Updated Salary Schedule shall be effective not earlier than August 2, 2024, pursuant to Section 325(g) of Republic Act No. 7160, which states that salary increases or adjustments shall in no case be made retroactive."

WHEREAS, the 1987 Constitution, particularly Article IX, B, Section 5 therein stipulates that:

"The Congress shall provide for the standardization of compensation of government officials and employees, including those in government-owned or controlled corporations with original charters, taking into account the nature of the responsibilities pertaining to, and the qualifications required for their positions."

WHEREAS, Republic Act No. 11466, otherwise known as the Salary Standardization Law of 2019 provides that:

"Section 2. Statement of Policy. It is hereby declared the policy of the State to provide all government personnel a just and equitable compensation in accordance with the principle of equal pay for work of equal value. In pursuing this policy, the State shall ensure that:

xxx

(b) The compensation for all civilian government personnel shall be standardized and rationalized across all government agencies to create an enabling environment that will promote social justice, integrity, efficiency, productivity, accountability and excellence in the civil service.

XXX

Section 3. Coverage. This Act shall apply to all civilian government personnel in the Executive, Legislative and Judicial Branches, Constitutional Commissions and other Constitutional Offices, Government-Owned or Controlled Corporations (GOCCs) not covered by Republic Act No. 10149, and local government units (LGUs). This shall cover government personnel whether regular, contractual or casual, appointive or elective; and on full-time or part-time basis."

WHEREAS, this Body deemed it fair and just that Local Government Unit officials and employees shall receive the benefit of the salary increase retroactively, effective January 01, 2024;

WHEREFORE, the Sangguniang Panlalawigan, on motion of Honorable Cerebo, seconded by Honorable Antao

RESOLVED, as it hereby resolves, to support, as it hereby supports, Resolution No. 667 of the Sangguniang Panlalawigan of Davao del Norte, requesting the Department of Budget and Management (DBM) through Secretary Amenah F. Pangandaman to reconsider a certain
