

WHEREAS, section 76 of RA 7160 states that every LGU shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission (CSC);

WHEREAS, the Local Chief Executive recommended to this August Body for a creation of positions and abolition of some vacant positions;

WHEREAS, section 5.2 of NDRRMC, DILG, DBM and CSC Joint Memorandum Circular No. 2014-01 dated on April 04, 2014 states that LDRRMO shall be initially composed of a Local DRRM Officer to be assisted by three (3) staff responsible for: 1.) Administration and Training; 2.) Research and Planning; 3.) Operations and Warning;

WHEREAS, in compliance with the said circular, some unfilled positions of organization structure and staffing pattern shall be abolished so that the budget of said positions be utilized for newly created mandatory positions subject to PS limitations;

RESOLVED as it is hereby RESOLVED to enact the following;

BE IT ORDAINED by the Sangguniang Bayan of Inopacan, Leyte that;

SECTION 1. The following positions are hereby abolished as follows:

Local DRRM Officer I, SG 11	Office of the Mayor
Admin Aide IV (Driver II), SG 4	Office of the Mayor

SECTION 2. Two (2) positions of Local DRRM Assistant with Salary Grade 8 under the Office of the Mayor are hereby created.

SECTION 3. For all intents and purposes the amended organizational structure and staffing pattern is hereto attached and made as integral part of this Ordinance.

SECTION 4. Repealing Clause. All ordinances, resolutions, orders, and/or rules and regulations inconsistent herewith are hereby repealed and modified accordingly.

SECTION 5. Separability Clause. If any section or provision of this Ordinance is declared void or unconstitutional, the remaining section or provision thereof shall not be affected by such declaration.

SECTION 6. Effectivity Clause. This Ordinance shall take effect immediately upon its approval.
