

AN ORDINANCE CREATING THE OFFICIAL WEBSITE OF THE LGU OF TANAUAN, LEYTE FOR THE MODERNIZATION OF INFORMATION AND ACCESSIBILTY OF ALL PUBLIC INFORMATION ONLINE PROVIDING FUNDS THEREFOR, AND PRESCRIBING PENALTIES THEREOF.

BE IT ENACTED BY THE SANGGUNIANG BAYAN OF TANAUAN, LEYTE IN REGULAR SESSION ASSEMBLED THAT:

WHEREAS, the Local Government Code of 1991 (Republic Act No. 7160) mandates that Local Government Units (LGUs) promote transparency, accountability, and citizen participation in governance;

WHEREAS, the use of technology and the internet has become an essential tool in modernizing public services and making government information easily accessible to the public;

WHEREAS, the Local Government of Tanauan, Leyte, recognizes the need to modernize its governance practices by enhancing the dissemination of information through digital platforms;

WHEREAS, one of the primary objectives of the Local Government of Tanauan, Leyte is to bring governance closer to the people by providing accessible information and government forms thereby enhancing transparency and fostering greater public participation;

WHEREAS, the creation of an official municipal website will serve as a platform for timely and accurate information dissemination to the constituents of the municipality, thereby promoting transparency, public participation, and accessibility;

WHEREAS, creating an official LGU website will ensure that public information, including ordinances, resolutions, public notices, financial reports, and municipal services, is available to the constituents in a timely and efficient manner;

WHEREAS, there is a need to provide the necessary funds for the development, maintenance, and security of the LGU website, and to ensure accountability among LGU officers and employees in its implementation;

WHEREAS, the Municipality of Tanauan, Leyte, is committed to promoting environmental conservation and reducing its carbon footprint through innovative measures, recognizing that the dissemination of information through digital platforms significantly reduces the reliance on paper and contributes to sustainability efforts;

NOW, THEREFORE, be it ordained by the Sangguniang Bayan of the Municipality of Tanauan, Leyte in session duly assembled:

SECTION 1. Title.

This ordinance shall be known as the "Ordinance Establishing Official website of the LGU of Tanauan, Leyte for Public Access to LGU Information."

SECTION 2. Objectives.

The primary objectives of this ordinance are:

- 1. To modernize the information systems of the LGU by providing an online platform for the publication of all public records and relevant information.
- 2. To ensure the transparency of LGU operations by making public information accessible to constituents online.
- 3. To promote efficiency in public service delivery by providing online access to municipal services, downloadable forms, and other resources.
- 4. To provide mechanisms for public feedback and participation through the LGU website.

SECTION 3. Creation of the Official LGU Website.

The Municipality of Tanauan, Leyte, shall create and maintain an official municipal website that shall be accessible to the public which will serve as the central platform for the publication and dissemination of all public information, including:

- 1. Executive Orders and Municipal Programs Executive orders, public announcements, and updates on local government projects, and any other information from the Executive Department that requires dissemination.
- 2. Legislative Information All ordinances, resolutions, and minutes of the Sanggupiang Bayan sessions, and any other information from the Legislative Department that requires dissemination.

- 3. Public Financial Records Budgets, financial reports, procurement notices, and other financial documents.
- 4. Public Services Guidelines for public services, downloadable forms, requirements for applications, and other related services.
- 5. Public Notices Information regarding public biddings, job vacancies, municipal programs, and events.
- 6. Citizen Feedback A section for constituents to submit inquiries, complaints, suggestions, and feedback on public services.

SECTION 4. The official website shall contain as a minimum (not limited to), the following:

- 1. The official municipal seal of Tanauan, Leyte shall be prominently displayed on the homepage.
- 2. The ordinance number of this ordinance and a copy of the ordinance and any amendments thereto should be included in the website's "About" section.
- 3. News and announcements from the local government.
- 4. Executive Department Section
- 5. Sangguniang Bayan Section
- 6. Other Departments/Offices
- 7. Information on municipal services, programs, and projects.
- 8. Contact details of government offices and officials.
- 9. Calendar of events, public holidays, and other important notices.
- 10. Public consultations and community engagement platforms.
- 11. Disaster and emergency information and resources.
- 12. Others, as required by the Municipal Mayor

SECTION 5. Responsibilities of the Municipal Information Officer.

The Municipal Information Officer shall be responsible for ensuring that all information is accurate, up-to-date, and that the website remains functional and accessible to the public.

If no existing position within the municipal government can handle this function, the Municipal Mayor shall appoint a personnel who will perform the functions stated herein.

The Municipal Information Officer (or in the absence thereof, a designated personnel appointed by the Municipal Mayor) shall have the following functions:

- 1. Overseeing the design, development, and regular maintenance of the LGU website.
- 2/ Ensuring that all relevant information and documents are uploaded to the website in a timely manner.
 - Ensuring that all information is accurate, up-to-date, and that the website functional and accessible to the public.
- 4. Coordinating with all LGU departments to gather information for publication.
- ≥5. Responding to public inquiries and feedback submitted through the website.
- 6. Ensuring that the website complies with data privacy standards and maintains secure access to sensitive information.

SECTION 6. Time Frame for Website Establishment.

The LGU website must be fully operational within six (6) months from the effectivity of this ordinance.

SECTION 7. Regular Updating of Website Content.

All LGU offices and departments (via Heads of Departments) must submit updates on their respective functions, public records, and services to the Municipal Information Officer not later than forty-eight (48) hours after any significant changes, approvals, or new issuances. Information must be updated on the website accordingly.

SECTION 8. Budget Allocation.

The necessary funds for the establishment, maintenance, and operation of the LGU website shall be included in the annual budget of the municipality, with the following provisions:

- Initial Funding A budget shall be determined by the Executive Department for the development, design, and initial operation of the website, subject to the approval of the Sangguniang Bayan. Should additional funding be required, the Executive Department shall determine the proposed budget for such needs, which will be subject to the approval of the Sangguniang Bayan.
- 2. Annual Maintenance and Operation An annual allocation for website maintenance, hosting, security, and updates shall be included in the LGU's budget.
- 3. Capacity Building Funds for training LGU personnel on website management and digital information handling may be allocated as necessary.

SECTION 9. Data Privacy and Security.

The LGU shall ensure that the website adheres to the provisions of Republic Act No. 10173, and/or the Data Privacy Act of 2012, Municipal Ordinance No. 2017-01 known as the "Freedom of Information Ordinance" and any other statutes protecting personal information from unauthorized access and misuse.

The website shall employ security measures such as encryption, secure passwords, and regular audits to protect against cyber threats and data breaches.

SECTION 10. Penalties for Non-Compliance.

- 1. Failure to Publish Information and Maintain the Website The Municipal Information Officer or any designated LGU employee who fails to comply with the provisions of this ordinance, particularly in terms of uploading relevant public information and maintain the website functional, secure, and up to date shall be subject to the following penalties:
 - a. First Offense: Written warning.
 - b. Second Offense: Suspension of one (1) week without pay.
 - c. Third Offense: Suspension of one (1) month without pay.
 - d. Subsequent Offenses: Administrative sanctions in accordance with the Civil Service Rules and Regulations.

All penalties shall follow due process as provided by the Civil Service Rules and other applicable laws, to safeguard fairness and justice and ensure that the rights of the concerned personnel are well protected.

SECTION 11. Monitoring and Evaluation.

The Sangguniang Bayan, through its appropriate committee, shall conduct regular monitoring and evaluation of the implementation of this ordinance to ensure that the website remains functional, user-friendly, and informative.

The Sangguniang Bayan as a whole shall conduct an annual review of the performance of the LGU website, including its functionality, content, and the level of public access and feedback. Recommendations for improvement shall be made based on this review.

SECTION 12. Separability Clause.

If any part or provision of this ordinance is declared invalid or unconstitutional, the remaining provisions shall continue to be in full force and effect.

SECTION 13. Repealing Clause.

All ordinances, resolutions, and other issuances inconsistent with the provisions of this ordinance are hereby repealed or amended accordingly.

SECTION 14. Effectivity.

This ordinance shall take effect immediately upon its approval and proper publication in accordance with the law.
