

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 03 FY 2024** of the **Municipality of Capoocan**, **Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 22**, **Series of 2024** with a total appropriation in the amount of **P2,000,000.00** reveals compliance with the same law and its implementing Rules and Regulations.
